Welcome & Introductions: The committee introduced themselves.

The committee welcomed Suzanne Sullivan from Teen Feed. Teen Feed was started 30 years ago by nurses in the U District who noticed that many of their teen clients were malnourished and they started serving a meal on Fridays. Now they serve meals every night of the week in the U District and last year, served 21,700 meals at their 3 sites (U District, Auburn & Rainier Beach. Their philosophy is to create a foundation of support to help their clients meet their futures. They are a low barrier program and their clients self-report which means they aren't eligible for government funding. Teen Feed relies funds raised through the CFD, to help keep their program running. Currently, 90 cents of every dollar goes to their program. They partner with volunteers and other agencies to offer meals out of the U District and help teens access services they need.
