Previous Months Action Items: <u>Annya requested envelopes to help procure items that</u> <u>don't have AGO information. Kerri to check with Philip to see if they have some available or</u> <u>she may order box of blanks.</u> Philip mentioned that he had sent them the Friday previously and Kerri will be on the lookout for them.

(Charity/agency fairs) Curtis will reach out to Brett Wolfe (WSF) to gage his interest in having a mini fair at his agency. Curtis said he had reached out to Brett and the logistics of having it there was still up for debate. They are possibly downsizing and he is not sure if in September they will be able to have it there.

Budget: Not a lot has changed from last month. Still have \$950 left in the budget for supplies. The committee recommended exploring creating a display board or slide show for tabling events. We discussed further what <u>Jeannie had volunteered to put together and what she had e-mailed out to the committee for review. We are supposed to review and provide any further suggestions.</u> Curtis suggested using a software and be a little more of a real slideshow than that, Philip mentioned a software program that CFD has access to and was going to share with Jeannie. We also suggested adding more photos since it will be scrolling. The committee also suggested travel totes to use for tabling events during the campaign. Kerri mentioned another cart, possibly bigger for travel.

Outreach & Development: The committee welcomed a guest speaker Barb Bocek from Northwest Harvest to speak about their organization and the impact the CFD has. Barb mentioned that 708,000 meals were created from giving from the CFD and talked about why it is important to give through the CFD. She also talked about soliciting donors through their newsletter and if they can do that with CFD participants. Would it be okay if they just included an envelope, is that considered solicitation. Philip answered no, that should be okay, because they can always opt out of the newsletter or report to CFD if there is any issues.
