NEW YORK, Dec. 17 .- Weston, Ellis and Thompson, colored men, were hanged in the Tombs prison at 9:30 this morning, for the murder of Abram Weisseburg, a pedaler, in September last. The crowd increased every moment and before 9 o'clock long lines of men, all clamorous for admission formed in Franklin and Central streets. At 9:15 A. M., the doors were opened for the

admission of reporters and a rush from Bills and resolutions introduced and all sides followed. A most disgraceful scene ensued and the police in vain struggled to preserve order. A violent rush was made for the gate and all those persons who had right of entrance were compelled either to fight every inch of a resolution instructing the Committee their way or remain outside. 


