HALF SHEET—We are sorry to be obliged to present our readers with only a half sheet this week. Our reason for so doing is because of a scarcity of white paper. The blockade in the Columbia river prevented our team from getting the supply of paper it was sent for. A large supply will hereafter be at our command, and we hope this will be the only halfsheet we may print for the year 1881.

The Seattle Post publishes the following "early reminiscence of Puget Sound." On the 25th day of May, A. D. 1825, D. S. Smith (now a resident of Seattle) embarked at Nantucket on a whaling voyage to the Pacific. The voyage to the Sandwich Islands occupied some nine months, including a short stoppage at Pataca, on the coast of Peru. At the Sandwich Islands Mr. Smith left the ship, and after a short residence on shore, embarked on a fur trader as armorer for the ship, for a voyage to the straits of San Juan De Fuca. They entered the straits without charts, in July or August, 1826, and came somewhere in the vicinity of Port Discovery, where they drove a brisk trade with the Indians for furs. Some little time having elapsed and the best of the trade for furs having evidently closed, and the Indians having become somewhat troublesome, the captain concluded to change his locality, and, if a favorable situation presented, would take on board a few spars for the return trip to the islands. They came up past Skagit head, and having discovered the entrance to what we now term Salmon bay, anchored a short distance off shore, and the crew cut and dressed four large spars and quite a number of smaller ones, and took them on board. They laid here some three weeks, after which they sailed again down the straits and back to the Sandwich Islands. While lying at the mouth of Salmon bay no Indians were seen, not a single one appeared in sight during the whole time. There is a legend among the Indians now here that a long time ago there came to Salmon bay a queer craft, of which the Indians there were all afraid and fled at its approach. This is probably the ship referred to. Mr. Smith can take the palm as an old pioneer.

The "Lupata" Lost.

ASTORIA, Jan. 8.—By the arrival of the lighthouse tender Mary Taylor this morning from Tillamook Rock, the loss of the British ship Lupata is confirmed. Capt. Wheeler, superintendent of construction of Tillamook Rock lighthouse, arrived here this evening, and reports that Monday evening, the 3d inst., about 8 o'clock, the weather being very thick and wind blowing hard from a southeast, workmen on the rock suddenly heard loud voices and shouting, and on emerging from their houses saw a ship's light just inside of the rock and immediately after heard a command given, "hard sport." Realizing that a vessel was in close proximity to the rock and lived in jeopardy, Capt. Wheeler ordered lanterns to be lit, one to be placed in the tower, and as rapidly as possible a large bonfire started, the illumination from which revealed a large vessel apparently not two hundred yards from the east side of the rock. The red port light of the ship was in sight about five minutes when it gradually disappeared, those on the rock concluding the captain had backed the ship and successfully steered his vessel out of danger. This morning for the first time since the fog had disappeared, it

was found that the captain, instead of rounding the rock westward, had run his vessel ashore on a reef of rock running out from Tillamook head, the topmost being visible from six to ten feet above water. The shore being a bold bluff rock for a considerable distance from the scene of the wreck, it is more than likely that the whole ship's company were lost, and the wreckage cast ashore leaves no doubt that the unfortunate vessel was the British ship Lupata, of London.

An English View of American Wheat Supply.

H. K. JACKSON expresses himself as follows in Darnbusch of Nov. 29th: The United States are reckoning they can supply this country with quite \$5 per cent. of its wheat requirements and accept the undertaking of so doing. Possibly this is reckoning without the rest of the world, which it does set down to forward us only some three million quarters. Now, last week's London arrivals of 77,000 quarters were made up of only about one-third of American and Canadian wheat. East India sent nearly a fourth and Australia more than a third and even Russia contributed a fifth of the American total. If, too, one turns from a single week to a more general basis, it is seen that of the 2,000,000 quarters now afloat in this country the contributions are: California, 900,000 quarters; Atlantic States, 530,000 quarters; Chile and Australia, 390,000 quarters; Russia, 150,000 quarters; India, 102,000 quarters. And thus it seems likely "all the other countries" may send 25 instead of 15 per cent. as their minimum supply. Even Russia has 145 ships now laden with wheat for the United Kingdom or continent, against 168 last season. But even if America does yield (as undoubtedly she could) 85 per cent. of our imports, say 12,000,000 quarters, that is but half our consumption, and the other half, supplied by home growers and other countries than America, will have an equal voice in deciding the markets. If, as I should expect, India, Australia, Egypt, etc., contribute 25 to 30 per cent. of our wants, such quantity will be quite sufficient to modify price, as being the competitive surplus seeking custom. This year's surplus in America must be first annihilated before speculation can establish a lodgment in European markets. An average of 50s for wheat beckons unseen supplies to come forward, and it is unlikely that America will allow itself to be undersold in Mark Lane, which to some extent is now being done.

The New Chinese Treaty.

The Chinese immigration treaty brought to Washington is a state secret, but it has, nevertheless become an "open secret." The substance of the whole matter is that the Chinese government freely consents that our government shall regulate, limit or suspend the immigration of Chinese laborers to this country whenever we may think proper, but Chinese citizens shall still be permitted to come here as merchants, students and teachers, or for the purpose of travel curiosity or pleasure, and all subjects of China traveling or residing in the United States shall be entitled to due protection of life, liberty and property. The commercial treaty contains a stipulation that Chinese vessels and cargoes, and American vessels and cargoes shall not be subjected by the high contracting parties to any discriminating duties in their respective ports of entry. It is now satisfactorily developed that this treaty contains also another important provision of a special nature, namely, one in regard to the opium traffic which comprehensively stipulated that Americans shall not import or sell opium in China, or that Chinese shall not import or deal in opium in the United States. The evident aim of the Chinese government in obtaining the insertion of this anomalous provision is to establish a precedent for placing precisely similar clauses in its future commercial treaties with all other nations who will consent thereto, and thus isolate Great Britain from other civilized powers in this respect and put a stamp of international condemnation of her maintenance of the opium traffic.

Closed In.—Between Unstilla and The Dalles the Columbia has not been navigable for a week. At Watula, yesterday, the river was full of running ice. Between Portland and The Dalles the river has been kept

open by the continued passage of boats, but it is liable to close at any time. The telegraph line has been down between The Dalles and Portland nearly all the time since the first of January. On Thursday the line worked for a few hours and we ordered dispatches for to-day, but yesterday the line was down again and we don't know what the rest of the world is doing. The stage road between The Dalles and John Day's river is impassable and mails from that point have reached here for a week. The railroad company expect to have the road between The Dalles and Blalock's Landing in running order the first of next week. Then there will be a gap of thirty miles between the ends of the road to be filled by steamboat or stage. Our mails from the north and east arrive regularly.—Union.
