IMPEACHMENT PROCEEDINGS.

IMPRACHMENT PROCEEDINGS.

Washington, May 4.—In the Senate after the reading of the Journal, Bingham commenced the final argument for the proceeding, protesting that he took part in the proceedings from no partian feelings but with the weighty sense of their solemity and true meaning. He proceeded to sketch the events attendant on the assassination of President Lincoln, and the accession of Andrew Johnson to the Presidency, referring to his oath to execute the laws. He spoke of their majesty and supremacy in our form of government, and claimed that the President was equally subject to this authority with the humblest frontier settler. He dwelt on the high trust committed to the Senate, and asserted that the issues of life and death to the Republic hung on their decision. He said the responsibility of deciding this issue rests upon the Senate. It cannot be divided with any human being outside of the Senate. The Senate have the whole power to try the impeachment and must of necessity be clothed with every power to decide all questions of law and fact. It has been implied by counsel on the other side to show that this is not so. They would like, it may be supposed, to have Andrew Johnson decide this is not so. They would like, it may be supposed, to have Andrew Johnson decide this question, as they say he has the right to do all others. His colleague, Butler, in opening the case had called this body Sanate instead of Court, and counsel tried to make a point out of this. It was easy to see that this was done with the view of drawing the attention of the Senate from the real issue, but he would not wast his time and throat the country of the same of of the this was done with the view of drawing the attention of the Senate from the real issue, but he would not waste his time and strength on trifles like these which were light as air. He would not follow connael on either side, especially the gentlemam from New York (Evarts) in his intellectual pyrotechnics. [Laughter.] He would deal in such arguments as would bring conviction to the mind of every man. Referring to the length of Evarts speech, Bingham said he supposed it was the impression of some members that to make a speech immortal it was necessary to make it eternal. [Laughter.] It had been stated by counsel on the other side that all questions arising under the Constitution of the United States must be decided by the Supreme Court. That was a very broad proposition. There were many questions which could not in the nature of things come before the Supreme Court though they tions which could not in the nature of things come before the Supreme Court though they arise under the Constitution, for instance: the Senator from Illinois or any other State, if his right to a seat here was disputed, did not go with his case to the Supreme Court. That must be decided by this body to which he was elected. He read from the decisions of hief Justice Marshall to show that it was the duty of the heads of departments to obey the laws, not to take commands of the was the duty of the heads of departments to obey the laws, not to take commands of the President. Instead of this, the decision shows that neither the President nor his heads of departments are above the laws. Bingham cited the case of the Fugitive Slave bill, which, though it was repugnant to every sense of justice—a bill which made chattels of men—a bill for which even God seemed to stand silent—a bill which forbade us to give shelter to the homeless—a bill which made us violate the command of our which made us violate the command of our which made us violate the command of our divine master, when he says "Give a cup of cold water to him who is ready to periad".

The Senate took a recess of fifteen minutes. After recess Bingham resumed his argument. He referred to that provision of the Constitution which says every bill argument. He referred to that provision of the Constitution which says every bill which shall have passed Congress shall, before itbecomes a law, be sent to the President. The language of the Constitution is, itshall become a law after it has gone through the process prescribed by the Constitution. The argument of the gentlemen on the other side is, it shall not be a law. To prove this, they brought forward their small arms, as well as their heavy artillery, and say it must be in accordance with the Constitution. So it must. But who is to decide that question? Not the President, certainly, for he is not a judicial but an executive officer. If the President may dispense with one act of Congress, why may he not dispense with all? At four o'clock the Court adjourned, leaving Bingham's speech unfinished. leaving Bingham's speech unfinished.

Look at it carefully; in only 14 States of this Union did the yield of wheat per acre exceed 12 bushels! The farmers in this Valley know that they can trebble these figures. Look at the fig-ures for Kentucky, Virginia, and Tennessee, only little over eight bushels to the acre; North and South Carolina below seven bushels: and where there is one man raising wheat in Walla Walla Valley, there are ten, or perhaps twenty, in either of these States, and doubtless ever one of them doing better than the wheat-raisers in this Valley; and why is this? Glance for a moment at the price per bushel which the farm ers in the different States receive for their grain. The highest price received is \$2 89, and the lowest \$1 32, making an average of \$2 23} per bushel. You must remember that this is the price within the State where the grain is raised, nd not what the State of Maryland received for her wheat when she had delivered it in the city of New York. Maryland received \$2 43 at home; the State of New York received \$2 64; Nebrasa ka, although she raised fifteen bushels to the acre, only received \$1 32, the lowest in the list of prices, with only three States outstripping her in quantity. Would not the farmers in this Valley readily accept \$1.32 per bushel for what wheat they could raise in this Valley? I think they would. Now what is the reason they can Our great lack of transportation It is railroad facilities that regulate the prices. You must know that one or two railroads rans ning through such States as New York or Illinois, must require branch roads to connect with the one or two main trunks. But Walla Walla Valley is the wheat growing portion of this Ter-ritory, hence a branch railroad through this Valley is an indispensable necessity, and must be built, or we had all better sell out to some persons that will develop the country. SENTENCED TO DEATH.—Michael Welsh was senienced on Friday, lat inst., to be hung at this place on Friday, the 5th day of June, for aiding in the killing of Solomon Prebble at Chinook, in Pacific county, in January last. In reply to the usual question whether the prisoner had anything to urge as a reason why the sentence of death should not be pronounced, he said that 'the was as innocent as a child unborn,' and went on to make a long rambling statement of how he happened at Prebble's house on the morning of the killing, stoutly dennying any participation therein or the utterance of threats agains the deceased's life. Judge Wyche remarked that it had been sufficiently proven that though not the one who actually did the killing, he had been one of the principal instigators of it; that he had been at various times heard to express a determination to take the deceased's life; that at the house of the deceased, on the morning of the murder, he shouted 'we have come for blood! Shoot! Shoot!' thereby inciding the act; that the accessory was held equally culpable with the principal in the eye of the law, and that in consideration of the awfulness of the fate which awaited him he should not deviate from the truth. The prisoner again protested his innoceance, when the Judge remarked rate which awaited him he should not userviate from the truth. The prisoner again protested his innocence, when the Judge remarked as there had been no good reason shown why the sentence of the law should not be passed there was no alternative left him but to comply therewith, which he accordingly did. The prisoner gave no outward indications of suffering, save in a slight tremulousness of voice. The Judge discouraged all hope of a reprieve. The scene was impressive in the extreme, and one not likely to be soon forgotten.—Vancouver Register.

Bond, of Maryland, be, and hereby are, appointed managers of the National Asylum for Disabled Soldiers, under the provisions and conditions of the third section of an act approved March twenty third, eighteen bundred and sixty-six, from the twenty-first of April, eighteen bundred and sixty-eight; and that Hugh L. Bond, of Maryland, be, and is hereby, appointed manager to serve out the unexpired term of Hioratio G. Stebbins, of California, resigned.

SEC. 2. And be it further resolved, That the Secretary of War be authorized to furnish, from the captured ordnance, such ordnance with their implements as he may deem proper, to the sev-

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the act of March three, eighteen hundred aand seventeen, entitled "An act to provide for the prompt settlement of public accounts," shall not be constructed to authorise the beads of departments to change or modify the balances that may be certified to them by the Commissioner of Customs or the Comptroller of the Treasury, but that such balances, when stated by the Auditor and properly certified by the Comptroller as provided by that act, shall be taken and considered as final and conclusive upon the executive branch of the government, and be subject to revision only by Congress or the proper courts: Provided, That the head of the proper department, before signing a warrant for any balance certified to him by a Comptroller, may submit to such Comptroller any facts in his judgment affecting the correctness of such balance, but the decision of the Comptroller thereon shall be final and conclusive as hereinbefore provided.
