Interviewing Villard. A Most Pleasant Work, Resulting in Free Answers to Questions Interesting to the Public.

Mr. Henry Villard and a portion of his party arrived in St. Paul yesterday 12:50, on time, by special train from Chicago.

Col. Gray, the counsel of the railway company, and the Boston gentleman, Messrs. William Endicott, Jr., and Richard S. Fay, had not arrived in Chicago at the time the party left there, but are expected in St. Paul to-day.

In the party from Chicago were General Manager Haupt, Mr. Wm. P. Clough, attorney for the Northern Pacific road, and Col. Wm. Crooks.

Immediately upon arrival in St. Paul they were driven to the Metropolitan where the following names were registered: Henry Villard, Henry Villard, Jr., Lloyd Garrison, Jr., of New York, J. B. Montgomery and H. W. Corbett, Portland, Oregon, Gen. James B. Fry, U. S. A., Capt. H. H. Goringe, U. S. A., Lewis Brothers, Tarrytown, N. Y., D. C. Miles, Massachusetts, H. D. Lloyd, Chicago.

A MEET INTERVIEW. Mr. Villard kindly received the Pioneer Press reporter, though others were waiting to talk with him.

"Was the Chicago interview with you published in the Pioneer Press correctly?" asked the reporter.

"Yes," said Mr. Villard, "substantially so."

"Nothing was said in that about the policy of your company regarding an eastern outlet?"

"What do you mean by that?"

"What will you do when you reach the St. Mary from Duluth?"

"I cannot tell. We have not yet decided. No one of us knows as yet. My own idea is that it will be best to form connection with existing lines."

"What road do you think of connecting with?"

"We have here half a dozen roads that have made propositions to us. All of them only want the chance."

"I am told that if the Northern Pacific should attempt to build a road eastward from St. Mary, that they would run against a stump in the form of Canadian Pacific influence."

"That is not so. Mr. Gould's interests in the Northern Pacific are very small. He no longer dictates its policy. This is very well known in Wall, street and has been for some time past."

"Then I understand the road is to be built."

"Yes. We are building a road from Portland, Oregon, to Baker City, to meet it."

"Then there will be identity of interests between your company and the Union Pacific."

"No, not that. The two companies are distinct, but probably we will have some sort of running arrangement for trade. The local business in that country cannot be forced northward to the Northern Pacific. It must pursue its own channels."

"Now sir, I would like to ask you another question. It has been asserted in my hearing that Jay Gould is interested in your plans, and in a measure is a backer."

"Jay Gould has no pecuniary interest in the Northern Pacific, the Oregon Railway & Navigation Company, or the Oregon Trans-Continental company, in any form that I am aware of."

"May I print that?"

"Certainly."

"One thing more; it has been frequently reported that wherever the Northern Pacific lays tracks in Minnesota and Dakota, that the Manitoba company will lay parallel lines, or cross lines. Now, then, what will your policy be, power or war?"

"As far that, I have not seen Mr. Hill. I do not know the gentleman personally. We want our road to make all the money it can, and of course harmonious relations with the Manitoba would be better for all concerned. I shall probably see Mr. Hill before long. But I came out here to see the ground for myself, so as to understand the situation better. I may come to see Mr. Hill again. I may see Mr. Hill as well as posted just now in Northern Pacific matters as I am in Oregon Navigation, but will be soon."
