When the forces came in contect, they whirled off at a tangent eastwards, carrying death and destruction in their progress. In the village of Viroqua, fifty buildings were instantly demolished and sont one hundred men, women, and children injured, some fatally, others with broken hones, the most fortunate examing with violent contunions—in one case a leady and her children were sitting in great alarm in a, room in their dwelling, when the whole building was, carried away from the flooring, and the family left unburst.

For several miles east of Viroqua, the storm destroyed everything in its course. It is eatimated that \$200,000 worth of property was scattered to the winds.

About the same date, in Iowa, the elements seemed to have gone mad; and with demonlas forzy sported with the creations of man's hands. The line of march of the storm extended mora than a hundred miles west of Dubuque, and beyond the State line on the north. Over this great extent the rain fell in such torrests that rivers were ranning after the storm, where, no sign of a brook existed a week bdfore. North Maquoketa river rose eight feet during the first three hours of the storm was marked with a great destruction of property. Railroad and other bridges of the most substantial description, were in cases dam-aged, in others totally destroyed, mildams and railroad tracks were, in many places, washed away. In one place skelcons were in many places washed from their quiet resting place.—The Catifix Valley was reported inundated and the cropp totally destroyed. The hurricane accompanying this deluge was very destructive, several buildings being blown down. No loss of life was reported.

Cashurane Shawla.—The Cashmere shawl-wool consists of the fleece beneath the undercoat of the hair of the shawl-goats. The shearing is performed at the commencement of the summer, which in those Alpine regions, though short, is very hot. The hair of the goat is first ent short with a knife, the shearer beginning at the head and following the direction of the fiscer twards the tail. The animal is then rubbed in the reverse direction with a sort of brush or comb which detaches the fine wool from next the skin (the anil) nearly free from hair. When the animals are not shorn, they relieve themselves of these winter vests of delicate down, by rubbing against the rocks. Seeing that the original possessors of the asuli are nearly wild as the winds, material for thousands of shawls must be anually blown about and utterly wasted amongst the pinnacles and crags of those desoiate regions. At present a very great quantity of the genuine suil is lost by being mixed with the coarser hair and common wool, and thus indiscriminately manufactured into pushmeena.

Edmund Burke's Politics,

The Oregonian has been quoting from Burke's writings to sustain its party principles. It gives the following quotations from this renowned statesman, and then draws consolation therefrom for itself and its party :

"When bad men combine, the good men must associate; else they will fall one by one, an unpitied sacrifice in a contemptible struggle." ("Party.") says the same master we have quoted, "is a body of men united for promoting by their just endeavors the national integrity, upon some particular principle in which they are all agreed."

At a glance, taking these paragraphs by them At a giance, taking these paragraphs by themselves, a superficial observer might be led to believe that Burke's political views coincided with those now held by the dominant party the United States; but any one who will take the time to peruse the author's works will find that he was no "loyal leaguer;" that in fact he denounced during the American Revolution the extreme war party of the English govern-ment, and was himself one of the foremost ad vocates among the British statesmen who favor ed the adoption of a conciliatory policy in deal-ing with the American colonies. We will here make a single quotation from Burke on a certain kind of "party," since he is good authority with the Oregonian, in that line:

the Oregonian, in that line:

"A constitution formed so as to enable a party to overrule lits very government, and to overpower the people, too, answers the purposes neither of government nor of freedom. It compels that power, which ought, and often would be disposed qualily to protect the subjects, to fail in its trust, to counteract its purposes, and to become no better than the instrument of the wrongs of a faction. Some degree of influence must exist in all governments. But a government which has no interest to please the body of the people, and can neither support them, nor with safety call for their support, nor is of power to sway the domineering faction, can only exist by corruption; and taught by that monopolizing party which usurps the title and qualities of the public, to consider the body of the people, as out of the constitution, they will consider those who are in it in the light in which they choose to consider themselves. The whole relation of government and of freedom will be a battle or a traffic."

We will now quote briefly from Burke's grea will be observed that he was in favor of dealing with our revolutionary forefathers very much upon the plan that the conservative men of the United States would have adopted du ring the late war for the pacification of the reb els of the Southern States:

els of the Southern States:

"I mean to give peace. Peace implies reconciliation; and where there has been a material dispute, reconciliation does in a manner always imply concession on the one part or on the other. In this state of things I make no difficulty affirming, that the proposal ought to originate from us. Great and acknowledged force in out impaired, either in effect or in opinion, by an unwillingness to exert itself. The superior power may offer peace with henor and with safety. Such an offer from such a power will be attributed to magnanimity. But the concessions of tear.—When such a one is disarmed, he is wholly at the mercy of his superior; and he loses forewer that time and those chances, which, as they happen to all inferior power."
"America, gentlemen soy, is a noble object.

happen to all men, are the strength and resources of all inferior power."

"America, gentlemen say, is a noble object, it is an object well worth fighting for. Certainly it is, if fighting a people be the best way of gaining thom. Gentlemen in this respect will be led to the distribution of the strength of the streng

First, Sir, permit me to observe, that the use of force alone is but temporary. It may subdue for a moment; but it does not remove the necessity of subduing again: and a nation is not governed, which is perpetually to be conquered. My next objection is its uncertainty. Terror is not always the effect of force; and an armament is not a victory. If you do not succeed, you are without resource; for, conciliation falling, force remains; but, force failing, no further hope of reconciliation is left.

A further objection to force is, that you impair the object by your very endeavors to preserve it. The thing you fought for is not the thing which you recover; but depreciated, sunk, wasted, and consumed in the context. Nothing less will content me, than whole America. 1 on to choose to consume its strength along with

ress will content me, than whole America. I do not choose to consume its strength along with our own; because in all parts it is the British strength that I consume. I do not choose to be caught by a foreign enemy at the end of this exhausting conflict; and still less in the midst of it. I may escape; but I can be a support to the caught of the caugh hausting conflict; and still less in the midst of it. I may escape; but I can make no insurance against such an event. Let me add, that I do not choose wholly to break the American spirit, because it is the spirit that has made the country."

Burke proceeds at great length with all the logic and argument which his great mind could bring to bear, to fortify the correctness of his positions. He dwells upon the character, temer and the indemitable spirit of the American neonle, and says of them, "a love of freedom is the predominating feature which characterizes the whole." But even this trait of character be said predominated to a greater extent in the Southern mind than in the Northern. Upon this point we quote his own words:

"There is however a circumstance attending these colonies, which, in my opinion, fully counterbalances this difference, and makes the spirit of liberty still more high and haughty than in those to the northward. It is that in Virginia and the Carolinas, they have a multitude of slaves. Where this is the case in any part of the world, those who are free, are by far the most 'proud and jealous of their freedom. Freedom is to them not only an enjoyment, but a kind of, rank and privilege. Not seeing there, that freedom, as in countries where it is a common blessing, and as broad and general as the air, may be united with much abject toil, with great misery, with all the exterior of servitude, liberty looks, among them, like something that is more noble and liberal. I do not mean, Sir, to commend the superior morality of this sentiment, which has at leastes much pride as virtue in it; but I cannot alter the nature of man. The fact is so; and these people of the southern colonies are much more strongly, and with an higher and more stubborn spirit, attached to liberty than those to the northward. Such were all the ancient commonwealths; such were our Gothic ancestors; such in our days were the Poles; and such will be all imasters of slaves who are not slaves themselves. In such a people the supthiness of domination combines with the spirit of freedom, fortifies it, and renders it invincible." haughtiness of domination combines wit spirit of freedom, fortifies it, and renders vincible."
