THE following is the concluding portion of Hon. George H. Pendle-ton's letter of acceptance of his nomination for Governor by the democracy of Ohio: "Governor Hays, in his speech at Wilmington, forgot to allude to the Fifteenth Amendment, and his views on the important question in discussing the finances he said: 'We are in the midst of profound peace, yet money is scarce and business is depressed.' He might have added that employment is difficult to be obtained; that labor is badly rewarded; that industrial pursuits are all hampered; that enterprising men engaged in business are standing on the very verge of bankruptcy; that interest is enormously high; that the tariff is most unequal, unjust and onerous; that dead capital is exempted, and active capital and labor weighed down; and, warming with the picture he might also have said that for eight years the republican party had been in absolute possession of the Government; that a republican Secretary of the Treasury has now control of the money market of the country, and that he uses his power only still further to contract the currency, to increase the hard times, and buy over due bonds at \$120, which by law he is entitled to buy at par, thereby taking \$20 for every 100 from the taxpayer and giving it to the bond holder.
