

In this idea she received great encouragement, and the house was opened with flattering prospects. In this venture she proved to be very successful and made money and saved it. By the growth of the city, her house finally got to be in the very center and, as the streets were laid out, it proved Harrison avenue and State street. Business was good and she continued to make money, which she invested wisely. She built another log house and rented it. Then she put up a frame building, which was rented before it was finished. Aboutputed her title to the land, and tried to dispossess her. But the old lady had so many determined friends among the miners that the effort was given up. Several months ago she refused an offer of \$10,000 for her property, and since that time she built a two-story block fronting on Harrison avenue, and as desirable a piece of property as any in Lead-ville. \$1000 a month—a pretty good record of business success for an old washer-woman. INDIANS DYING OFF. - Nachez recently received a letter from his sister, the Princess Sallie Winnemucca, who is now teaching the Indians at Yakima reservation, near Fort Simcoe, Washington terri-tory, in which she says that the Piutes taken there last winter, are dying off like sheep. She says that no Indians taken sick get well, and she wants to get away from there. She speaks in terms of the highest praise of Father Wilbur, and says that some fifty of her people were recently converted and baptized by him. She noticed the contrast between the treat-ment of the Indians at Yakima and Malheur, and says that not an Indian was ever taught the alphabet at the latter place, while many of them at Yakima are fluent readers.—Silver State.

In order to fully ascertaia the immense strides this "upper country" has made with-in the past five years, it is absolutely necessary that a man should have known the country before that period. New comers here take everything for granted, and as a matter of course, it is the old settlers who are surprised at the progress made. When the first settlements were made, the land that was mostly in demand was that situated was then considered to be fit for any-other purpose except grazing, without expensive irrigation works. As time wore on, and the country became more populated, encroach-ments were made by degrees on the land sloping from the hills toward the streams. These lands bore such unprecedented crops that farmers were encouraged to further, until finally the whole cou ged to go still ole country, hill not too steep to plow, became a grand wheat field. This has applied in the past to the great Walla Walla country, which in-cludes the Touchet and its numerous tributaries in and around Dayton and Waitsburg. As the traveler rides along on the stage be-yond that point, he receives the impression that the country has been settled up as the immigrants went along, as if they had come upon a location and were satisfied without going any further. Reaching the Tucannon and Pataha creeks, we find young and thrivand Pataha creeks, we find young and thriv-ing towns springing up, with every indica-tion of prosperity around them. Marengo is the town of the Tucannon and contains an hotel, and a mill that has the reputation of turning out one of the best brands of flour in he country. A beautiful stream of water courses through the valley and adds much to its

ROMANTIC APPEARANCE Between this stream and the Pataha is a Between this stream and the ratana is a high bench from which can be seen in every direction, even unto the edge of the timber in the Blue mountains, numerous fields of waving grain. Pomeroy is a fine little town that must in course of time be a large place. It has a flour mill, some stores, and every thing else that goes toward making a city; our short stay prevented us from any ex-tended observation. Pataha city, three miles further up the creek, is a rival town; Vine Favor is the acknowledged magnate of the city. Here we found a fine planing mill and one of the finest grist mills in the whole country. There is a very nice hotel where the stages stop, and the bungry can always depend upon a good, clean meal. From Pa-taha toward the Alpowai, the road leads over a fine, well graded toll road owned by Mr. Wheeler, through some of the richest farming lands in the country. We can easily remember the time when this land was con We can easily sidered as fit for nothing but to graze cay-cayuses, cattle and sheep. It has only re-cently been located, for amongst the stubble cently been located, for amongst the stubble fields are many acres that have not yet been touched with the class.

CASANAVE. - Gustave Casanave is a ne-

gro undertaker and livery stable keeper in New Orleans. He was one of the Re-turning Board who sold the electoral vote of Louisiana to Hayes. His three partners in the infamous transaction were Anderson, Wells and Kenner. This trio have been paid for their dirty work by the fraudulent administration. They and, as Casanave testifies, forty of their family connections are all occupying positions under the government. The four were in-dicted for their crime, and in the language of the Philadelphia Times, "but for the technical defense ingeniously devised by able counsel, they would have been sent to the penitentiary, while the administra tion, which is the creation of the Board, would have been covered with lasting disgrace." That defense cost \$5,000, which could not be collected from Wells, Anderson and Kenner, who have no property and for which their counsel has received judgment against Casanave. To pay the judgment would rob him of his all, and asanave, not content to thus be made a beggar, has been in Washington for some weeks, trying to compel the members of the administration, the beneficiaries of his crime to pay it for him. A part of the sum has been contributed by republican officials, and the Collector of the Port of New Orleans has been telegraphed to from the Treasury to advance another part out of the public funds in his hands. Secretary Sherman said to an interviewer that it would be all paid, that "it is: damned cowardly piece of business for the republicans to be afraid to help Casanave," that he had no hesitation in announcing his willingness to give money and "that any republican who hesitates to do so is a damned fool." I regard it as a signal of kindness to the people of Georgia, as well as to my adminis-tration as governor of the state, that you call my attention as you have in your letter of a recent date to certain most extraordinary and startling charges brought against us in an article in the Lewiston Journal which has recently appeared. The burden of the accusation is about this; that in the of the accusation is about this; that in the last two years a large number of men have been lynched in Georgia because they be-longed to the Methodist church, voted the republican ticket, and interested themselves in the education of our colored people. The allegation is further made that there is no pumishment for these outraces and that our punishment for these outrages, and that our state is tending to only strife and bloodshed.

feeling which such charges as these are likely to arouse, if true, in the breasts of honorable and upright and humane mon everywhere, I am justified in the use of strong terms in expressing my thanks to you for the friendly interest which you have taken in the cause of truth and further thanks. of truth and fraternal feeling, by calling my

tonishing misrepresentations.

Another Triumph. On September 24, ANOTHER TRUMPH.—On September 29, the little steamer Vega arrived at Yokohama Japan, having on board Prof. Nordenskjold, the Arctic explorer. The voyage made by this little craft is one of the most remarkable measurement. able successes of Arctic explorations. It will be memorable for the ease and safety with which it accomplished a voyage which it had been left for the present generation of men to make for the first time. The Vega sailed from Gothenberg, Sweeden, on July 4th, 1878, having for its object the discovery of a north east passage to the Pacific. The fact that the same steamer the expedition started out in, has arrived in Yokohama harbor clearly indicates its success. The little craft was hemmed in by the ice for a period of over 200 days, yet all the crew came out in good condition with no deaths. It is very possible that this new and important discovery may have a great effect on this country of ours. The route has been proved to be practicable, and, but for the lateness of the season, the trip would have been made in a few weeks. A perusal of the Danish geographer's letter shows very clearly the advantages that the modern Arctic explorers enjoy over the earlier navigators. Leaving the mouth of the river Lena, in 1760, with a small vessel built there, he succeeded that year in reaching the river Jana. Next year he succeeded in rounding the Sviatoi Nos, or Holy Cape, and sought winter quarters at the mouth of the river Kolyma. Next year he only reached Cape Schlelagskoj, when his crew mutinied, and he had to return to the Kolyma and to Russia. "Thus," as Professor Nordenskjold says, "these explorers required three years to accomplish what we, aided by steam, had måde in four or five days." The letter suspending the circular of June 27th, 1879, reads as follows :

DEPARTMENT OF THE INTERIOR, General Land Office, Washington, D. C., Aug. 14, 1879.

REGISTER AND RECEIVER, Walla Walla, W. T. Gentlemen: -You are hereby no tified that the circular from this office of June 27th, 1879, (copy enclosed herewith) is rescinded so far as the same applies to Washington territory. Very Respectfully,






