

The Stramsung Clock.—The priest and milther have retired, and I am now sitting in a chair facing the gigantic clock—from the bottom to the top not less than one hundred feet, and about thirty feet wide and fifteen feet deep. Around me are many strangers waiting to see the working of this clock as it strikes the hour of noon. Every eye is upon the clock. It now wants five minutes to twelve. The clock has struck, and the people are gone, except a few whom the sexton or head man, with a wand and sword, is cenducting round, the building.

End of the Presidential Contest.

our country's history. The day was looked forward to by every intelligent American woe the fate of our great Republican goverument. The partisans on either side have struggled for the mastery with a zeal never the Republic. Each -party strove to convince the people that to preserve the govit was an indispensable prerequisite to elect its own candidates and carry out the principles laid down in the platform of its own making and choice; that the platform, principles, and leading men of the opposition party, were disloyal, thoroughly opposed to the preservation of the government; and its success at the Presidential election would be the sure forerunner of disunion and the country's ruin. The principles to which either party adhered, to sustain and perpetuate the government, were discussed and con, and the people had every opportunity to judge of the merits or demerits of the different principles advocated through by the public speakers in the press and their midst. To believe that the American people are eapable of maintaing a Republican form of government, carries with it also the conviction that they are capable of discriminating between right and wrong, between false and true theories, and between correct and long established principles and new and peculiar doctrines. Having weighed thoroughly the issues presented for their consideration, and conscientiously made up their verdict for the best interests of the nation and the citizen, the people assembled at the ballot-box on Tuesday last to give expression to their sovereign will by their votes. Presuming that the expression of the will of the majority has been fairly arrived at, at the late election, or as fairly as could be expected at a time when the publie feeling was at such a pitch of excitement, we conceive it to be the duty of the minority party to submit as gracefully as possible to the party that has gained the ascendancy. It matters not whether Lincoln or McClellan is to be our next President, so far as the duty of the minority is concerned. In either case, we are bound by all rightful precedents to submit to the lawful will of the majority; we are forced to acknowledge, if in the minority, that the popular will has been fairly expressed under the forms prescribed by law, and charity and every principle of right and justice should bid us acknowledge that our opponents were endowed with reasoning powers and that they were actuated in their aims, in choosing for a President, from sincerity of purpose and from convictions that they were acting for the best interests of the country, like ourselves. Doubtless many persons who have acted with the respective parties in the Presidential contest, are disloyal to the core and have lost no opportunity to promote the de-struction of the Republic. Still, we must concede that the masses of the people are honest and that they have labored earnestly and faithfully in the ranks of either party to promote the general weal; and for selves, we are willing to abide the result of the contest, whichever way it has terminated, and accept it as the verdict of the American people. We have opposed some of Mr. Lincoln's policies and opposed his re-election, believing that his general policy as a whole, was unwise, and illy calculated to restore peace and maintain the integrity of the Union in its pristine glory. have believed that if re-elected, he would consider the Baltimore platform, (as he did his former Chicago platform) "a law unto himself;" and that the doctrines enunciated therein would be adhered to by him as the text-book of his Presidential action. It is unnecessary for us to review the doctrines laid down in the Baltimore platform or to trace the unhappy consequences which we believe would be inflicted upon the country by strictly carrying out those doctrines. Our views upon these questions are well known to the community. We are looking at the gloomy side of the picture-that of Mr. 's re-election, and his probable future course; but we may be mistaken about Mr. Lincoln, and he may be the man for the times, although we have been unable to "see Perhaps the McClellan party are following after strange lights and do not see quite as clearly as the opposition. TELEGRAPHIC FREAKS .- The Telegraph is a queer institution. There is no account ing for its quirks and freaks of late, upon any other hypothesis than to throw the blame of its frequent and spasmodic inaccuracies upon the operators who figure along the line of its operations. We are among those who regard the Telegraph as one of the greatest improvements ever developed by the genius of man. It is a medium through which ideas can, and ought to be, communicated accurately and intelligibly across the continent in "less than no time."
