Specific Contract Decision.

The Oregonian has the following in re lation to a decision recently rendered in the Circuit Court, Multnomah county, by Judge Shattuck, in the case of J. Bloom vs. Thomas Stephens:

"Suit was brought on three promissory "Suit was brought on three promissory notes given by defendant last Spring, amounting, with the interest accrued, to about the sum of \$8,600, the notes specifically providing for payment to be made by defendant in gold and silver coin. The defendant proved that he, last August, tendered plaintiff the amount of principal and interest then due, in Legal Tender Notes, which were refused by the plaintiff, who brought suit for coin, under the provisions of the law to authorize courts to enforce the navment of specific contracts passed since payment of specific contracts passed since tender was thus made. The Court decided that this Act was valid under the laws of mat this Act was valid under the laws of Congress, and awarded judgment for payment in gold and silver, as contracted in the notes, holding that tender made last August was not a bar to the operation of the law in this case, and did not defeat the recovery at this time. This is the first judgment renthis time. This is the first judgment ren-dered under the new law, and the decision of the Court touches several important points, and affords a precedent that may be valuable to persons, generally, as well as to courts.

The effect of this decision if finally sus tained, will be to enforce payment in gold and silver coin in all cases whether contracts were entered into before or after the passage of the contract law. If no contract existed etween the creditor and debtor, previous to the passage of the act, still the debtor under the operations of this decision, would be compelled to pay the ereditor in gold and silver, if exacted by the latter. It would appear that the law by this construction is ed by the latter. It would post fucto in its nature. It relates back in its operation and may compel payment in coin where debts existed prior the passage of the law and where no agreement or understanding was made as to the kind of currency to be paid; and inasmuch as greenback currency was equally a legal tender the same as gold and silver, before the passage of the specific contract act, it stands to reason that the legal tender notes should be made acceptable for debts in all cases and up to the time that the specific contract law went into effect. It appears from the decision rendered in the case of "Bloom vs. Stephens," that the court made the decision without reference to the legal tender act of Congress, and just as if that act never had any real existence. The decision pays no respect to the legal tender law, at any stage of its existence, and it makes a man pay in gold and silver for debts contracted back to the time the legal tender law was supposed to have gone into operation. In short, the decision treats the greenback law as a nullity, having no practical force or validity.

It must be perfectly plain to every one that Congress in passing the legal tender law acted with a view to making the greenback notes as legal a currency as either gold or silver, with the exceptions named on the back of the notes. Now if these notes are lawful money and "legal tender" for debts, public and private, it is nonsense for an in-dividual to attempt to enforce the payment

The Funeral of Chief Justice Taney.

The remains of the late venerated Chief Justice Taney, who died on the 12th inst., in Washington, in the 88th year of his age, were removed, by special train, on Saturday, the 15th inst., to Frederick city, where, in the 15th inst., to Frederick city, where, in accordance with his request, they were deposited in the old Catholic burial-ground, by his mother's side. They were accompanied from Washington by the male members of the immediate family of the deceased, with a few of his nearest friends, and by the Attorney General of the United States, the Clerk of the Supreme Court and the Marshal of the District, who, with Messrs. Carlisle, Robinson and Stone, of the Washington Ber, attended as mall-bearers. The train was liste, Robinson and Soine, or use Washington, Bar, attended as pall-bearers. The train was met at the Relay House by the Judge of the District Court of the United States, the Hon. Wm. P. Giles, and a few friends of the family from Baltimore city, and arrived at Frederick shortly after eleven "o'clock.—
The funeral escort was there joined by the sampless of the Baranda a number of the cit. members of the Bar and a number of the members of the Barand a number of the circus of Frederick, and proceeded, amid the tolling of bells, to St. John's Catholic Church where a crowded congregation was already assembled. The coffin was received at the foot of the nave, by a large number of the clergy, and placed upon an elevated catafalque in front of the altar. After the celebration of a High Mass of deep solemnity, with a placent and impressive sermon from the que in from o i in aitar. After the ceiebration of a High Mass of deep solemnity, with an eloquent and impressive sermon from the Rev. Father Maguire, late President of the Georgetown College, the body of the Chief Justice was borne by his professional brethren and friends to the near churchyard, where, with the leaves of autumn falling on the uncovered heads of the assemblage, it was reverently committed to the earth according to the touching ceremonial of his faith. Upon the modest stone, beside which the grave of the illustrious dead was opened, it was recorded that the mother of his affections had gone; fully fifty years before him, to her resting place, and there was something inexpressibly affecting in the thought of that childlike simplicity and devotedness of heart, in which the struggles and triumphs of intellect and ambition, the pride of station the explicitions and flattering of excession.

of intellect and ambition, the pride of station the seductions and flatteries of society and power, through half a century of greatness, had failed to weaken for a moment the pious tenseity of filial remembrance. To the manly and high serenity of such a nature it is easy to understand the utter insignificance personal detraction and partizan maligni-in life. How foolish and idle their atty in life. How looish and lost their as tempt to stand between the memory of such a character and the reverential opinion of good men or the crowing verdict of time! Among the mourning friends who where last to leave the humble spot where the venerable magistrate was laid, were his old and attached colored servants, one of whom, at least, had been his slave and manumited by his kindness forty years ago, before philanthropy had left men's hearts to be a party clap-trap. Their unaffected grief was, in itself, a vindication and a history.
