**Letter from the Dalles.**  
DALLES, May 29th, 1862.  
MESSRS. EDITORS—The cry here is, "still they come,"—not McDuff's hosts in pursuit of his antagonist, but the swelling waters of the Columbia. On Wednesday morning last the lower end of Main street was submerged, causing the occupants of the buildings in that locality to retire in haste to the higher grounds adjacent, and convert private residences and tents into business houses. Some of us most ardently hoped the destructive element would not advance so as to overflow the higher points on Main street, but we were doomed to disappointment. By Wednesday night at ten o'clock the business houses as far up the street as the Western Hotel were deserted, and the rise still threatening those situated farther up. It is thought that the stone buildings at the lower end of the street, in which the water has risen to the depth of several feet, will be entirely ruined, the materials used in their construction not being considered "water-proof." A case illustrating the danger to which these buildings are liable in consequence of high water, occurred during the last term of court in this place. A certain owner of two of them sold out a short time before the high water, but was obliged to dispose of a couple of obnoxious tenants before he could confirm the sale by securing possession to the purchaser. To the surprise of the community, he had the property sold to a party, probably driven to the last resort, brought a celebrated and invincible gentleman by the name of Richard Roe alias John Doe, and secured a continuance of the case until the next term. This though the litigation won't cause the buildings to stand or fall, it will make a slight difference in the small matter of dollars and cents as to who really owns them at the moment of their demolition.
