2. LIBTECH CONSORTIUM MEMBERSHIP UPDATE

As noted in the RFP, "a few additional Phase 1B libraries may still be added in 2023 depending on availability of equipment from other grant sources". Sufficient outside funding and equipment have been secured to add the following libraries to the confirmed membership roster for 2023:

- East Adams Library System Ritzville Public Library, Lind Community Library & Washtucna Community Library
- Asotin County Library System Downtown Branch, Heights Branch Library & Asotin High School Branch Library
- Grandview Library Single Site System/Branch
- Cle Elum Carpenter Memorial Library Single Site System/Branch

Additionally, the **Lopez Island Library** has been moved to the 1B category and will now be added in a later year. Exhibit D - LIBTECH Membership and Phases has been revised to reflect these membership and phase updates.
