

On behalf of the Office of the Secretary of State and election officials statewide, I am honored to present the 2023 General Election Voters' Pamphlet. This guide includes information about voting to help you make informed decisions as you exercise your right to vote.

To participate in the election, you must be registered to vote. Voter registration forms that are mailed or completed online must be received by Oct. 30. If you are already registered, review your registration information at **VoteWA.gov** to ensure it is up to date. After Oct. 30, you must visit an elections office or voting center during regular business hours or until 8 p.m. on Election Day, Nov. 7, to register to vote or update your registration and receive a ballot.

After you have marked your ballot, be sure to sign the return envelope. Your signature is important because trained election officials check to ensure your signature matches the one on your voter registration record before they count your ballot. Next, return your ballot. If returning by U.S. mail — no postage necessary — remember that ballots must be postmarked by Nov. 7 to be counted. You can also use an official ballot drop box anywhere in the state. Drop boxes are open until 8 p.m. on Election Day. Go to **VoteWA.gov** to locate a ballot drop box or check the status of your ballot.

By voting, you are making your voice heard. Thank you for participating in our democratic process.

Qualifications

To vote, you must be at least 18 years old, a U.S. citizen, a resident of Washington, and not currently serving a



sentence of total confinement in prison.



If you're 16 or 17 years old, you can sign up as a Future Voter and be automatically registered to vote when you qualify.

Registration deadlines



By mail or online:

Your application must be received no later than October 30.

In person: Visit a local voting center no later than 8 p.m. on November 7.

Check your registration info at **VoteWA.gov**.

Moved? Update your voting address

Contact a county elections office to request a ballot at your new address.

By October 30: Have your application received by mail or updated online.

Or

By November 7: Visit a local voting center in person.

What if I'm not 18 yet?



If you are 16 or 17, become a Future Voter!



Sign up online at **VoteWA.gov** with your Washington state driver's license, permit, or ID. Or you can fill out a paper registration form using the last four digits of your Social Security number and mail it in. You'll be automatically registered to vote when you qualify. If you will be 18 by the November Election, you can vote in the Primary Election.

Every January on Temperance and Good Citizenship Day, high school students 16 and older have the opportunity to complete a voter registration form in class.

Your right to vote is restored when you are no longer serving a sentence of total confinement in prison.

If I am a victim of a crime. can I vote safely?



Keep your voting address confidential

You may be able to enroll in the Address Confidentiality Program (ACP) and register as a Protected Records Voter if you are:

- · a survivor of domestic violence, sexual assault, trafficking, stalking; or
- a criminal justice participant or election official who is a target for harassment.

To become a Protected Records Voter:

- You meet with a Certified Advocate who can assist with threat assessment, safety planning, and the program application.
- The best time to enroll is when you move or are planning to move to a location that is unknown to the offender and undocumented in public record.

How do I know if something is true?

When reviewing online or printed information, think about:

- Who made this, and who is it for?
- Why did they make it?
- When was this made?
- What makes it believable?
- How might other people read this message?
- Ask the experts consult a fact-checking site or ask an official source. Get trusted info from your county auditor or elections office.

What's in the budget?


Operating Budget: pays for day-to-day operations of state agencies, colleges and universities, and public schools (including federal funds and dedicated funds).

Transportation Budget: pays for transportation activities, such as designing and maintaining roads and public transit.

Capital Budget: pays for acquiring and maintaining state buildings, public schools, higher education facilities, public lands, parks, and other assets.




If you're registered to vote, there is no need to request a ballot. Your ballot will be mailed by October 20 to the address you provide on your voter registration. If you need a replacement ballot, contact a county elections office listed at the end of this pamphlet.







Vote your ballot and sign your return envelope. We need your signature to accept your ballot. You are not required to vote every race on your ballot. We encourage using this pamphlet to help you decide.






Return your ballot by mail, no stamp needed. If mailed, your ballot must be postmarked by November 7. Don't let a late postmark disqualify your ballot.





Or, return your ballot to an official ballot drop box. Drop boxes are open until 8 p.m. on November 7. Find drop box locations at VoteWA.gov.





If you cannot personally return your ballot, let only people you trust deliver it for you.



Check the status of your ballot on VoteWA.gov to see if it has been received by your county elections office.







Election staff will contact you before your ballot is processed if:

- · Your signature is missing
- Your signature doesn't match your voter registration record

After 8 p.m. on election night, tallied results from each county are posted at results.vote.wa.gov.

Results are updated as counties report and unofficial until certification.

Letter from the Auditor's Office

Dear Asotin County Voters,

Your General Election ballot will be mailed by October 20th and should arrive a few days later. For your ballot to be counted, you must sign your yellow envelope with a verifiable signature, or if you are unable to sign please mark an X that is witnessed by two people who must also sign the yellow ballot envelope. Power of Attorney is not valid for voting purposes. Your ballot must be received in any one of our drop boxes before 8:00pm on Election Day or postmarked no later than Tuesday, November 7th. Please return ballots as soon as possible.

Ballot drop boxes are located in the alley behind City Hall in downtown Clarkston, in the parking lot behind Lincoln Middle School in the Clarkston Heights, and in the Asotin County Courthouse. Stamps are not required to mail your ballot.

The Elections Department will make every attempt possible to contact you should there be a discrepancy with signature verification, unsigned ballot envelopes, etc. If the issue is not resolved prior to November 27th, the day prior to election certification, your vote may not be counted.

Reminders: please make sure the yellow ballot envelope that you are signing has your name on it and not another family member from your household. If you have moved, please cross a line through the old address and write the new address next to it. The elections department will update your address after certification of the election.

If you haven't received your ballot by October 27th, please contact the Auditor's Office to receive a replacement. Our phone number is (509) 243-2084 ext. 1534.

Resolution No. 2023-11

A RESOLUTION PLACING AN EXCESS PROPERTY TAX LEVY FOR AN AMBULANCE SERVICE OPERATED BY THE CITY OF CLARKSTON, ON THE BALLOT AT A SPECIAL ELECTION TO BE HELD ON NOVEMBER 7, 2023 IN CONJUNCTION WITH THE STATE GENERAL ELECTION TO BE HELD ON THE SAME DATE.

WHEREAS, the City of Clarkston has established and operates an ambulance service providing emergency medical services and ambulance transport to the residents of the City of Clarkston; and

WHEREAS, the City portion of the cost of said Ambulance services for 2024 is anticipated to be \$875,979.00; and

WHEREAS, if the Ambulance is discontinued, the City will be unable to meet its obligations to IAFF #2299, a labor contract; and

WHEREAS, RCW 84.52.052 AUTHORIZES AN EXCESS PROPERTY TAX LEVY TO SUPPORT OBLIGATIONS OF CONTRACT AND FOR OTHER PURPOSES UPON VOTER APPROVAL; and

WHEREAS, the lack of emergency medical services care to the residents of the City of Clarkston constitutes an emergency dealing with health and welfare of the citizens of the City;

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF CLARKSTON IN REGULAR MEETING ASSEMBLED AS FOLLOWS:

SECTION 1.0

That a special election is to be held in the City of Clarkston, State of Washington, on November 7, 2023, in conjunction with the state general election to be held on the same date. This election is for the purpose of submitting an excess levy proposition as authorized by RCW 84.52.052 in the amount of \$875,979.00 to the electors of said City for their approval or rejection, the proceeds thereof be placed in the Ambulance/EMS Fund of the City to be used for the maintenance and operation of the Ambulance Service.

SECTION 2.0

Proposition: Shall the City of Clarkston, Washington, authorize the County Commissioners of Asotin County to levy in the year 2024 as part of the ad valorem real property taxes to be collected for the City in 2024 the sum of \$875,979.00, which will require a rate of approximately \$1.45 per thousand dollars of assessed valuation of the aforesaid City based upon the assessment ratio of 100 percent of true and fair value. Said tax levy is to be in addition to the maximum levy provided by law for such City. The proceeds thereof are to be placed in the Ambulance / EMS Fund to be used for the maintenance and operation of the Ambulance / Emergency Medical Services Unit, which shall be submitted to the electors of said City for their approval or rejection in the form of the following ballot title:

The Clerk of the aforesaid City is hereby directed to immediately transmit to the Asotin County Auditor a copy of this Resolution duly signed and attested and upon receipt of which the Asotin County Auditor is hereby requested to concur in the finding of an emergency and to take all procedural steps necessary and as are required by law to the end that this proposition shall be submitted to the voters of said City.

Education

Clarkston High school graduate. As part of my career as an electrician, I was trained in analytical troubleshooting, the ability to analyze a problem, gather necessary information, and work out solution(s). These skills should be beneficial in addressing current issues in the district, including matters dealing with improving and modernizing the high school.

Statement

As per the school facilities manual on the k12.wa.gov website, "School district board of directors has the responsibility and authority to determine the type of school facilities it desires for the district and to select the building design team. Citizens play a key role in the schools in their community, and should be encouraged to participate in school planning activities as early as possible." As promised in the last bond voter pamphlet, I presented a plan for the high school in writing and in person to every member of the school board and the superintendent. The board has to do the first step by establishing an advisory committee to research an alternate frugal plan. Board has sole discretion and so far has indicated no interest in any other plan except for an expensive new school, which was rejected four times by taxpayers.

An extremely important issue is high school security. Several times, I suggested inexpensive, easy to do solutions and the board failed to act. Clarkston school district 2021-22 report card shows 48% ELA, 28.2% math, 47.5% science students are meeting standards, yet 73% graduate in 4 years. It's essential we do better. The problem is not the teachers, they are well qualified. I presented to school officials several possible improvements, but again no action. Everyone I talked with the last few months, for and against the bond, want the very best for Clarkston schools. Therefore, let's put our differences aside, brainstorm, and work together for the best possible outcome.




