On behalf of the Office of the Secretary of State and election officials statewide, I am honored to present the 2023 General Election Voters' Pamphlet. This guide includes information about voting to help you make informed decisions as you exercise your right to vote.

To participate in the election, you must be registered to vote. Voter registration forms that are mailed or completed online must be received by Oct. 30. If you are already registered, review your registration information at **VoteWA.gov** to ensure it is up to date. After Oct. 30, you must visit an elections office or voting center during regular business hours or until 8 p.m. on Election Day, Nov. 7, to register to vote or update your registration and receive a ballot.

After you have marked your ballot, be sure to sign the return envelope. Your signature is important because trained election officials check to ensure your signature matches the one on your voter registration record before they count your ballot. Next, return your ballot. If returning by U.S. mail — no postage necessary — remember that ballots must be postmarked by Nov. 7 to be counted. You can also use an official ballot drop box anywhere in the state. Drop boxes are open until 8 p.m. on Election Day. Go to **VoteWA.gov** to locate a ballot drop box or check the status of your ballot.

By voting, you are making your voice heard. Thank you for participating in our democratic process.

The ballot return envelope has free postage, but don’t let a late postmark disqualify your ballot. The USPS recommends that you mail a week before Election Day.

Qualifications

To vote, you must be at least 18 years old, a U.S. citizen, a resident of Washington, and not currently serving a sentence of total confinement in prison.



If you're 16 or 17 years old, you can sign up as a Future Voter and be automatically registered to vote when you qualify.

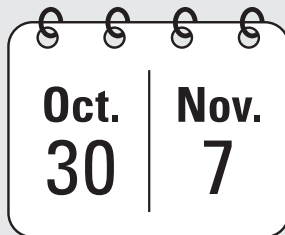

In person: Visit a county elections office (listed at the end of this pamphlet).

Registration deadlines



By mail or online: Your application must be received no later than October 30.

In person: Visit a local voting center no later than 8 p.m. on November 7.

Check your registration info at VoteWA.gov.

Moved? Update your voting address

Contact a county elections office to request a ballot at your new address.

By October 30: Have your application received by mail or updated online.

Or

By November 7: Visit a local voting center in person.

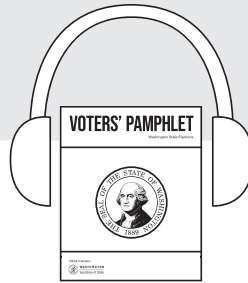

Sign up online at VoteWA.gov with your Washington state driver's license, permit, or ID. Or you can fill out a paper registration form using the last four digits of your Social Security number and mail it in. You'll be automatically registered to vote when you qualify. If you will be 18 by the November Election, you can vote in the Primary Election.

Every January on Temperance and Good Citizenship Day, high school students 16 and older have the opportunity to complete a voter registration form in class.

Your right to vote is restored when you are no longer serving a sentence of total confinement in prison.

You must re-register to vote in order to receive a ballot.

You may re-register to vote by mail, in person, or online at **VoteWA.gov**.

If I am a victim of a crime, can I vote safely?



Keep your voting address confidential

You may be able to enroll in the Address Confidentiality Program (ACP) and register as a Protected Records Voter if you are:

- a survivor of domestic violence, sexual assault, trafficking, stalking; or
- a criminal justice participant or election official who is a target for harassment.

To become a Protected Records Voter:

- You meet with a Certified Advocate who can assist with threat assessment, safety planning, and the program application.
- The best time to enroll is when you move or are planning to move to a location that is unknown to the offender and undocumented in public record.

How do I know if something is true?

When reviewing online or printed information, think about:

- Who made this, and who is it for?
- Why did they make it?
- When was this made?
- What makes it believable?
- How might other people read this message?
- Ask the experts — consult a fact-checking site or ask an official source. Get trusted info from your county auditor or elections office.



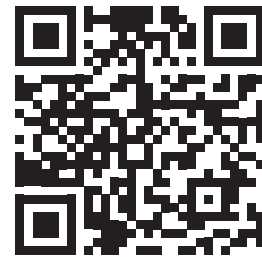

What's in the budget?

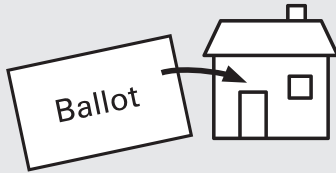
Operating Budget: pays for day-to-day operations of state agencies, colleges and universities, and public schools (including federal funds and dedicated funds).

Transportation Budget: pays for transportation activities, such as designing and maintaining roads and public transit.

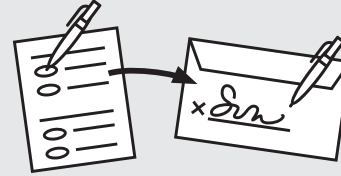
Capital Budget: pays for acquiring and maintaining state buildings, public schools, higher education facilities, public lands, parks, and other assets.

How do I vote and return my ballot?

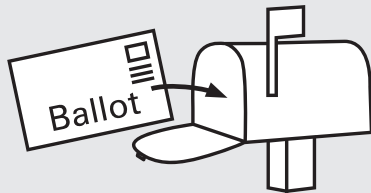
1 If you're registered to vote, there is no need to request a ballot. Your ballot will be mailed by **October 20** to the address you provide on your voter registration. If you need a replacement ballot, contact a county elections office listed at the end of this pamphlet.



2 Vote your ballot and sign your return envelope. We need your signature to accept your ballot. You are not required to vote every race on your ballot. We encourage using this pamphlet to help you decide.

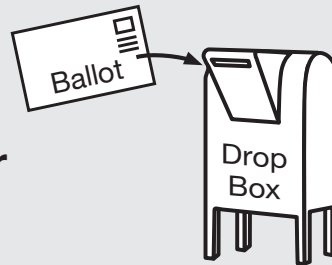


3 Return your ballot by mail, no stamp needed. If mailed, your ballot must be postmarked by **November 7**. Don't let a late postmark disqualify your ballot. The USPS recommends that you mail a week before Election Day.




Or, return your ballot to an official ballot drop box. Drop boxes are open until 8 p.m. on **November 7**. Find drop box locations at **VoteWA.gov**.

Or



If you cannot personally return your ballot, let only people you trust deliver it for you.

4 Check the status of your ballot on **VoteWA.gov** to see if it has been received by your county elections office.



Election staff will contact you before your ballot is processed if:

- Your signature is missing
- Your signature doesn't match your voter registration record

View election results online

After 8 p.m. on election night, tallied results from each county are posted at **results.vote.wa.gov**.

Results are updated as counties report and unofficial until certification.

Online and by mail - October 30 by 5:00 p.m.

In person - November 7 by 8:00 p.m.

It is illegal to:

- Vote if you are not a United States citizen;
- Vote if you have been convicted of a felony and have not had your voting rights restored;
- Cast a ballot or sign a ballot declaration on behalf of another voter.

Accessible voting



Using Clear Access

Cowlitz County voters who are unable to vote their ballot in the standard way have the option to vote independently using an accessible voting unit (AVU). The Clear Access AVU can display larger type or provide an audio ballot for persons with visual or cognitive disabilities. The equipment supports a number of assistive switches.

Beginning 18 days before each primary or election, the Clear Access unit is available from 8:30 a.m. to 5:00 p.m., and on Election Day from 7:00 a.m. until 8:00 p.m. at the Cowlitz County Elections Office.

Ballot drop box locations

Castle Rock - 137 Cowlitz St West, in front of the Castle Rock Library

Kalama - North 1st St, near the Kalama Post Office boxes

Kelso - Bridge Market Lane, between LJ's Furness Drug and the Allen St Bridge

Kelso - 207 N 4th Ave, Admin Building North Entrance parking lot

Longview - Broadway St, east of the Longview Post Office boxes

Longview - Civic Center Circle, across from Broadway St, near the Longview Post Office boxes

Ryderwood - 208 Morse St, next to the Ryderwood Library

Woodland - City parking lot at Davidson and 2nd St, near the City's utility payment drop box

Ballot drop boxes are open 24 hours a day starting October 19, 2023, and close promptly at 8:00 p.m. on Election Night, November 7, 2023.



We recommend dropping your ballot in one of our secure drop box locations. If you choose to mail your ballot instead, ballots come with prepaid postage, so no stamp is necessary. Don't be late! Mail early so that your ballot is postmarked by Election Day, November 7, 2023.

Keep your registration current

While the Elections Office is continually updating the voter rolls with information from the Department of Licensing, the post office, local obituaries, and a monthly public health deceased list, you can do your part by following these simple steps:

- Update your address with the Elections Office whenever it changes. Address changes can be made through votewa.gov, by email, mail, or phone until October 30. You may update your registration in-person until 8:00 p.m. on Election Day, November 7.
- If you are a snowbird or a college student, call or email our office to set up a seasonal or temporary mailing address.
- Return to Sender! If you receive a ballot for a person who does not live at your address, write "Does not live here" on the unopened envelope and put it back in the mail. Do not drop in a ballot drop box.
- If you receive mail for a recently deceased voter, write "Deceased" on the unopened envelope, and put it back in the mail. We will research and follow up.



Candidate and measure statements are printed exactly as submitted.

No spelling, punctuation, or grammatical corrections have been made.

Cowlitz County does not confirm that the statements printed are true or factual. The candidate or committee is responsible for content.

This provides voters a candid, unedited view of submissions.

To register to vote you must be:

- A citizen of the United States.
- A legal resident of Washington State.
- At least 18 years old.
- Not disqualified from voting due to a court order.
- Not serving a sentence of total confinement for a Washington felony conviction.
- Not currently incarcerated for a federal or out-of-state felony conviction.

Voting tips



Fill out your ballot

You can use any color of pen to complete your ballot. You do not have to vote in every race to have your ballot counted. Make selections in the contests you'd like to vote, and you can skip those that you're unsure about.



Sign your envelope

Don't forget to sign the back of your return envelope. Your ballot cannot move forward in the process without a valid signature.

Return your ballot on time

We recommend dropping your ballot in a drop box to ensure it is received on time.



If returning by drop box, there are 8 secure drive up locations across the county. You can find a list on page 12 of this pamphlet. Drop boxes close promptly at 8:00 p.m. on Election Day, November 7, 2023.

If returning by mail, your ballot must be postmarked by Election Day, November 7 in order to be counted. No stamp is needed.



You can also return your ballot in-person at the Cowlitz County Elections Office up until 8:00 p.m. on Election Day.

Change in office hours

The Elections Office will be temporarily changing its business hours to accommodate voters during the 18-day voting period.

The office will be open Monday – Friday, 8:30 a.m. until 5:00 p.m. This change will begin October 16, 2023, and continue through November 3, 2023.

The office will resume the normal business hours of Monday – Thursday, 7:00 a.m. – 5:00 p.m. on November 6, 2023.

Extended hours of service will be provided on Election Day only, November 7, 2023, from 7:00 a.m. – 8:00 p.m.

Proposition 1

Creation of a Metropolitan Park District

The City Council of Longview adopted Resolution No. 2455 concerning the creation of a Metropolitan Park District to levy a property tax to raise funds restricted to parks and recreation.

The proposition would create a metropolitan park district governed by the Longview City Council as the *ex officio* board of commissioners, in accordance with RCW 35.61, with the authority to levy a general tax on all property located in the District each year, not to exceed twenty-five cents per thousand dollars of assessed valuation, to fund parks and recreation.

Shall the City of Longview Metropolitan Park District be so created and governed?

Explanatory Statement

The Longview City Council passed Resolution No. 2455 to allow voters to decide whether to create the City of Longview Metropolitan Park District with boundaries coterminous with the City of Longview, as now or hereafter established. If approved, this proposition would create a metropolitan park district with all the powers provided in chapter 35.61 RCW, including, but not limited to, the authority to levy a general tax on all property located in the District each year not to exceed twenty-five cents per thousand dollars of assessed valuation. The District would be governed by the Longview City Council as the *ex officio* board of commissioners to support parks and recreation programs.

This proposition provides that the City would maintain its current general fund support of the Longview Park and Recreation Department and that the Metropolitan Park District would pay the City to increase support to the Park System. The District would pay for this increased support by imposing a property tax that would be \$0.25 per thousand dollars of assessed value or \$87.75 per year for an average home with a value of \$351,000. The money would be used to pay the City to improve and maintain City parks, address deferred maintenance and project backlog, replace park restrooms and picnic shelters, improve park safety and lighting, facility and park amenity repair, sports field and court improvements, repair boating facility infrastructure, and support other Parks programs.

Argument For

Summary

The City of Longview operates a Parks and Recreation system that includes 300 acres of parks and various recreation programs. While the present budget for this department provides money for basic maintenance and operations, there is no money for capital improvements or replacement of facilities that have reached the end of life. This will all change with a *for* vote for the creation of a Metropolitan Parks District.

How the money will be spent:

The money raised will be used to replace aging bathroom facilities, develop new trails, and make sorely needed repairs. The proposal is structured so that the money must be used for capital improvements and not for general operating expenses.

Grant qualification

The money raised by the District can be used as matching funds for various State and organizational grants. Most of these grants require a 50% match so we can use District money to complete even more projects in our parks system. Right now we can't capitalize on these grants because we cannot come up with our 50% share of the money needed to qualify for the grant.

Your cost and benefits

The cost to the homeowner would be 25 cents per \$1000 of assessed valuation. This means less than \$88 per year for a home valued at \$351,000. We hope that you agree with us that this is an investment in our city that is worthy of your support. We ask you to vote *for* on this issue.

Rebuttal of Argument Against

Without a Parks District the city will be unable to meet our expectations for well-maintained, clean, safe, and enjoyable parks and park facilities.

Voting yes for a Parks District grants the City no new additional authority except for the ability to collect 25 cents per \$1,000 valuation for the purpose of supporting the parks we all enjoy.

There's a plan to catch up on deferred maintenance and repairs. A yes vote is for better parks.

Argument Against

Forming a Metropolitan Park district is complicated, be informed!

Once voters approve the formation of the park district, that is where their input ends.

City Council has decided to make themselves the managing directors of the park district. This gives them the authority to annex property, reroute roads, and spend taxed funds as they see fit, all without voter oversight.

If the citizens of Longview decide that the park district is not working for them, only city council can remove it.

The city is proposing a forever tax of 50 cents per \$1000 of property value which can be raised by 25 cents per year, at the councils whim.

Without a doubt, this is a continual tax increase. Is this what is best for Longview? A vote "No" keeps more money in the hands of Longview citizens.

After 8 p.m. on Election Day all scanned ballots are tallied. Ballots will be scanned and tallied over the next several days until all the votes are counted. Every county conducts a post-election audit.



New Washington resident

Welcome! Register to vote online, by mail, in person, or when you get your new driver's license or ID at the Department of Licensing. You may not vote in more than one place, so cancel your previous voter registration.

**Military or overseas voter**

Register to vote anytime on or before Election Day. You may receive your ballot by mail, email, or fax. Spouses and dependents also away from home have the same voting rights.

**College student**

Register to vote using either your home or school address, but you may not vote in more than one place. Your ballot can be mailed to you anywhere in the world; however, your residential address must remain in Washington.

**Non-traditional address voter**

Use any physical location you consider your residence such as a shelter, park, or marina. Your mailing address can be general delivery at a local post office, a PO Box, or an address of a trusted friend or relative. A federally recognized tribe may designate tribal government buildings to serve as residential or mailing addresses for voters living on tribal lands.

**Seasonal resident**

Vote in Washington even if you're away during an election. To ensure you receive your ballot, update your mailing address at VoteWA.gov or with a county elections office. Your ballot can be mailed to you anywhere in the world; however, your residential address must remain in Washington. You may not vote in more than one place.

**Person convicted of a felony**

If you were convicted of a felony in Washington, your right to vote is restored when you are no longer serving a sentence of total confinement in prison. After your right to vote is restored, you must re-register to vote in order to receive a ballot.

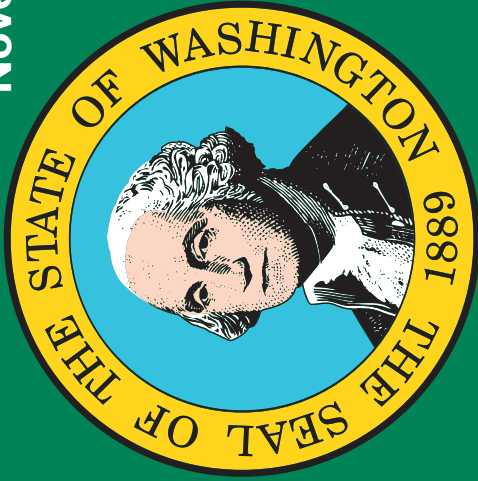
