On behalf of the Office of the Secretary of State and election officials statewide, I am honored to present the 2023 General Election Voters' Pamphlet. This guide includes information about voting to help you make informed decisions as you exercise your right to vote.

To participate in the election, you must be registered to vote. Voter registration forms that are mailed or completed online must be received by Oct. 30. If you are already registered, review your registration information at **VoteWA.gov** to ensure it is up to date. After Oct. 30, you must visit an elections office or voting center during regular business hours or until 8 p.m. on Election Day, Nov. 7, to register to vote or update your registration and receive a ballot.

After you have marked your ballot, be sure to sign the return envelope. Your signature is important because trained election officials check to ensure your signature matches the one on your voter registration record before they count your ballot. Next, return your ballot. If returning by U.S. mail — no postage necessary — remember that ballots must be postmarked by Nov. 7 to be counted. You can also use an official ballot drop box anywhere in the state. Drop boxes are open until 8 p.m. on Election Day. Go to **VoteWA.gov** to locate a ballot drop box or check the status of your ballot.

By voting, you are making your voice heard. Thank you for participating in our democratic process.

Qualifications

To vote, you must be at least 18 years old, a U.S. citizen, a resident of Washington, and not currently serving a sentence of total confinement in prison.



If you're 16 or 17 years old, you can sign up as a Future Voter and be automatically registered to vote when you qualify.

How do I register to vote?



By mail: Request a paper form be mailed to you or print your own at sos.wa.gov/elections

No internet access? Call 1 (800) 448-4881.

In person: Visit a county elections office (listed at the end of this pamphlet).

Registration deadlines



By mail or online: Your application must be received no later than October 30.

In person: Visit a local voting center no later than 8 p.m. on November 7.

Check your registration info at VoteWA.gov.

Moved? Update your voting address

Contact a county elections office to request a ballot at your new address.

By October 30: Have your application received by mail or updated online.

Or

By November 7: Visit a local voting center in person.



Sign up online at VoteWA.gov with your Washington state driver's license, permit, or ID. Or you can fill out a paper registration form using the last four digits of your Social Security number and mail it in. You'll be automatically registered to vote when you qualify. If you will be 18 by the November Election, you can vote in the Primary Election.

Every January on Temperance and Good Citizenship Day, high school students 16 and older have the opportunity to complete a voter registration form in class.

Felony conviction?



Your right to vote is restored when you are no longer serving a sentence of total confinement in prison.

You must re-register to vote in order to receive a ballot.

You may re-register to vote by mail, in person, or online at **VoteWA.gov**.

If I am a victim of a crime, can I vote safely?



Keep your voting address confidential

You may be able to enroll in the Address Confidentiality Program (ACP) and register as a Protected Records Voter if you are:

- a survivor of domestic violence, sexual assault, trafficking, stalking; or
- a criminal justice participant or election official who is a target for harassment.

To become a Protected Records Voter:

- You meet with a Certified Advocate who can assist with threat assessment, safety planning, and the program application.
- The best time to enroll is when you move or are planning to move to a location that is unknown to the offender and undocumented in public record.

How do I know if something is true?

When reviewing online or printed information, think about:

- Who made this, and who is it for?
- Why did they make it?
- When was this made?
- What makes it believable?
- How might other people read this message?
- Ask the experts — consult a fact-checking site or ask an official source. Get trusted info from your county auditor or elections office.

What's in the budget?


Operating Budget: pays for day-to-day operations of state agencies, colleges and universities, and public schools (including federal funds and dedicated funds).

Transportation Budget: pays for transportation activities, such as designing and maintaining roads and public transit.


Capital Budget: pays for acquiring and maintaining state buildings, public schools, higher education facilities, public lands, parks, and other assets.

How do I vote and return my ballot?


1 If you're registered to vote, there is no need to request a ballot. Your ballot will be mailed by **October 20** to the address you provide on your voter registration. If you need a replacement ballot, contact a county elections office listed at the end of this pamphlet.



2 Vote your ballot and sign your return envelope. We need your signature to accept your ballot. You are not required to vote every race on your ballot. We encourage using this pamphlet to help you decide.




3 Return your ballot by mail, no stamp needed. If mailed, your ballot must be postmarked by **November 7**. Don't let a late postmark disqualify your ballot. The USPS recommends that you mail a week before Election Day.



Or, return your ballot to an official ballot drop box. Drop boxes are open until 8 p.m. on **November 7**. Find drop box locations at **VoteWA.gov**.

Or



If you cannot personally return your ballot, let only people you trust deliver it for you.

4 Check the status of your ballot on **VoteWA.gov** to see if it has been received by your county elections office.



Election staff will contact you before your ballot is processed if:

- Your signature is missing
- Your signature doesn't match your voter registration record


After 8 p.m. on election night, tallied results from each county are posted at **results.vote.wa.gov**.

This election, candidates will be running for local positions.

As a voter, here are ways to ensure that your ballot is counted:

- Return your voted ballot quickly
- Use a ballot drop box whenever possible
- If you return your ballot via US Postal Service, make sure it is postmarked by General Election Day, November 7, 2023
- Sign your return ballot envelope
- If you receive a letter from our office regarding your signature, return it to our office as soon as possible.

The sooner voters return their ballots, the more complete the results will be when we post them on election night!

Instructions

Vote for one in each contest




Fill in the box to the left of your choice using black or blue ink.

You may leave a contest blank, your ballot will still count.

If you vote for more than one, no votes will be counted for that race.

Correcting a mistake



Draw a line through the incorrect candidate name or ballot. You may then you may make another choice.

Optional write-in

To vote for a candidate not listed in that contest, fill in the box to the left of the dashed line and print the name on the line.

Vote your ballot...

- Use a blue or black ink pen to mark your ballot.
- You may leave a contest blank, your ballot will still count.
- Put your voted ballot in the security sleeve.
- Put the security sleeve in the return envelope.
- Seal the return envelope.
- Sign and date the declaration on the return envelope. If you are unable to sign, make your mark and have it witnessed by TWO people. *Ensure that both people sign the envelope.*
- A power of attorney cannot be used to sign a ballot.

Place your ballot in a ballot drop-box ...

- Deposit your ballot in a drop box. Drop boxes are picked up by Elections department staff, not the USPS. See drop box locations on the next page.
- Drop boxes are open 20 days before Election Day. They remain open 24 hours a day until 8:00 PM Election Night.
- Skagit County Elections strongly encourages using drop boxes.

Or return your ballot by mail...

- NO STAMP** required if mailed in the U.S.
- Ballots sent by USPS **MUST** be postmarked no later than Election Day*

Proposition No. 1

Fire and Emergency Services Levy Lid Lift

The City Council of the City of Sedro-Woolley adopted Resolution No. 1121-23 concerning a levy lid lift to fund fire and emergency services. This proposition would fund fire and emergency services, including additional firefighter/EMTs to improve response times. This proposition would increase the City's regular property tax by \$0.8165/\$1,000 assessed valuation; not exceeding a total rate of \$2.6173/\$1,000 for collection in 2024. The 2024 levy amount, less expiring levies, will be the permanent basis to calculate subsequent levies, per RCW 84.55. Qualifying seniors, veterans, and others would be exempt, per RCW 84.36.

Explanatory Statement

Written by City of Sedro-Woolley

RCW 84.55.050(1) allows cities to increase property taxes above the 1% limit, if the increase is voted on and approved by a majority of voters in an election. This ballot proposition asks the voters in Sedro-Woolley to approve a one-time permanent levy increase in order to support the continued provision of fire and emergency medical services, including the hiring of 8 additional firefighter/EMTs or paramedics. Call volume has increased 44% since 2018, resulting in approximately 1100 additional calls for service per year. The additional 1100 calls per year result in overlapping calls for service. During January through June 30th of 2023, 37% of Sedro-Woolley's incidents have had a second 911 emergency happen prior to crews being able to complete their first assigned incident. Additional positions will help reduce call times and improve level of service. The City's general fund does not provide adequate funding for additional personnel. If approved by a majority of voters, a new maximum regular tax levy amount of \$2.6173 per \$1000 assessed value would be established. The average impact to a taxpayer that owns a \$400,000 home is calculated to be approximately \$326.58 per year, or \$27.22 per month.

Argument For

The Sedro-Woolley Fire Department is facing a critical challenge with an increasing population and decreasing membership to ensure the safety and well-being of its citizens.

Relying on a fire department that is primarily staffed with volunteer firefighters is no longer sustainable to meet the needs of our rapidly growing community. While volunteer firefighters play a crucial role in providing emergency services, volunteerism as a whole is declining. This has left the fire department at times with no scheduled staff at fire station 2. With year-over-year call volume increasing to 3,635 emergency calls in 2022 and daily staffing being minimal, it puts higher demand on our already limited staff. The investment in this levy would allow our fire department to provide cost-effective fire and EMS services by employing 8 full-time professional firefighter/EMTs to work alongside our very own local volunteers.

Career firefighters will provide consistent daily coverage at both station 1 and station 2, which is vital for responding to emergencies. This comprehensive approach aims to improve emergency response capabilities, reduce response times, and enhance the overall level of services provided by the Sedro-Woolley Fire Department, all while building longevity within our city. Additionally, these funds would go towards providing essential medical training and supplying necessary lifesaving equipment for these 8 full-time firefighters.

Supporting this levy would ensure Sedro-Woolley's citizens' safety and well-being for years to come. Keep our citizens and first responders safe. Vote Yes!

Rebuttal of Argument Against

The police department passed a similar levy in 2020, this 2024 levy is separate to address the needs of the Sedro-Woolley Fire Department both now and for years to come. A vote 'yes' for this proposition will add 8 full-time firefighter/EMT's, that will ensure consistent staffing alongside volunteers, preventing unmanned stations and units. This unanimous Council-approved measure, endorsed by city legislators, administration, and membership, is aligned with the mission to protect both lives and property.



This proposition would finance fire protection and emergency medical services by restoring the District's regular property tax levy in 2023 to an amount not to exceed \$ 1.05 per \$1,000.00 of assessed valuation and authorize setting the limit factor at 103% for the following five years. The maximum allowable levy in the final year shall serve as the base for subsequent levy limitations as provided by Chapter 84.55 RCW.

Explanatory Statement

Written by Fire Protection District No. 6

Skagit County Fire Protection District No. 6 provides emergency fire protection and medical services to its citizens. If approved by the voters, this proposition will authorize the District to restore its regular real property tax levy rate to \$1.05 per \$1,000 of assessed valuation in 2023 for collection in 2024 (the current levy is approximately \$.70 per \$1,000 of assessed valuation and the District's tax levy rate was previously at \$1.05 in 2018). The proposition also establishes an annual growth rate of up to three percent for following five years. The dollar amount levied in the final year will be subject to the statutory one percent limit.

The District's Board of Commissioners has determined that this proposition is necessary to maintain an effective level of services, fire fighter staffing, equipment and facilities in light of rising costs. Approval of this measure will allow the District to maintain the level of fire protection and emergency medical services provided to its citizens.

Skagit Fire District 6 needs your support to pass a fire levy to keep up with the community demands on fire and emergency medical services. Call volumes have increased 102% since 2016. There were over 1,250 calls in 2022 of which 67% were medical related incidents.

Skagit FD6 is asking voters to approve a \$0.35 lid lift to return the levy rate to a \$1.05 per \$1,000.00 of assessed property value which will bring the rate up to the same rate approved by voters in 2018.

The approved levy will provide two additional resident firefighters, replace an aging ambulance, replace, and add much needed breathing/oxygen tanks and protective gear for firefighters, additional sleeping quarters for the resident firefighters that will enhance and increase 24-hour firefighting and emergency service response time for residents living within Fire District 6.

With the growing population, increasing ages of existing residents, increasing costs associated with the current day economy and the growing demand on FD6 services, it is important to pass this levy request to maintain the quality of service that Fire District 6 provides. In addition, these improvements will maintain or improve the Fire District's risk rating that will positively affect homeowner's insurance premiums.

Your county receives your ballot



Your signature is verified

Your signature is important and we need it to accept your ballot. The signature on your return envelope is compared to the signature on your voter registration record.
