Dear Judge Bridges:

Petitioners write in response to the WSDCC's request that the Court modify the scheduling order to require other respondents to disclose witnesses as well as illegal votes and other errors by Friday, April 15. Petitioners do not object to the Court's setting a date for such disclosures, though that issue was not discussed at the hearing last week, and it may not be fair to the other parties to require disclosure on such short notice. While it may be that no other party intends to allege errors or illegal votes, as the WSDCC suggests, any notice should give them sufficient time to prepare their disclosures. Petitioners propose that the Court set May 6 as the disclosure date for other respondents, as that is the date the Court set for the Intervenor-Respondents WSDCC.


