District Court. The District Court, Hon. J. R. Lewis, Chief Justice, presiding, convened in this town last Monday at 11 o'clock a. m.

The U.S. Grand Jury was empaneled on the same day, and consists of the following persons: A. McAllister, Wm. Bishop, G. H. Gistler, S. Hancock, B. F. Loveland, R. B. Holbrook, James Kavanagh, D. M. Whitehill, C. A. Anderson, John Smith, Wm. Ward, H. D. Coffey, James Smith, Horace Tucker, J. G. Clinger.

All of the above-named gentlemen were also on the Territorial Grand Jury except the five persons last above mentioned. Those places the following were selected: D. H. Rothchild, L. M. Moore, J. E. Fugh, A. F. Leonard and Geo. Tharbo. E. B. Hubbard, Foreman.

In the suit of Burton vs. Katz and others, the demurrer to the complaint was sustained. The court held that plaintiff could not sue in his own name. Objection sustained, jury discharged and case sent to the Grand Jury.

C. H. Rothchild for retail license accepted, and license ordered to be issued at the rate of \$300 per annum. The application of Richard Thompson for retail liquor license at Fort Ludlow rejected. Petition of E. S. Fowler and J. J. Hunt for permission to build a wharf at the foot of Adams street, granted as by the County Commissioners have power to grant. Ordered, that sealed proposals be received for building county jail, and that the Auditor publish notice of the same in the WEEKLY ARGUS. Board adjourned.
