

Claim-Jumping and Murder.

It will not be a most difficult matter to arrive at all the facts with regard to the killing of the Ward Brothers at Lake Minnewauken. That these young men have been stigmatized with the opprobrious name of "claim-jumpers" does not affect the nature of the crime one iota. In Dakota, as well as anywhere else, the attack upon the Wards by a mob of armed men, resulting in the death of the former, will be regarded by all right-thinking men as containing the essential nature of murder. We have law enough in Dakota, and sufficient ability and willingness to execute that law, to settle all criminal matters without the intervention of an unscrupulous and unreasoning mob, who individually less of real principle and influence than the victims they sacrifice. Without any special reference to this Ward case, respecting which the facts are yet to be ascertained, we do not hesitate to avow our sympathy with the claim-jumper rather than with the original claimant, where we have been familiar with the facts. Thousands of acres of land, which may be quite truthfully said, have been filed upon in this Territory by parties who never had the slightest intention of carrying out the provisions of the law, who never would make settlers, and who took the claims for purposes of speculation pure and simple; and all this to the personal detriment of every man who comes into the Territory to make a real home therein. Prevention, lying, fraud, and perjury, have characterized too many of these claims. We regard it as a burning disgrace to the general government and an injustice to every honest settler, that the testimony of perjured men is accepted by the land department equally as readily as that of honest claimants, without any attempt whatever being made to substantiate the statements by any official examination. We sympathize with the honest settler, who through sickness or poverty, or through the pressure of unavoidable business that compelled his absence, fails to comply with all the letter of the law with regard to filing. The smallest medium of common sense will convince any one who thinks upon the subject that such a man should be protected against the claim-jumper. On the other hand we would have no mercy on the speculator, whose deliberate purpose is to evade every requirement of the law that can possibly be ignored, to get possession of a quarter-section with the smallest investment of labor, time, or money, and to hold it for an advance of price as soon as he has made his final proof. How is it that those townships can be found in which there is not a vacant claim to file on, and yet scarcely a resident settler or five dollars' worth of improvements to the square mile? The answer is found in the words we have already used, that "prevention, lying, fraud, and perjury, have characterized too many of these claims." The stigma and the crime should be attached to the fraudulent claimant, not to the man who "jumps" such a claim for the purpose of doing settlement duty and making the claim his real home.—Dakota Ez.

Beware of False Prophets.

Now that the big Wiggins scare is over and no one hurt would it not be better for intelligent people to take a more sensible view of matters that are beyond human ken than listening to the senseless vapors of impudent adventurers, who profess to unfold the secrets possessed alone by the Omniscient One? During a period of nearly ten years the daily press has teemed with the vague conjectures of a set of vipers, who have brazenly assumed to map out the character of the season and locate storm dates many months in advance of the time predicted for their coming. The worst feature in the case is a large percentage of the people have, to a considerable extent, taken these idle vapors upon trust, and are often guided by them in their business affairs. This has been particularly true with a large portion of the agricultural people, and quotations from Tice, Vennor, Couch, etc., have been nearly as current as the daily fluctuations of wheat and corn in metropolitan markets. One after another these fellows have come to grief, until the intelligent portion of the people have ceased to pay attention to their predictions, but treat them with the contempt they deserve. The sole objects these adventurers have in view is to create a sensation, and gain a sufficient publicity to enable them to sell the almanac, which nearly or quite every one of them publish. Some of them have in this way reaped a handsome reward in dollars and cents, and this is the allurement which draws others on. Each succeeding adventurer of this class is a greater fraud than those who have preceded him; it appearing a necessity to him, in order to get the public ear, to outdo in impudence all others engaged in the same line. We hope our agricultural friends will go to work this spring when the soil is in fit condition for tillage, paying not the least regard to the senseless vapors of these charlatan adventurers, but rather place their trust in Him who has placed the "bow of promise" in the heavens, and who has no vice-regent on his planet to whom he has imparted the secret of the "times and seasons." If the press would cease to give utterings of these weather predictions, the occupation of the authors of them would soon come to a timely end. This alone gives respectability to either the men who make them or the predictions themselves.—Burlington Husker.

A Crowl from Palouse.

PALOUSE CITY, W. T., May 16, 1883. EDITOR STATESMAN.—Our neighbors over the line are having a domestic fight for the relocation of the county seat from Lewistown to Moscow. We are as deeply interested in the result as the citizens of Nez Perce county; situated as we are on the boundary line, one and a quarter miles distant. Our interests are the same when the success of annexation is an assumed fact, which we hope is not far distant, for it cannot be of any political significance to annex North Idaho to Washington Territory for we would only be represented in Congress by a delegate. It would be better for the people of Nez Perce county to let it remain as it is, and the majority of the people say so by signing the remonstrance against any change in the county by the Twelfth session of the Idaho Legislature. But that ambitious borough, Hog Heaven, scouted the preachers at the last election, although pledged to oppose any change in county affairs. They were not long in trying to carry out the fully understood programme of Moscow. It was so understood by certain town real estate property owners of the borough. They did dare to make it public, but used the parents to deceive the people, who in their zeal to serve their country, Yamhill and Moore, they were not long in showing the cozened folk. But if the people of the north part of the county vote to let it remain as Lewistown, then in the future the people of Lewistown will assist them to fix and bound the boundaries hereafter, so as to be of no advantage and benefit to both the north and south part of the county. Freeman, the man who, in a fit of religious frenzy, murdered his little child, Edith, at Pocomat, Mass., some four years ago, and who was subsequently committed to the asylum at Danvers, is now considered perfectly sane. For some time he has been under merely nominal restraint, being allowed to travel about with a single attendant, pay visits to friends, etc., and there have been no symptoms of a return of his malady. There is an indictment for murder pending against him in the Supreme court, and his case will come up in the term which begins May 1st at Barnstable. Freeman, at the time of the murder, said that he was inspired and commanded by the Lord to offer up the child as a sacrifice. He has no recollection whatever of having committed the crime, and says his "inspiration" must have come from the devil. There is much speculation as to the final disposition of the case, but it now looks as though he would be released on his own recognizance. A Philadelphia exchange, after making an observation on the business situation and outlook, concludes "that American commerce, both internal and external, is sound, solid, prosperous, and flourishing, and that there is no prospect of a financial crisis or an era of contagious and epidemic insolvency. The timidity manifested by the manufacturers is fast giving way before the increasing volume of consumption caused by the renewed confidence in the settlement of the tariff agitation. Financial matters are moving along quietly, with money seemingly growing more and more abundant, and rates gradually receding; the nominal figure of five per cent., with reported transactions above and below that rate." A singular case has been decided at Cleveland. Forty years ago Adam McDowell, a slave, married Maria Walker, another slave. The marriage was solemnized by a duly ordained Christian minister, and with the consent of both masters. McDowell subsequently escaped to Canada, but his wife was recaptured in an attempt to break from bondage. Her husband married again in Canada, and going to Cleveland, amassed considerable wealth, which he bequeathed to his children by the Canadian wife. Mary, the slave wife, brought suit, claiming that the Canadian marriage was illegal. The court has decided in favor of the second wife. Thus the poor slave wife is left in the cold. A decline of 5 s. per quarter, or 15 cents per bushel, in the price of wheat in England has caused heavy losses to certain gentlemen of a speculative turn of mind in London, and the provinces which had bought American wheat on the supposition that the continuous bad weather would cause a rise in prices. The impending bankruptcy of these victims of their own mistaken judgment will be called a "financial disaster," we suppose, but it is a disaster which English working men who have to buy flour for large families can bear with the most complete resignation. In the English army shoe stores scrupulous attention is shown to shape and make in conformity with surgical authority. The inner line of the boot is made straight, so that the great toe is not arched at the same spot. A shoe-maker usually measures his customer's foot when he is seated, and thus fails to allow adequately for expansion. His plan is to stand up and have the outline drawn on paper with a pencil. The British soldier's boots are made wide in the tread and low heeled. We may get by voting by electricity. At least the prospect is introduced by the fact that permission has been obtained to put a patent electrical voting machine in the two houses next session, to illustrate their workings.
