PREAMBLE



INDUSTRIAL WORKERS OF THE WORLD

The working class and the employing class have nothing in common. There can be no peace so long as hunger and want are found among millions of the working people and the few, who make up the employing class, have all the good things of life.

Between these two classes a struggle must go on until the workers of the world organize as a class, take possession of the earth and the machinery of production, and abolish the wage system.

We find that the centering of the management of industries into fewer and fewer hands makes the trade unions unable to cope with the ever growing power of the employing class. The trade unions foster a state of affairs which allows one set of workers to be pitted against another set of workers in the same industry, thereby helping to defeat one another in wage wars. Moreover, the trade unions aid the employing class to mislead the workers into the belief that the working class have interests in common with their employers.

These conditions can be changed and the interest of the working class upheld only by an organization formed in such a way that all its members in any one industry, or in all industries if necessary, cease work whenever a strike or lockout is on in any department thereof, thus making an injury to one an injury to all.

Instead of the conservative motto, "A fair day's wage for a fair day's work," we must inscribe on our banner the revolutionary watchword, "Abolition of the wage system."

It is the historic mission of the working class to do away with capitalism. The army of production must be organized, not only for the everyday struggle with capitalists, but also to carry on production when capitalism shall have been overthrown. By organizing industrially we are forming the structure of the new society within the shell of the old.

**REPORT AND MINUTES OF THE GENERAL
EXECUTIVE BOARD SESSION FROM
AUG. 14 TO AUG. 30**

Chicago, Illinois, Aug. 30, 1919.

Fellow Workers:

The newly installed General Executive Board sends greetings to all the membership, both in and out of jails, and to the working class in general.

As to the general condition of our organization, we are pleased to report that, despite the persecution of our members by the hirelings of the plutocracy, we are growing at a most encouraging rate. The workers are awakening to the dangers that lie ahead and are turning to Industrial Unionism as a solution of all economic and social ills and inequalities.

The re-organized Marine Transport Workers' Industrial Union No. 8 is experiencing a splendid increase in membership on both the Atlantic and Pacific coasts, and along the Great Lakes, and is in active and sympathetic touch with Transport Workers of the other Maritime nations of the world.

Agricultural Workers' Industrial Union No. 400 is in the midst of an enormous drive for membership. With hundreds of delegates in the field, they are making good on their slogan, "Come on, 400!" and confidently expect an increase of 10,000 by September 1.

Construction Workers' Industrial Union No. 573 is growing steadily in all parts of the country, and will commence a concentrated drive in the middle states in September. From now on a printed bulletin will be issued by this union every week, which is expected to be a model in every way.

Metal and Machinery Workers' Industrial Union No. 300 is having better success than was anticipated, and conditions are now so shaping themselves that the prospects of this union are more than encouraging. It should have a vast increase in membership during the coming Fall and Winter.

Railroad Workers' Industrial Union No. 600 is increasing steadily. One great sign of increasing interest among the Railroad Workers is the fact that on many roads only the migratory worker with a Wobbly card is able to get by.

Hotel, Restaurant and Domestic Workers Industrial Union No. 1,100 forges steadily ahead, preparing the way for dignifying a service that even the workers have heretofore regarded as menial. Every worker can help strengthen this union by demanding that the waiters and others wear the H. R. & D. W. I. buttons.

In the Lumber and Mining Industries of the Northwest we find L. W. I. U. No. 500 and M. M. W. I. U. No. 800 going strong. This is very encouraging when we consider that this section has been under the Iron Heel more than any other. Other sections are stirring also, and both Lumber Workers and Metal Miners have more calls for organizers than they are able to supply.

The Textile Workers' Industrial Union No. 1,000 is progressing, and recently began publishing the Textile Worker at Paterson, N. J.

The other unions are growing according to the vigor of their membership and the spread of knowledge among the workers in their industries.

Now, Fellow Workers, our present growth is a positive demonstration that we cannot be destroyed as an organization. We may receive setbacks, but the principles of Industrial Unionism are immortal. The working world is now awakening to class con-

sciousness, and we have the opportunity to demonstrate that the Industrial Unions can take over the industries and save a civilization that has been wrecked by the greed and corruption of its plutocratic overlords. We have been accused of attempting to wreck the social structure when we pointed out its inherent rottenness and warned the world of the impending disaster. Our function is to save the good there is in life and restore the world to sanity.

A hundred forceful and determined men could now overthrow capitalism, but in the present disorganized state of the working class, only chaos could result from such an act—a disaster that would be irretrievable. Our duty is to organize the workers, not so much to overthrow capitalism, for it dissolves before our very eyes, as to carry on production and guarantee the needs of life, and create social stability when the old system goes upon the rocks. This is the task of the working class—the task for which we must prepare.

Remember, also, that we have hundreds of faithful Fellow Workers languishing in the unspeakable jails to whom we must give an adequate defense. Our best defense, of course, is organization—an overwhelming increase in our numbers; but, while we build the unions as the final fortress of defense, let us also contribute largely to the immediate battle and the propaganda through the courts.

GENERAL EXECUTIVE BOARD MEETING

August 14, 1919

Meeting of the General Executive Board called to order at 9:30 a. m. by Secretary-Treasurer Thos. Whitehead. Members present: John Jackson, Fred Nelson, Charles Miller, George Bradley and James King.

John Jackson was elected temporary chairman. James King was elected recording secretary.

Resolutions, communications and bills taken up and placed in their proper order as nearly as possible.

Adjourned at 5:20 p. m.

August 15, 1919. Meeting called to order at 9 a. m. by temporary chairman.

New business. Moved by Nelson, seconded by King, that resolution pertaining to tentative agreements be referred to Industrial Unions. Carried. (Note—This resolution suggested getting out leaflets, stating the wages and conditions we would work for. Also that tentative agreements be made with employers. As this is a matter for the Industrial Unions, it was referred to them for action.)

Moved by G. Bradley, seconded by H. Bradley, that resolution asking for a book of instruction and advice for delegates be referred to Industrial Unions, with recommendation that they get out a book of instructions to delegates. Carried.

Moved by King, seconded by G. Bradley, that we recommend all Industrial Unions to send delegates to radical conferences in their locality. Carried.

Moved by G. Bradley, seconded by Nelson, that we concur in the following resolution: Any person working under the supervision of the G. E. B., and who shall submit reports not founded upon facts, or who shall exaggerate the facts for any reason in his report, shall be discharged by the G. E. B. at once. Each person employed shall be informed of this ruling upon being employed by the General Executive Board. (Note—We take this action because in times past the membership have been led to believe that enormous strikes were on where there was probably a very small affair. We do not gain anything by exaggerating facts; if we state the plain facts we will know better where we stand.)

Moved by H. Bradley, seconded by G. Bradley, that we concur in the following resolution: That in all Industrial Unions and Headquarters the letter files are of no use after three months. If any errors occur they will come to light in that time. All Industrial Unions, General Office, Recruiting Unions and Defense Committee shall destroy all letters of delegates upon the closing of their accounts and the issuance of a clearance card. Carried. (Note—We advise this, not because we fear our usual correspondence, but because we do not want the organization held responsible for the ravings of some individual, or any letters that may be planted in our files.)

Adjourned at 11:55 a. m.

Called to order at 1:00 p. m.

Fellow Worker George Speed elected permanent chairman.

Moved by Nelson, seconded by Jackson, that the General Executive Board members be paid from the time of starting for the meeting till they get finished, including time taken to reach their destination. Carried.

Moved by Jackson, seconded by Nelson, that all defense and relief stamps be called in except what the referendum calls for, by September 1. Carried.

Moved by Jackson, seconded by Nelson, that housewives who are the wives of workingmen shall be admitted to membership in H. R. & D. W. I. U. 1100 of the I. W. W. Carried. We take this action because we deem it necessary to keep in touch with housewives as they have a tremendous effect on the men in time of strikes, and this is the proper union to have them if we are going to get them with us and educate them to their class position. Miller opposed to motion.

Moved by G. Bradley, seconded by King, that owing to the increased cost of the new cards, duplicate cards shall be charged for at the rate of 50 cents per card (this to include the changing of a partly filled old card for a new card), while

continuation cards shall be free, the same as usual. Carried.

Moved by G. Bradley, seconded by Nelson, that we the Secretary of the Defense be empowered to start a speaker on a tour of publicity in Europe and to arrange meetings enroute to the Atlantic Coast. Carried.

Moved by Jackson, seconded by Nelson, that notice be published in all I. W. W. papers, requesting members to send in any suggestions they may have as to ways and means of building up the organization. Carried. (Note—We wish to get a better line of communication with the membership, so we will know the sentiment of the membership at all times.)

Meeting adjourned at 5:15 p. m.

August 16, 1919. Meeting called to order at 9 a. m. by chairman.

G. E. B. Member Geo. Bradley of M. T. W. recommends a delegate to represent M. T. W. and R. R. W. I. U. No. 600 at International Transportation Congress, to be held at Amsterdam in October. Moved by Miller, seconded by H. Bradley, that the recommendation be given the endorsement of the G. E. B. Carried.

Moved by Jackson, seconded by Nelson, that universal credentials be approved as presented. Carried.

Moved by Nelson, seconded by H. Bradley, that we do not concur in the recommendation of No. 573 and that class war prisoners shall be given the same stamps as other members. Carried.

Adjourned 11:50 a. m.

Meeting called to order by chairman at 1 p. m.

Moved by King, seconded by H. Bradley, that October 1 shall be set as date to check all supplies on hand, in all Industrial Unions. Supplies on hand on this date and supplies and stamps actually sold previously, but not remitted for, will be taken as a basis to start new accounts. Carried. (Note—We set this date ahead instead of back, like the convention, because it is almost impossible to go back and get a check, where it would be easier to work ahead.)

Moved by King, seconded by H. Bradley, that all employes and elected officials paid by the general office shall not be paid over \$28 per week. Motion lost. King, H. Bradley and G. Bradley voted for the motion. (Note—The convention was told by one employe that he could not work for less than \$40 a week, but still they nominate him and he is elected by a referendum ballot, while the secretary-treasurer is instructed by the convention to hire a bookkeeper whom they knew would not work for \$28.)

Moved by King, seconded by H. Bradley, that no employe of the general office, or elected official,

shall be given any further raise of wages without the consent of the G. E. B. Carried.

Moved by Jackson, seconded by Nelson, that bills paid to Industrialists by the Duluth Defense Committee, be turned over to the General Defense Committee for collection; funds collected in this way to be used for general defense. Carried.

Meeting adjourned at 5:15 p. m.

August 17, 1919. Meeting called to order 9:20 by chairman.

Moved by Nelson, seconded by G. Bradley, that we instruct all secretaries of recruiting and Industrial Unions that all members must be transferred to their respective Industrial Unions as the constitution provides. Carried.

Moved by Jackson, seconded by G. Bradley, that an organizer be sent to the Kentucky coal fields, as requested by Metal Mine Workers' Industrial Union No. 800, headquarters to be reimbursed by No. 800, as set forth in letter from A. S. Embree. Carried.

Moved by Nelson, seconded by King, that Hotel, Restaurant and Domestic Workers' Industrial Union shall be classified in the public service. Carried.

Moved by George Bradley, seconded by King, that the G. E. B. approve the action of Industrial Union secretaries, editors of papers, and secretary-treasurer, in forming General Defense Committee and electing William D. Haywood as secretary. Carried.

Moved by George Bradley, seconded by King, that the secretary of the General Defense Committee be instructed to issue a general defense bulletin at least once a week. Carried.

Meeting adjourned at 1:50 p. m.

August 18, 1919. Meeting called to order at 9 a. m. by chairman.

Moved by Nelson, seconded by Jackson, that the secretary-treasurer be instructed to pay Attorney Recht \$500 on account and the balance as the organization is able. Carried.

Moved by Jackson, seconded by G. Bradley, that defense funds shall be segregated from organization funds. Amended by King and seconded by H. Bradley, that itemized and summarized reports shall be segregated. Amendment carried.

Meeting adjourned at 12 noon.

Meeting called to order at 1 p. m. by chairman.

Moved by King, seconded by Nelson, that secretary-treasurer be instructed to write Attorney Siegel requesting data as to what work he did for the defense, and on whose authority. Carried.

Moved by King, seconded by Nelson, that secretary of Defense Committee be instructed to avoid the building of a network of attorneys as far as possible. Carried. George Bradley, Miller and Jackson opposed.

Moved by Nelson, seconded by Miller, that communication of Attorney Arthur LeSeuer be placed on file. Carried.

Meeting adjourned at 5:10 p. m.

August 19, 1919. Meeting called to order at 9 a. m. by chairman.

Moved by Nelson, seconded by Jackson, that constitution be accepted as read. Carried.

Moved by G. Bradley, seconded by King, that constitutions be made the same size as the due books. Carried.

Moved by King, seconded by H. Bradley, that the secretary be instructed to pay Fellow Worker T. A. Jenkins the \$21.47 due him for wages for work he was hired to do by the convention. Carried.

Moved by George Bradley, seconded by H. Bradley, that the secretary-treasurer be instructed to advance M. M. W. I. U. No. 300 the sum of \$500 in two monthly installments, with \$500 more to be advanced later if the first money shows results, this money to be charged against M. & M. W. I. U. No. 300 and returned as soon as possible. Amended by King, seconded by Nelson, that the second \$500 shall not be advanced unless they make some attempt to pay their per capita tax to headquarters. Carried, with the amendment included.

Moved by Jackson, seconded by Miller, that secretaries of Industrial Unions be requested to pay per capita tax to headquarters at the end of each month. Carried. (Note—Fellow Workers, headquarters has quite a heavy demand for organizers and financial assistance from small unions, so it is up to those unions that are able to pay their per capita tax regular. Headquarters also has to pay cash for all supplies, but cannot do so unless helped by the Industrial Unions.)

Adjourned at 12 noon.

Meeting called to order at 1 p. m. by chairman.

Moved by Nelson, seconded by Miller, that General Organization shall charge Industrial Unions for the new due books at the rate of 20 cents per book. Carried. (Note—The increased charge is due to the increased cost of the new book.)

Moved by King, seconded by H. Bradley, that all Industrial Union secretaries shall be instructed to transact business with other Industrial Unions on a 50 per cent basis. Carried.

Moved by King, seconded by Miller, that secretary-treasurer be instructed to get out a universal loose leaf ledger, based on the book used by Industrial Union No. 600, with two extra columns for business done with other Industrial Unions. Carried.

Moved by G. Bradley, seconded by King, that Defense Committee, in case of absence of present secretary, shall elect a secretary pro tem, who shall

hold no other official position while acting as secretary of the defense. Carried.

Meeting adjourned at 5:20 p. m.

August 20, 1919. Meeting called to order at 9 a. m. by chairman.

Moved by G. Bradley, seconded by H. Bradley, that play, called "General Strike" offered by Robin Dunbar, to be published in pamphlet form, be returned to him with an explanation of why we could not use it. Carried.

Meeting adjourned at 12:10 p. m.

Meeting called to order at 1 p. m. by chairman.

Moved by H. Bradley, seconded by Miller, that matter of Haywood's account be laid over until we can get further information. Carried.

The afternoon was taken up in conference with the various editors and the manager of the publishing bureau.

Meeting adjourned at 5:10 p. m.

August 21, 1919. Meeting called to order at 9 a. m. by chairman.

Members present: Jackson, H. Bradley, Speed, Miller, George Bradley and King, Fred Nelson having left for home.

Moved by King, seconded by G. Bradley, that manager of printing plant discontinue all outside work so that we can take care of our own work. Carried.

Moved by King, seconded by Miller, that papers shall not be held up for the printing of pamphlets, papers to have precedence at all times. Carried.

Moved by G. Bradley, seconded by H. Bradley, that manager of printing plant shall be instructed to sell all old machinery that is useless, the funds so derived to be used to pay off on machinery already bought. Carried.

Moved by H. Bradley, seconded by King, that all editors and the manager of the printing plant shall meet and make arrangements as to when the copy for each paper shall be submitted and printed, a copy of these arrangements to be posted in each editorial office. Carried.

Moved by Jackson, seconded by G. Bradley, that editors and manager of printing plant shall meet once a week so as to insure co-operation. Carried.

Meeting adjourned at 12:30 p. m.

Meeting called to order at 1:30 p. m. by chairman.

Moved by Miller, seconded by H. Bradley, that any group wishing to start new papers must furnish the G. E. B. with a statement of funds on hand and their future prospects. Carried.

Moved by Jackson, seconded by Miller, that editor of German paper and press committee shall be instructed to issue their paper semi-monthly until we see if it will warrant a weekly edition. Carried.

Moved by King, seconded by Miller, that Spanish paper shall be discontinued after the next issue.

Carried. (Note—The reason for this action is because the paper is running in debt on an average of \$200 a month and hasn't much of an outlook.)

Moved by King, seconded by H. Bradley, that all editors of papers now running in debt to General Headquarters shall be informed that if their papers do not show an improvement within three months we will be forced to suspend the papers. Carried. Miller opposed.

Moved by G. Bradley, seconded by H. Bradley, that manager of printing plant shall be raised to \$35 per week. Carried.

Moved by Jackson, seconded by H. Bradley, that shipping clerk shall give written order for pamphlets direct to manager of printing plant after getting the approval of the secretary-treasurer, so as to facilitate the publishing of pamphlets, and that manager shall be requested to recognize these orders. Carried.

Moved by King, seconded by H. Bradley, that the following price list be adopted for the literature named:

New Unionism by Andre Tridon, 25 cents per copy, \$15 per hundred.

Haywood's Testimony Ind. Rel. Com., 10 cents per copy, \$5 per hundred.

Doran's Testimony, Chicago Trial, 10 cents per copy, \$5 per hundred.

Everett Massacre, by W. C. Smith, 50 cents per copy, \$35 per hundred.

Vanderveer's Opening Statement, 10 cents per copy, \$3.50 per hundred.

Haywood's Testimony, Chicago Trial, 15 cents per copy, \$10 per hundred.

Chicago Trial, by H. George, 25 cents per copy, \$15 per hundred.

Note—Fellow Workers, we have thousands of these very good pamphlets on hand. They should be gotten into the hands of the workers, and we believe they can, at these prices, if everyone will put his shouldr to the wheel and try to sell them.

Moved by G. Bradley, seconded by King, that we publish a vest pocket edition of the Industrial Relations Commission report, one that will meet the need of the present day. Carried.

Adjourned at 5:10 p. m.

August 22, 1919. Meeting called to order at 9 a. m. by chairman.

Moved by King, seconded by H. Bradley, that secretary-treasurer be instructed to have constitutions printed in various languages, as he has call for them. Carried.

Moved by H. Bradley, seconded by Jackson, that editor of Solidarity be empowered to get out a book of cartoons, the initial issue to be not more than 10,000. Carried.

Moved by G. Bradley, seconded by H. Bradley, that inasmuch as there is no call for sheet music

and phonograph records, the secretary-treasurer shall be instructed not to have any made. Carried.

Moved by G. Bradley, seconded by H. Bradley, that Solidarity be issued as a six-page paper, the defense to get at least one page. Carried. King opposed.

Moved by G. Bradley, seconded by H. Bradley, that History, Structure and Methods of the I. W. W. be accepted as revised by St. John. Carried.

Meeting adjourned at 12 noon.

Meeting called to order at 1 p. m. by chairman.

Moved by King, seconded by H. Bradley, that bills of H. W. McMillan, due Charles H. Kerr & Co., be turned over to No. 800. Carried.

Moved by Miller, seconded by H. Bradley, that the G. E. B. communicate with Justus Ebert to find out if he can write a handbook of the I. W. W. and what his terms will be. Carried.

Moved by King, seconded by H. Bradley, that secretary of the defense be instructed to communicate with Attorney John Lind, with the purpose of having him handle the case of Masanovitch and others. Carried.

Moved by King, seconded by Miller, that secretary-treasurer be instructed to communicate with the officials of the Canadian One Big Union, requesting information regarding their movement. Carried.

Moved by Miller, seconded by H. Bradley, that we cannot comply with the request of the secretary-treasurer of M. T. W. that old dues stamps and books be issued to him, to in turn be issued to Marine Transport Workers of England at the rate of \$1 for initiation fee and 25 cents per month dues, as it would be in direct contradiction to the constitution and the last convention. Carried.

Moved by King, seconded by Miller, that the secretary-treasurer be instructed to inform the District Council of New York that the G. E. B., upon due consideration of all material available upon the New York situation, find that they are functioning as an excellent propaganda committee, but not as a district council, so that therefore we cannot issue them an Industrial District Council Charter. Carried.

Meeting adjourned at 5:20 p. m.

August 23, 1919. Moved by G. Bradley, seconded by H. Bradley, that the Russian editor be permitted to issue a Russian paper three times a week as requested. Carried.

Moved by G. Bradley, seconded by King, that secretary-treasurer shall be instructed to keep in closer touch with organization papers, especially those outside of Chicago. Carried.

Meeting adjourned at 12 noon.

Meeting called to order at 1 p. m. by chairman.

Moved by King, seconded by Jackson, that owing to the constitution not outlining the function of In-

Industrial District Councils, and as we cannot see any urgent necessity for such bodies, we recommend that if Industrial Unions find it necessary, they form a Central Committee to carry out the wishes of the Industrial Unions. We further recommend that the forming of Industrial District Councils be withheld till functions of said councils have been outlined by a general convention and ratified by a referendum ballot. Carried.

The balance of the afternoon was taken up with the appeal of T. B. Weber on expulsion from Los Angeles Recruiting Union.

Meeting adjourned at 5:15 p. m.

August 24, 1919. Meeting called to order at 9 a. m. by chairman.

Moved by King, seconded by Bradley, that we notify Los Angeles Recruiting Union that we cannot take any action in the case of J. Waugh against T. B. Weber for the following reasons: Because the evidence seems to be nothing but hearsay; and further, the various statements and reports of witnesses and trial are not properly signed and do not have the seal of the branch, the trial committee's report not even having their signatures. Carried. (Note—If the unsigned report of trial committee presented to the board is really official, the evidence would not warrant expulsion.)

Meeting adjourned at 12:20 p. m.

August 25, 1919. Meeting called to order at 9 a. m. by chairman.

Moved by Miller, seconded by H. Bradley, that Defense Committee shall be instructed to pay Mrs. Stenberg \$10 per week relief. Carried.

Moved by G. Bradley, seconded by Miller, that a Spanish organizer shall be sent to Panama as soon as the organization's funds will warrant. Carried.

Meeting adjourned at 12:15 p. m.

Meeting called to order at 1:10 p. m. by chairman.

Moved by G. Bradley, seconded by H. Bradley, that Jewish press committee be empowered to issue five thousand copies of the I. W. W.—The Greatest Thing on Earth, translated into the Jewish language. Carried.

Meeting adjourned at 5:15 p. m.

August 26, 1919. Meeting called to order at 9 a. m. by chairman.

Moved by G. Bradley, seconded by Jackson, that delegate to International Transportation Congress shall be instructed to arrange a system with revolutionary working class organizations of foreign countries whereby members from foreign countries can pay dues in this country, and vice versa. Carried unanimously.

Moved by King, seconded by Jackson, that the editors of the papers shall be instructed to publish articles in the papers to get the sentiment of

the membership of the general organization regarding the raising of dues to \$1 per month. Carried unanimously.

Moved by H. Bradley, seconded by Miller, that owing to the fact that we cannot get the original documents in the case of Jane Street, and considering that the original accuser, Phil Engel, is in Chicago at the present time, but refuses to come before the board to present his side of the case, we can do nothing but give Fellow Worker Street the benefit of the doubt and exonerate her of the charges preferred against her. Carried unanimously.

Meeting adjourned at 12:15 p. m.

Meeting called to order at 1:10 p. m. by chairman.

Moved by King, seconded by H. Bradley, that the following resolution be adopted and copies sent to all parties concerned: Resolved, That M. M. W. I. U. No. 800, or one of its organization committee, has not acted fairly with H. R. & D. W. I. U. No. 1100 in keeping Roberta Bruner, who was making a tour for H. R. & D. W. in Colorado, thereby breaking her tour and causing H. R. & D. W. to suffer a considerable loss of finances expended to advertise and make the tour a success, and be it further resolved that we condemn any action that tends to build up one Industrial Union at the expense of another, and we believe that M. M. W. I. U. No. 800 should pay the loss sustained by H. & R. D. W. I. U. No. 1100. Carried unanimously

Moved by G. Bradley, seconded by King, that songs presented to us by committee be accepted as read, and published as soon as possible. Carried unanimously.

Meeting adjourned at 5 p. m.

August 27, 1919. Moved by King, seconded by Miller, that communication from M. T. W. be turned over to the secretary of the Defense Committee for action on matters pertaining to the defense. Carried unanimously.

Moved by G. Bradley, seconded by King, that telegram from Seattle District L. W. I. U. No. 500 be answered, explaining why we cannot send Fellow Worker Haywood on a tour at the present time. Carried unanimously.

Moved by Miller, seconded by Jackson, that the G. E. B. recommend to all Industrial Union secretaries and district officers that all business between Industrial Unions shall be transacted by the General Office of Industrial Unions. Carried unanimously.

Moved by Speed, seconded by King, that the following resolution be concurred in and that the secretary-treasurer and the secretaries of Industrial Unions shall act as a committee to communicate with officers of the Third International. Resolved,

Whereas the Soviet Republic of Russia in its call for the organization of the Third International, included the I. W. W. as one of the bodies eligible to such new international, and

Whereas, The I. W. W. is the only revolutionary organization in the United States whose program is absolutely scientific and uncompromising, and is the logical American unit of the Third International, and

Whereas, The proletarian revolution is world-wide and not national or local in its scope;

Therefore, The time has come for the I. W. W. to assume its proper place as the American Unit of the Workers' Red International, and to establish closer relations with groups of the same or similar principles in every country, such as the communist of Russia, Hungary, Bavaria, etc., the Spartacans of Germany, the Syndicalists of France, Italy and Great Britain and other countries and the Industrial Unionists of Canada and Australia; therefore, be it

Resolved, That the I. W. W. shall create a committee on International Relations, which shall at once establish and maintain correspondence and fraternal relations with such aforesaid revolutionary groups throughout the world and shall provide for the representation of the I. W. W. as a constituent member of the Third International. Carried unanimously.

Moved by King, seconded by Miller, that the selection of Fellow Worker William France as editor of the Croatian paper be approved, with power to start the paper as soon as possible, he to have the authority to hire someone to do stenographic work and bookkeeping, if necessary. Carried unanimously. Meeting adjourned at 12:15 p. m.

Meeting called to order at 1:15 p. m. by chairman.

Moved by King, seconded by Miller, that editors of paper shall be instructed to put the following plan before the membership: That Industrial Union bulletins shall be published in the various papers instead of each Industrial Union issuing a separate bulletin. Carried unanimously.

Note—The issuance of large printed bulletins by separate Industrial Unions tends to keep down the circulation of the organization papers and takes quite a lot of money that could be used for other purposes. For instance, if the Industrial Worker acts as the official bulletin of the Industrial Unions in the Northwest, the New Solidarity for Industrial Unions in the Middle States, and the Rebel Worker for those in the East, we will avoid the publication of news items which tends to lower the circulation of the papers, and will cut down the expense of the organization as a whole. We must carry on our work as efficiently as any business firm if we wish to survive.

Moved by King, seconded by Bradley, that Fellow Workers Woodruff and Sandgren be appointed a committee to arrange for the writing of an I. W. W. Handbook by Justus Ebert, Ebert to be informed that \$28 per week is the usual scale, but if necessary we will pay him \$35, the same as he receives for working at his trade. Carried unanimously.

Moved by G. Bradley, seconded by H. Bradley, that secretary-treasurer shall be instructed to get out leaflets appealing to colored workers. Carried unanimously.

Meeting adjourned at 5:20 p. m.

August 29, 1919. Meeting called to order at 9 a. m. by chairman.

Moved by H. Bradley, seconded by Jackson, that the G. E. B. endorse the publishing of the Jewish paper, Industrial Arbeiter, in Chicago. Carried unanimously.

Moved by King, seconded by H. Bradley, that all wages shall remain the same as they are, and a referendum ballot be gotten out to decide whether four or five dollars a day shall be the wages for all employes elected to office or appointed by the G. E. B. Carried unanimously. Miller absent.

Moved by Jackson, seconded by G. Bradley, that the question of raising the monthly dues to \$1 per month be included in the referendum ballot on wages. Carried unanimously.

Moved by H. Bradley, seconded by King, that all editors shall request monthly statements with remittances from all parties receiving bundle orders. Failure to comply with this ruling will result in bundle orders being stopped. Carried unanimously.

Moved by King, seconded by G. Bradley, that Industrial Unions shall pay \$100 per month for rent of office and that they shall be given good janitor service. Carried unanimously.

Moved by G. Bradley, seconded by H. Bradley, that G. E. B. appoint Fellow Worker Woodruff to assist G. E. B. members Speed and Jackson to audit the books. Carried unanimously.

Adjourned 12:30 P. M.

Meeting called to order 1:30 P. M.

Moved by G. Bradley, seconded by King, that we notify Paterson Tetile Workers that we cannot sanction affiliation with the Workmen's Circle or any fraternal organization, as it would be contrary to the constitution and would probably cause dissension between the two organizations. Carried unanimously.

Note.—A member of the I. W. W. can belong to any other organization or society he wishes to, but we cannot affiliate as an organization.

Moved by King, seconded by H. Bradley, that the accounts of all the papers under the supervision of the G. E. B. shall be kept by the editors, they

to have vouchers for all money received and receipts for all money expended, beginning as soon as possible. Carried unanimously.

Adjourned 5:00 P. M.

August 30, 1919.

Meeting called to order 9:00 A. M. by chairman.

The morning was spent in going over the minutes and discussing various matters pertaining to the organization work.

Adjourned sine die at 12:00 M.

(Note)

In the body of these minutes notes are occasionally inserted in explanation of the actions of the Board, and a commentary is now added as further explanation of some of the motions, as follows:

The matter of refusal to enter into time agreements is a fundamental principle of Revolutionary Industrial Unionism, and is written into our constitution. However, we have always observed temporary accommodations between the workers and employers, and since the conditions are peculiar to each industry and cannot well be reached by a general recommendation, we feel that these matters should be handled in each instance by the Industrial Union involved in the settlement.

In these times of intense labor unrest, it is highly necessary that the I. W. W. shall do all in its power to stabilize the situation and endeavor to lead sentiment towards sane economic action, rather than in the direction of fanatical insurrectionism. We approve the resolution that the Unions send delegates to radical conferences, as thereby we have an opportunity to exert a rational influence and at the same time keep our finger on the pulse of working class sentiment.

Every strike situation or aggravated labor condition produces a certain amount of hysteria from which even members of the I. W. W. are not immune. Hysteria begets exaggeration, the worst form of misinformation. We can only act intelligently as the actual facts are known, and in the labor world, hasty or ill advised action may ruin the best laid plans of organization. The master class will tell us enough lies in order to mislead us, so let us avoid the pitfalls of exaggeration. As you value Industrial Unionism observe this motto—Truth. The whole truth and nothing but the truth.

The holding of correspondence beyond a reasonable time serves no good purpose. Errors are usually discovered and corrected within 90 days and the retaining of correspondence in regard to accounts that have been definitely closed is a waste of space that can be used to better advantage.

This is a time of greatest activity in labor organization and reactionary unions are especially busy in this regard. It is characteristic that workers are

reluctant to make new union affiliations even after they realize that they have been stung, and this is especially true where job control has been achieved. Many situations are being lost to us because we were not prepared to handle them at the particular moment. It is possible to retrieve many of these losses and enter new fields of organization and no one should hesitate to send in suggestions in regard to these matters—your plan may be the one to succeed.

The International Transportation Workers' Congress at Amsterdam in October will be of great importance. As members of Marine Transport Workers' Industrial Union No. 8 are in close touch with the European workers it will be an easy task to be adequately represented at the congress. With the great movement of the workers back to Europe since the war we are afforded better opportunities for communication now than at any time in the past three years. Here is bound to be a closer bond between the workers in all lands, due to this great return movement.

It is the purpose of the I. W. W. to build up the Industrial Unions as rapidly as the workers of the respective industries can be reached. For that reason, every effort should be made to transfer the members into their proper unions so that they can begin to take action on their own account. To fail in this regard is not only to retard the growth of the organs of the new society, but is a violation of the workers right to properly function with his fellows.

The function of Hotel, Restaurant and Domestic Workers is to cater to the personal needs of the people in regard to the immediate service of food and shelter—an immediate personal service that clearly comes under the head of Public Service.

The action of the Union Secretaries, the Secretary-Treasurers and the Editors of the papers in reorganizing the Defense Committee and electing Fellow Worker Haywood secretary of the same was approved by the Board on account of the need of immediate action. We think Haywood, with his large experience in such matters, is the most capable person available at this time for this work. He will get the work running and when it is possible to place it in other capable hands, which should be soon, he will make a tour of the country in the interest of the defense.

The constitutions were ordered printed the same size as the new due book, so that they can be carried in the same card case and thus avoid inconvenience to the members.

It must be remembered that there are a number of the industries in which we have practically no membership, and these industries must be reached at the earliest moment. Headquarters secures its funds with which to conduct the pioneer work in

these industries from the per capita tax and the organization stamps. The more regularly and fully the per capita tax is paid, the more the propaganda can be carried forward in these unoccupied fields.

At the time of the convention, it was estimated that the new due book could be supplied at 12½ cents, but the steady rise in the price of leather and other materials has put such a price out of the question. It is 20 cents or go back to the old style book.

The organization is anxious to increase the number of language papers so as to reach all the various groups in the country, who should have our message of Industrial Unionism, but we have not the funds with which to do all the work in this line that should be done. In order not to swamp the organization with expenses it is necessary that groups or committees wishing to publish papers in the various languages shall be able to finance them for a time sufficient to determine whether there is a genuine demand for the same. The Spanish paper must be suspended for this reason. It has been a drain on the treasury for some time, but was continued in the hope that it would show an improvement. Fellow Worker Guscetti will try to get the paper out as a monthly until there is a greater interest shown by the Spanish-speaking workers. Other papers that are running behind will be discontinued after three months if they fail to show any improvement within that time.

There is much agitational and other literature that should be got by the organization. Among this is the report of the Industrial Relations Commission, which the board has ordered printed in a vest pocket size. Also a book of the best cartoons that have been printed in our papers. But most important is the hand book of the I. W. W., which is designed to be written in the simplest style and so complete that it can be understood by the simplest person and be translated easily into any language. The idea is that this book should be the entering wedge of Industrial Unionism in all foreign countries.

The Masanovich case in Minnesota has been a sore spot with the I. W. W. ever since these fellow workers were imprisoned. They should be released and active steps have been ordered to get a full hearing and see what can be done for them.

The One Big Union movement of Canada was the nine days wonder for a time, but apparently the premature General Strike at Winnipeg exhausted its infant energies. Under able direction of class conscious workers the O. B. U. should grow and we should lend unstinted aid, but we cannot do anything unless we have information that will permit us to act with intelligence.

In the matter of the Industrial District Councils, we find that the last Convention completely skele-

tonized this institution. The Councils had never functioned and many delegates wanted to abolish them altogether. As they now stand in the constitution, by the last referendum, they have no specific economic function and are designed to promote solidarity in the particular localities. Under these circumstances, the Board does not feel justified in issuing charters giving economic powers to the councils, but rather urges that they be at present used to solidify the work of propaganda and to assist the union delegates in their organizing work.

It is the intention of the I. W. W. to promote a world-wide organization of labor and we are preparing to carry the propaganda into all foreign lands. An aid to this work will be an accommodation between our unions and foreign unions whereby the cards of similar class-conscious organizations will be mutually recognized and the workers enabled to pay dues regularly when away from their homes in other countries. This will aid in breaking down nationalistic prejudices and build up a sense of solidarity.

All delegates in the field are now supplied with universal credentials and are authorized to line up members in all the Industrial Unions, but the delegates must remember that they shall report all business done directly to the Union that appointed them. The transfers of the record will then be made in the office of the Industrial Union. When a 400 delegate lines up a 300 man he reports it directly to the secretary of 400, who squares the transaction with the secretary of 300. Study your report blank.

Get all your supplies from your own union, and the business of squaring the account will be done at the office. This relieves you of doing business with a dozen offices—you haven't the time for that, but the secretary has help that is able to take care of the matter quite easily.

Branch secretaries also transact their business with other Industrial Union secretaries thru their own Industrial Union secretary. This enables the accounts to be checked up and any errors corrected at once.

Remember, we are building the new society within the shell of the old, and the Industrial Unions are the organs of that new society. But one Industrial Union is a futility unless the other Industrial Unions are also organized. A piece of bread may be bread, but it is not the loaf. We are organizing the Industrial Workers of the World.

Our credentials are universal credentials so that no man may be missed, and all must be lined up right. Every member should realize that at all times, he is an I. W. W., but for the purpose of administration and to get job control, he should always transfer into the Industrial Union of the

job where he goes to work. We do not want to be patriotic to a Union as such—we want to be patriotic to the Working Class. Remember when you leave the harvest fields to go on Construction, or into Metal and Machinery, you should transfer from 400 to 573, or 300, as the case may be, and you are helping cinch the job for Industrial Unionism. Equally when you go from the weaving room or tailor shop into the printing plant, you transfer from 1000 to 1200. You have changed your Industrial Union, but you are still an I. W. W.

We have the historic mission of the working class to carry out, and Industrial Unionism is the instrument by which we expect to accomplish our task. We can only do this as we give all our energy to the work and co-operate to the fullest measure. If we are to build the new society, we must have the One Big Union actually functioning in the Industries, and not spelled out in scrawly letters on a piece of paper only. Would you be free? Then, get busy!


