NoHLA Advocacy: 2019 Year in Review

In 2019, NoHLA worked to expand coverage for immigrants, advocated for laws to increase consumer health insurance protections and affordability, and successfully sought improvements in reproductive health and language access. We've fought against harmful federal proposals through amicus curiae court briefs, commented on rules that would restrict access, provided trainings, and encouraged



supporters to take action at critical points. We also celebrated our 20th anniversary with colleagues, friends, and new NoHLA supporters.

Here are just some of the victories in which NoHLA played a significant role:

- Helped to shape the law, rules, and consumer notice that prohibit "surprise" out-of-network billing after a five-year effort.
- Ensured that protections of the Affordable Care Act were placed in state law, including those preserving the anti-discrimination rules.
- Advocated successfully for the Reproductive Health Access for All Act, extending the current family planning program to immigrants regardless of status with income up to 260% of the federal poverty level.
- Spurred the Insurance Commissioner to begin improving accessibility of information to limited English proficient Washingtonians.
- Served on workgroups to design a state standard health insurance plan and to improve access to behavioral health care.
- Contributed to an amicus curiae brief cited in a court decision blocking the harmful "public charge" rule while litigation continues.

As a voice for consumers, NoHLA also participated in drafting amicus curiae briefs in cases in the 9th Circuit Court of Appeals challenging the exclusion of hearing aids from insurance coverage, and opposing federal Title X rules prohibiting family planning clinics from providing abortion or discussing it as an option.
