Purpose of the proposal and its anticipated effects, including any changes in existing rules: The purpose of this proposal is to repeal Chapter 434-110 as these rules have been added to Chapter 434-112 in an effort to resolve conflicting rules and remove repetitive rules.

Reasons supporting proposal: Consolidating rules gives both customers and staff fewer opportunities to error in filing corporate and charitable organization documents. Having one chapter, rather than two, means finding what they need faster and with more accuracy. All of the subject matter of this chapter is now in Chapter 434-112.
