I am pleased to present the 2021 General Election Voters' Pamphlet. We offer this comprehensive guide as a reference to help you find information about the candidates and measures that appear on your ballot.

This general election you will have the opportunity to vote for local officials and measures that could have a significant impact on your community. Yet in order to make your voice heard, you must be registered to vote. Voter registration forms that are mailed or completed online must be received by Oct. 25, and we encourage you to check your registration information today at **VoteWA.gov**. After Oct. 25, you must visit your local elections office or voting center during regular business hours and until 8 p.m. on Election Day to register to vote or update your registration and receive a ballot.

Once you have completed your ballot, be sure to sign the return envelope. This is important, as election officials verify your signature matches the one on your voter registration file before they can count your ballot. Then, send your ballot via U.S. mail — no postage needed. Remember, all ballots must be postmarked by Nov. 2 in order to be counted. The U.S. Postal Service recommends that you mail a week before Election Day. You can also return your ballot using an official ballot drop box anywhere in the state. Drop boxes are open until 8 p.m. the day of the election. Check **VoteWA.gov** to locate a ballot drop box.

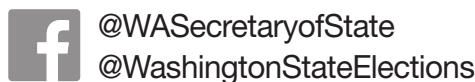
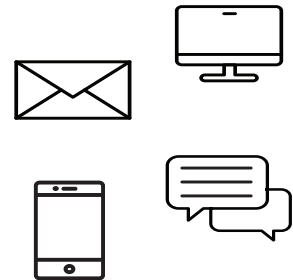

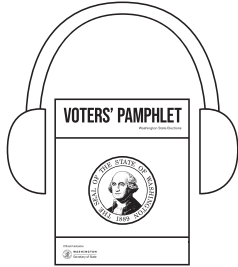

Qualifications

You must be at least 18 years old, a U.S. citizen, a resident of Washington, and not under Department of Corrections supervision for a Washington felony conviction.

If you're 16 or 17 years old, you can sign up as a Future Voter and be automatically registered to vote when you qualify.



How do I register to vote?

Online: Register at VoteWA.gov

By mail: Request a paper form be mailed to you or print your own at sos.wa.gov/elections

No internet access? Call 1 (800) 448-4881.

In person: Visit a county elections office (listed at the end of this pamphlet).

Registration deadlines



By mail or online: Your application must be received no later than October 25.

In person: Visit a local voting center no later than 8 p.m. on November 2.

Check your registration info at VoteWA.gov.

Moved? Update your voting address

Contact a county elections office to request a ballot at your new address.

By October 25: Have your application received by mail or updated online.

Or

By November 2: Visit a local voting center in person.



What if I'm not 18 yet?



If you are 16 or 17, become a Future Voter!

Future Voter

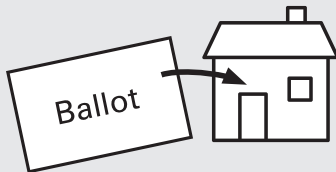
Sign up online at VoteWA.gov with your Washington state driver's license or ID. Or you can fill out a paper registration form using the last four digits of your Social Security number and mail it in. You'll be automatically registered to vote when you qualify.

Every January on Temperance and Good Citizenship Day, high school students 16 and older have the opportunity to complete a voter registration form in class.

How do I vote and return my ballot?

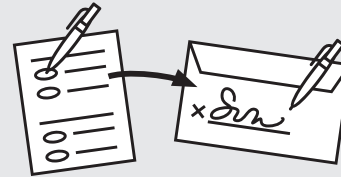

If you're registered to vote, there is no need to request a ballot. Your ballot will be mailed **October 15** to the address you provide in your voter registration. If you need a replacement ballot, contact a county elections office listed at the end of this pamphlet.



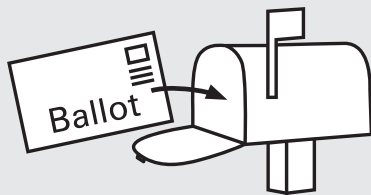

Vote your ballot and sign your return envelope. We need your signature to accept your ballot. You are not required to vote every race on your ballot. We encourage using this pamphlet to help you decide.



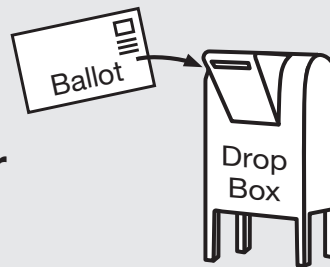

Return your ballot by mail, no stamp needed. If mailed, your ballot must be postmarked by **November 2**. Don't let a late postmark disqualify your ballot. The USPS recommends that you mail a week before Election Day.



Or, return your ballot to an official ballot drop box. Drop boxes are open until 8 p.m. on **November 2**. Find drop box locations at **VoteWA.gov**.

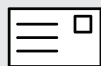

If you cannot personally return your ballot, let only people you trust deliver it for you.

Check the status of your ballot on **VoteWA.gov** to see if it has been received by your county elections office.



Election staff will contact you before your ballot is processed if:

- Your signature is missing
- Your signature doesn't match your voter registration record

View election results online

After 8 p.m. on election night, tallied results from each county are posted at **sos.wa.gov/elections**.

Results are updated as counties report and unofficial until certification.

When reviewing online or printed information, think about:

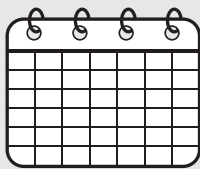
Who made this, and who is it for?

Was it a company, or an individual person? Who is the intended audience?



Why did they make it?

Think about the purpose. Is it to inform, entertain, or persuade?



When was this made?

Is the information relevant today?



What makes it believable?

Is there evidence from a reputable source or expert?

How might other people read this message?

Consider how someone with a different background might interpret it.



Ask the experts

Consult a fact-checking site or ask an official source. Get trusted info from your county auditor or elections office.



i Advisory votes are the result of Initiative 960, approved by voters in 2007. The Office of the Secretary of State publishes the Attorney General's advisory vote description according to RCW 29A.72.283.

You are advising the Legislature if you do or do not favor a tax increase passed during the recent legislative session.

Repeal — means you **don't favor** the tax increase.

Maintain — means you **favor** the tax increase.



**Advisory votes are non-binding.
The results will not change the law.**

The legislature imposed, without a vote of the people, a 7% tax on capital gains in excess of \$250,000, with exceptions, costing \$5,736,000,000 in its first ten years, for government spending.

This tax increase should be:

- Repealed

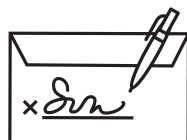

If I'm a crime survivor, can I vote safely?**Keep your voting address confidential**

If you are a survivor of domestic violence, sexual assault, trafficking, stalking, or an employee in criminal justice and target of felony harassment on the job, you may be able to enroll in the Address Confidentiality Program and register as a Protected Records Voter.

To become a Protected Records Voter:

- You must first meet with a Certified Advocate who can assist with threat assessment, safety planning, and the program application.
- The best time to enroll is when you move or are planning to move to a location that is unknown to the offender and undocumented in public record.

Odd-year elections are local elections. Local measures, local candidates, local issues. This one contains an especially local – and rare – issue: the opportunity to change the County’s charter. Some counties in Washington State, including San Juan County, have adopted “charters,” sort of like county constitutions. Charters allow counties to structure their governments differently from other Washington counties and/or create requirements for the operation of government beyond those required in the State constitution.

Like the State Constitution, a county’s charter can be amended only by a vote of the people. The most common way charter amendments are proposed is by a Charter Review Commission. A Charter Review Commission elected last year has proposed six charter amendments for the 2021 general election. You, the San Juan County voter, will decide if they become local law.

In addition to the Charter amendments and three statewide Advisory Votes, this ballot contains four other local ballot measures, all of which touch on the quality of life in San Juan County. SJI Fire & Rescue is proposing a levy to fund EMS services; SJI Hospital District is proposing a levy to provide long-term care; Orcas Island Park & Rec is seeking renewal of its regular tax levy; and Lopez Solid Waste is seeking approval of its annual property tax levy.

Not just those particular measures, but also who governs local jurisdictions within the county will be determined by this election. Commissioners of port, fire, park & rec, hospital, cemetery, school, sewer, and water districts, as well as Friday Harbor’s mayor and two of its Council members, are all on the ballot.

The operations, actions and decisions of these local jurisdictions affect your lives. This is your opportunity to influence them. Read carefully, consider thoughtfully, and vote. We’re counting on you.

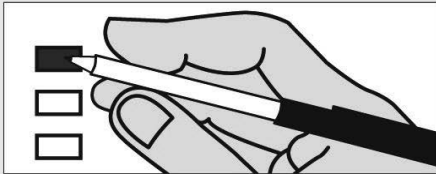
What is a Ballot “Measure”?

- Measures are anything on a ballot that is not a race between candidates. Measures include initiatives, referenda, Constitutional or Charter amendments, levies, district formations, etc.
- Initiatives are laws proposed (“initiated”) by citizens. State Initiatives may be sent to the Legislature for adoption (in which case they are called Initiatives to the Legislature, or ITLs), or may be sent directly to the ballot for a vote of the people. An ITL that is not adopted by the Legislature is automatically sent to the ballot for a vote of the people.
- Referenda “refer to the people,” for approval or rejection, laws passed by the Legislature. The legislation might have originated as a bill or as an Initiative to the Legislature.
- Constitutional amendments, in Washington, may be initiated only by the Legislature. Even though the initiative process is well known and often used in Washington, it cannot be used to amend the Constitution.
- Advisory Votes are a uniquely Washington measure which give voters the chance to vote on whether the Legislature should have passed a law they already passed. However, unlike referenda, advisory votes have no effect and do not change the law that has passed.

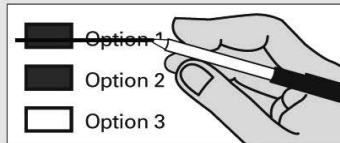

Explanatory Statement

This proposed amendment to the San Juan County Charter has been submitted by the Charter Review Commission.

The San Juan County Charter begins with a preamble concerning the benefits of a home rule charter. This proposition would repeal the existing preamble and replace it with three parts. The first part would begin the County Charter with an acknowledgment that we who live in San Juan County reside on the ancestral lands and waters of the Coast Salish people and that we honor inherent, aboriginal and treaty rights. The second part is a new preamble which would acknowledge the intent to secure rights granted by law for self-governance, equal protection and the recognition of a healthy community, a resilient economy and a vibrant natural world. The third part would set forth a declaration of community values on the topics of inclusive community, an economy that encourages sustainable growth and development, the natural world, and responsible stewardship including protection and preservation of public lands and undeveloped lands, and the strong enforcement of codes and regulations.

Generally, the introductory topics to a county charter are not legally binding and do not alter existing law. Under existing law, the County Council evaluates and reviews every ten years many of the topics in the Declaration of Community Values. This review is undertaken by the County Council as mandated by the Growth Management Act, a set of state laws that require the County to develop and periodically review the County's comprehensive plan, vision statement, development regulations and other rules and regulations. These existing laws provide a comprehensive regulation of uplands and shorelines, land use, private and public development, and preservation of open space. The existing laws also provide for administrative and legal action for code enforcement where the primary intent of all enforcement actions is to educate the public and to encourage the voluntary correction of violations.

This proposition will become part of the County Charter if it is approved by a majority of those voting. A fiscal note was not prepared for this proposition.

Statement For Proposition No. 1

This proposed Charter Introduction Amendment combines the addition of an Acknowledgement of the Coast Salish People, a replacement Preamble, and a newly created Declaration of Community Values.

The Acknowledgement recognizes the important history of the Coast Salish people in our county and region, reminding all who live here that these lands were the ancestral lands of the Coast Salish People. This Acknowledgement is offered in the spirit of community and abiding fellowship and was developed by county staff working with tribal representatives.

The new Preamble reminds us of: 1) why we adopted our Home Rule Charter (to maximize our right to govern ourselves locally); 2) the importance of equal protection under the law for everyone; and 3) our place as a part of the natural world around us.

The Declaration of Community Values gives credit to values we hold in common, including a safe and welcoming community, a resilient economy, and a flourishing ecosystem and sustainable environment. Such values are derived from the contributions of numerous activists and from our conversations with many members of the public. They serve as a guiding light for our county leadership in navigating our future. These values provide a yardstick with which to measure the success of the local government, and indeed, our collective community, in living up to our highest aspirations.

We ask that you read through this Introduction, recognize its worth, and join us in voting yes.

Statement Against Proposition No. 1

The purpose of the Charter Review Commission is to make recommendations to our County Council related to governance. The preamble is used as an introduction. Rather than simply altering the preamble, the CRC wishes to include an Acknowledgment and a Declaration of Community Values. Both of these are philosophies that not all voters would agree with, yet they are grouped together, forcing voters into an all or nothing vote.

This is concerning when the Acknowledgment uses language that potentially could lead to claims of appropriating land that we 'took' from the Coast Salish. Voting on an acknowledgement that says we reside on land belonging to them is opening land owners up to unforeseen problems. It is an admission that we unjustly occupy Coast Salish land. This threatens private property rights. The existing Treaty of Point Elliot recognizes the ancestral history of the Coast Salish in our area. It stands strong after 160 years.

The Charter Review Commission has no reason to 'Declare Community Values' outside of the County Council's framework. They can recommend the Council include these goals in a resolution. It does not need to be a part of this amendment. The only logic behind grouping agreeable language into an amendment like this would be to pass an un-agreeable portion of it. This should raise red flags regarding the intentions of the CRC.

Vote 'no' to keep the existing preamble in effect and save good hearted islanders from unintentionally voting away their property rights.

Statement for Proposition No. 2

Concerning Term Limits for Council Members

The San Juan County Charter Sections 5.20 shall be amended to read as follow:

Section 5.20 – Qualifications; Residency for County Council Members

Each county officer holding an elective office shall be, at the time of appointment or filing a declaration of candidacy for election, at the time of election, and at all times while holding office, a citizen of the United States and a resident and registered voter of San Juan County. In addition, County Council members must reside in the district to which he or she seeks or holds office at the time of appointment or filing a declaration of candidacy for election and at all times while holding office. No person shall be eligible to be elected or appointed to more than three consecutive full terms for the position of County Council Member, regardless of which district the Council Member resides, provided that this term limit eligibility requirement shall expire three years after the end of the third term for purposes of filing for office but shall remain in effect for an additional one year for purposes of appointment. No County Council residency district boundary change shall disqualify the County Council member from holding office for the remainder of the term of office.

This proposed amendment to the San Juan County Charter has been submitted by the Charter Review Commission.

Under existing law, the San Juan County Council has established a department of Environmental Stewardship which is responsible for climate change, stormwater, solid waste utility, marine programs, and other topics involving environmental protection. A separate department, established pursuant to the Growth Management Act, handles land and development and State Environmental Policy Act topics. Existing law also provides that hiring and supervision of department heads is carried out by the County Manager on behalf of the County Council.

This proposition adds a new commission to the County with nine members, all county residents, except for the Coast Salish Tribal member, appointed by the San Juan County Council. The duty of the commission would be to provide oversight and support for the Environmental Stewardship Department and to participate in the hiring of the director of that department. The commission members would meet with the director of the Environmental Stewardship department monthly, write and update a Climate and Environment Action Plan and release annual updates of the Action Plan including progress or lack of progress by county departments and elected officials. The commission also would have authority to recommend executive and legislative actions be taken with respect to Resolution 20-2020, a Resolution of the County Council to Respond and Adapt to Climate Change, and the activities of the Environmental Stewardship Department to ensure conformity with laws and regulations concerning climate change and environmental protection.

A fiscal note was not prepared for this proposition, but the proposition provides that "the commission shall be funded with an appropriate budget and given support from County Staff."

This Proposition will become part of the County Charter if it is approved by a majority of those voting.

The San Juan County Charter Article 4 – Administrative Departments shall be amended to read as follows:

Section 4.60 – Climate and Environment Commission

1) The people of San Juan County establish the San Juan County Climate and Environment Commission to advance climate action, the protection of our environment, and the implementation of San Juan County Resolution 20-2020 by providing oversight and support to San Juan County’s department responsible for environmental stewardship and reduce and mitigate the impacts of climate change. The San Juan County Resolution to Respond and Adapt to Climate Change, 20-2020, charges the County with the responsibility of leading the community in reducing its carbon footprint and adapting to changing ecological and economic conditions. The resolution targeted building management, transportation and fleet/equipment, green purchasing and waste management, environmental restoration and health, and green energy production and independence, along with the encouragement of individual practices to promote sustainability. The Climate and Environment Commission will provide a mechanism for citizen engagement and transparency in the County’s efforts to address climate change and protect our natural environment.

2) The Climate and Environment Commission is hereby established and includes nine members who are not county employees. The County Council shall appoint the membership of the Commission. The Commission will select a chair from its membership to manage operations and communications and the Commission shall meet on a monthly basis at the direction of the chair. All members of the Commission shall be residents of San Juan County with the exception of the Coast Salish member. All members shall be registered voters, with the exception of the Coast Salish member and the youth member if that person is under the age of eighteen (18). Members shall serve four-year staggered terms. The Commission established by this Charter shall supersede any previous commission/s created to advance climate action, the protection of our environment, and the implementation of San Juan County Resolution 20-2020 and/or advise the department with these responsibilities.

3) One person shall be appointed from three of the four following entities:

- The Marine Resources Committee
- The Salmon Recovery Committee
- The Solid Waste Advisory Committee
- The Agricultural Resources Committee

4) Additional members of the Commission shall include:

- A representative from an environmental nonprofit organization based in San Juan County
- A professional contractor with experience in residential construction
- A youth (age 16-25 inclusive) who is active in climate change and environmental protection activities
- An enrolled member of a Coast Salish nation or tribe who is not necessarily a resident of San Juan County
- Two members serving at-large

5) The Commission shall have oversight over the department in San Juan County responsible for environmental stewardship and reducing and mitigating the impacts of climate change. Oversight is defined as the duties and responsibilities described herein. The Commission will review the activities of said department and recommend executive or legislative action to support the implementation of San Juan County Resolution 20/2020 20-2020, and ensure conformity with Charter, county, state, and federal laws and regulations concerning climate change and environmental protection. The Commission shall conduct all searches and vet future candidates for the director position and make a recommendation to the County Council. The Commission shall be funded with an appropriate budget and shall be given support from County staff, including the the staff of said department to:

- Develop and update annually a Climate and Environment Action Plan
- Conduct monthly public meetings with the director in an oversight role for the department
- Release annual updates to the public on the implementation of the Action Plan, including progress, or lack of progress resulting from the activities of County departments and elected officials

Proposition 4 would remove the requirement that when an initiative requires the expenditure of additional funds for an existing or new activity it will provide specifically for the additional source of revenue to pay for such activity. Proposition 4 also reduces the number of signatures to qualify a local initiative or referendum for the ballot from 15 percent to 8 percent of the votes cast in the County in the last gubernatorial election. This proposition will also add a new provision requiring paid signature gatherers on San Juan County initiatives and referendums to display that they are a “paid signature gatherer.”

This Proposition will become part of the County Charter if it is approved by a majority of those voting. A fiscal note was not prepared for this proposition.

Argument For Proposition No. 4

The most empowering aspect in the charter is the right of initiative and referendum. Current requirements to place issues on the ballot are excessive and act as deterrents to citizen involvement. The bar is prohibitively high for petitioners to get an issue on the ballot. This amendment strengthens the initiative process and encourages a grassroots political culture that welcomes community engagement.

Our current signature requirement of 15% is the highest of all WA home rule charter counties. (Others range from 7 to 10%.) This amendment will align signature requirements with Washington State's 8%. This percentage gives us the benefit of community members bringing forward critical issues with a solid level of interest to warrant getting onto the ballot.

Money can have undue influence on initiatives. Outside signature gatherers can falsely tip the scale of what was designed to be a local democratic process. Requiring paid signature gatherers to be clearly identified, voters can distinguish who a paid signature gatherer is and help shape the conversation.

Our power to self govern is diminished by the current misplaced requirement to identify a funding source within the language of the initiative. Financial responsibility is paramount but rests with the county government. The requirement that initiatives provide for sources of revenue needed to implement the initiative presents a huge stumbling block for citizens who don't have access to complex interwoven grants, federal funding, and budget information.

Vote for this amendment to reinforce community participation and self governance in San Juan County.

Argument Against Proposition No. 4

Proposition 4 is irresponsible and dangerous because it hides the costs of initiatives from the voters.

This proposed amendment rolls up three topics regarding initiatives by combining two relatively innocuous changes (reducing the number of required petition signatures and identifying paid signature gatherers) with a third that disconnects the initiative proponents from any obligation to disclose costs or source of funds, thereby blinding the voters to the financial consequences of a successful initiative.

The proponents of this proposal claim that they should be relieved of the burden of a cost analysis—a burden that applies to every other governmental cost in advance of expenditure. This proposition omits this absolutely necessary step in responsible governance.

Unfettered initiatives are detrimental to responsible governance. Budgets are zero-sum games: a “never mind the cost, we want it” initiative destabilizes county finances, can result in the reallocation of funds for things that matter more, and in extreme cases impair our county's credit rating (due to exposure to uncontrolled initiative-induced expenses) thereby increasing county borrowing costs.

The innocuous reduction in the number of required signatures only makes such misadventures more likely.

Our County Charter wisely gives us the right to petition to change our local laws but balances that right with the obligation to disclose costs and sources. This is the same responsibility our County Council and Auditor have in developing a budget. Initiative proponents should be required to exercise the same level of responsibility for costs to be imposed upon the taxpayers.

The San Juan County Charter Sections 6.21, 6.22, and 6.41 shall be amended to read as follows:

Section 6.21 – Initiative – Limitations

- (1) No initiative shall contain more than one (1) issue.
- (2) No initiative proposal requiring the expenditure of additional funds for an existing activity or of any funds for a new activity or purpose shall be filed unless provisions are specifically made therein for new or additional sources of revenue which may thereby be required.
- (3) (2) Redistricting of the County Council Residency districts shall not be subject to the initiative process.

Section 6.22 – Initiative – Procedures

- 1) Any legal voter or organization of legal voters of San Juan County may file an initiative proposal with the County Auditor, who within five (5) working days shall confer with the petitioner to review the proposal as to form and style. The County Auditor shall register the initiative by giving the proposed initiative a number, which shall thereafter be the identifying number for the measure.
- 2) The County Auditor shall then transmit a copy of the proposal to the Prosecuting Attorney, who within ten (10) days after receipt thereof, in consultation with the petitioner shall formulate a concise statement, posed as a positive question, not to exceed seventy-five (75) words, which shall express and give a true and impartial statement of the purpose of the measure. Such concise statement will be the ballot title.
- 3) The petitioner then has one-hundred-twenty (120) days to collect the signatures of the registered voters in the County equal in number to at least fifteen (15) eight (8) percent of the votes cast in the County in the last gubernatorial election. Each petition shall contain the full text of the proposed measure, ordinance or amendment to an ordinance and the ballot title.
- 4) The County Auditor shall verify the sufficiency of the signatures on the petition and, if it is validated, submit the proposal to the people at the next general election that is at least one hundred and twenty (120) days after the registering of the petition.

5) The County Council may choose to enact the proposal without change or amendment. If the County Council does not adopt the proposed measure and adopts a substitute measure concerning the same subject matter, the substitute proposal shall be placed on the same ballot with the initiative proposal.

6) The voters shall be given the choice of accepting either or rejecting both. The voters shall then be given the choice of accepting one and rejecting the other. If a majority of those voting on the first issue is for accepting either, then the measure receiving the majority of the votes cast on the second issue shall be deemed approved. If a majority of those voting on the first issue is for rejecting both, then neither measure shall be approved regardless of the vote on the second issue.

Section 6.41 – Referendum – Procedures

- 1) Any legal voter or organization of legal voters of San Juan County may file a referendum proposal, against any enacted ordinance or portion thereof, with the County Auditor. The proposal shall be presented to the County Auditor within forty-five (45) days after the ordinance is passed by the County Council.
- 2) Within five (5) working days, the County Auditor shall confer with the petitioner to review the proposal as to form and style. The County Auditor shall register the referendum by giving the referendum proposal a number, which shall thereafter be the identifying number for the measure.
- 3) The County Auditor shall then transmit a copy of the proposal to the Prosecuting Attorney, who within ten (10) days after receipt thereof, shall formulate a concise statement, posed as a question, not to exceed seventy-five (75) words, which shall express and give a true and impartial statement of the measure being referred. Such concise statement will be the ballot title.
- 4) The petitioner then has one hundred and twenty (120) days to collect the signatures of registered voters of the County equal in number to at least fifteen (15) eight (8) percent of the number of votes cast in the County in the last gubernatorial election. Each petition shall contain the full text of the measure being referred and the ballot title.

5) The County Auditor shall verify the sufficiency of the signatures on the petition and if validated, submit the measure to the people at the next general election that is at least one hundred and twenty (120) days after the registering of the petitions.

Section 6.80 – Paid Signature Gathering

Paid signature gatherers collecting petition signatures for San Juan County initiatives and referendums must visibly display a statement showing they are paid, to each person from whom they receive a signature. This may be fulfilled by posting a legible and conspicuous sign, or placard, or wearing a badge stating, “Paid Signature Gatherer.”

This proposed amendment to the San Juan County Charter has been submitted by the Charter Review Commission.

Under existing law, the County and all employees and officials in the performance of their duties are required to comply with state and federal laws with respect to the nondiscrimination provisions and protection of certain classes, subject to limited exceptions.

This proposition would add a new section to the San Juan County Charter which will list the classes which are protected from discrimination. That list includes several classifications that are the same as state and federal law such as sex, race, color, national origin, religious affiliation, age over 40, pregnancy, sexual orientation, and status as a veteran who was honorably discharged. In addition, this proposition adds the protected classes of body type, status as care provider for dependents, marital status, gender identity or expression, age under 40 except minimum age, and discharge from the military due to sexual orientation or gender identity or expression. No exceptions are stated.

Under existing law, contractors with the County are subject to applicable state and federal laws. This measure requires contracts for professional services to provide that the County will adhere to the grounds for nondiscrimination in the County Charter as described above. Further, in contracts with vendors to provide goods, the County will adhere to the nondiscrimination requirement of the County Charter to the maximum extent possible. An exception is made for contracts and grant agreements with public entities, which will abide applicable state and federal laws.

This Proposition will become part of the County Charter if it is approved by a majority of those voting. A fiscal note was not prepared for this proposition.

Argument For Proposition No. 5

The need to enact Proposition 5 is overdue. The guiding structural framework of our Home Rule Charter has been established but a commitment to critical principles and values now requires our focus. Among these, our San Juan County Home Rule Charter makes no mention of justice, diversity, equity, or inclusion. Our county is one of two among the State’s seven charter counties without a localized foundation to guard against marginalization and disenfranchisement of members of our community.

As the national spotlight on discrimination, prejudice, and bigotry has intensified, many residents can cite local examples of racism and intolerance. In the conduct of its business, our local government must ensure that such injustice has no place in the treatment of our county’s residents, employees, and visitors.

We have an opportunity to achieve this by including an essential safeguard in our County’s Charter. Voting in favor of Proposition 5 reinforces our county’s responsibility to provide a safe and inclusive community for all, and expands protected classes identified in State and Federal law to further eliminate barriers and broaden diversity.

Proposition 5 will support county leadership in upholding our shared values of respect and equity. It is the key to growth” -- Rev. Jesse Jackson. The time for Proposition 5 is now.

Concerning Nondiscrimination in the Exercise of County Powers and Performance of its Duties

A NEW SECTION shall be added to Article 10 – General Provisions on Non-Discrimination in the Exercise of County Powers and Performance of its Duties to read as follows:

1) In the exercise of its powers and in the performance of its duties, the county shall ensure that no person is discriminated against in hiring and conditions of employment, compensation, or termination of county officers or employees, or in the treatment of residents and visitors in the provision of government services on account of sex, race, color, national origin, religious affiliation, disability, sexual orientation, gender identity or expression, marital status, pregnancy, body type, age except by minimum age and retirement provisions, status as a care provider for dependents, military status, or status as a veteran who was honorably discharged or who was discharged solely as a result of sexual orientation, gender identity, or expression. The County Council, department heads, and elected officials shall take all steps necessary to accomplish the purposes of this section consistent with the county, state and federal constitutions, laws, and regulations.

2) In the contracting of professional services with any person, firm, organization, corporation, or other non-governmental entity, the County shall ensure adherence to the grounds listed in clause (1). For the purchase of goods, and those services and goods acquired through cooperative purchasing, the County should direct vendors to adhere to clause (1) to the maximum extent possible. This restriction does not apply to contracts and grant agreements with public entities.

In 2020, the San Juan County Council adopted Resolution No. 31-2020 which concerns a safe and inclusive community. Under existing law, the County Council may form a commission to advise on the implementation of Resolution No. 31-2020 and to appoint members accordingly.

This proposition would add a new section to the San Juan County Charter to establish a new commission of 11 persons to provide advice and support to all elected and appointed officials, except the superior court and district court judges, and is intended to be a mechanism for citizen engagement and to advance the core values expressed in Resolution 31-2020 and other county, state and federal laws regarding nondiscrimination.

The commission will be appointed by the County Council and be composed of 11 members from residents of the county with staggered, four-year terms with representation of women, minorities, diverse communities and one member of a Coast Salish tribe who may not be a county resident.

This Proposition will become part of the County Charter if it is approved by a majority of those voting. A fiscal note was not prepared for this proposition.

Argument For Proposition No. 6

In recent years, social movements focused on gender, diversity and inclusion have generated large protests, marches, and awareness-campaigns. Progress through #MeToo, Black Lives Matter (BLM) and other movements have heightened community understanding of the need to address gender, racial, ethnic, and religious discrimination across the United States, and in this County.

In the wake of the BLM movement last year, the County Council unanimously passed Resolution No. 31/2020 Affirming a Commitment to a Safe and Inclusive Community. Few are aware of this important resolution as it is not law.

Unlike the other six Charter Counties in the State, the San Juan County Charter is silent on values such as justice, diversity, equity, and inclusion. We are a County of compassionate people who are concerned about the well-being of everyone. Yet there are no mechanisms through which the local population can engage with the County government on these issues and ensure accountability and transparency in the performance of elected and appointed officials to uphold these values for the benefit of all residents.

Proposition No. 6 establishes a Justice, Equity, and Inclusion Commission and brings residents into meaningful dialogue with the government to ensure non-discrimination, equity and inclusion can be experienced by everyone.

A vote for this proposition will demonstrate how our County can be a model and lead by example when it comes to justice, equity, diversity, and inclusion. This proposition will allow the voters of the County to be the change we want to see.

Argument Against Proposition No. 6

Just like our island communities, our county government adheres to a set of accepted values which include justice, equity and inclusion. Their commitment to a more equitable island environment has been commendable. County Council passed Resolution No. 31-2020 'Affirming Commitment to a Safe and Inclusive Community' to guide them in situations of injustice. We can continue to trust our elected officials to uphold these values. Creating a new commission of up to 11(!) members to ensure this resolution is followed is excessive and unnecessary. The Charter Review Committee is overstepping its role by micromanaging our county council.

The plans for this new commission are not clear, specific or measurable. Are they to accomplish anything or simply exist? Are members compensated? If so, from what budget? Appointing an unelected commission with undefined powers and unlimited access to government is risky, leaving many unanswered questions. This could've been a recommendation to County Council to utilize in their decision-making processes. It did not need to be a charter amendment.

A solution to achieve the goal of a more equitable county government would be to fill vacant seats of existing commissions with women, minorities, Coast Salish and other diverse members. There are plenty of opportunities to do so. Our county would be stronger for it.

The Charter Review Commission has proposed a new commission that will undermine the County's pre-existing commitment to equity, justice and inclusion. Vote "no" to stop the CRC from inflating our government with more redundancy and unknowns.

Complete Text:

A NEW SECTION shall be added to Article 10 –

General Provisions on the subject of the Justice, Equity and Inclusion Commission to read as follows:

Section 10.60 – Justice, Equity and Inclusion Commission

There is hereby established a Justice, Equity, and Inclusion Commission which shall provide advice and support to, and collaborate with the county government, elected and appointed officials and county employees, with the exception of the county’s Superior and District Court judges, on matters concerning justice, equity, diversity and inclusion. The Justice, Equity and Inclusion Commission will provide a mechanism for citizen engagement and transparency, and may recommend executive and legislative actions to advance the core values of the San Juan County Council Resolution No. 31-2020 entitled “Affirming Commitment to a Safe and Inclusive Community,” and other county ordinances and resolutions, and state and federal laws and regulations regarding non-discrimination.

The Commission shall have a maximum of 11 members and include representation of women, minority, and diverse communities in the county, and at least one member of a Coast Salish tribe. All members of the Commission shall be residents of the county, with the exception of the Coast Salish member(s), with at least one representative from each County Council district. All members shall be registered voters, except for a youth member if that person is under the age of eighteen (18), and shall serve staggered four-year terms. The Commission shall have representation from each branch of the county government (executive, legislative and judicial). The Chair of the Commission, or a designee from the Commission, shall be a resident who is not a county employee and serve on the county’s Law and Justice Council. The County Council shall appoint the membership of the Commission.

The Board of San Juan Island Fire District No. 3 has passed a resolution requesting an election to authorize a property tax levy in an amount not to exceed fifty cents per \$1,000.00 of assessed valuation, each year for six (6) successive years, commencing in 2023. The hospital district, which currently employs several paramedics providing advanced life support (ALS) services to San Juan Island, is transferring those employees over to the fire district. This levy would provide sufficient EMS revenue to fund the fire district's brand new paramedic program, including the salaries, equipment and medical supplies of firefighter paramedics, and the cost to deliver critical ALS care and emergency ambulance transport service.

The vote on the levy is required by RCW 84.52.069. This tax revenue may only be used for the provision of emergency medical services, including related personnel costs, training for such personnel, and related equipment, supplies, vehicles and facilities needed to provide such services to all of San Juan Island and near islands within the existing district.

If approved, the EMS tax on a \$500,000 assessed value property would be \$250 each year or approximately \$20.83 per month. Since this is the first ever EMS levy for District No. 3, it requires 60% approval of the electorate. However, the hospital district has agreed to no longer have an EMS levy, so this EMS levy will replace that.

Argument For Proposition No. 1

This proposed levy will fund the consolidation of emergency medical, fire and rescue services into a single emergency service agency.

A single emergency services agency is the national model, proven to be the best way to provide efficient, high quality and cost-effective emergency services. The ability to provide these critical services has been challenged by new population growth throughout our islands. An appointed citizens advisory group strongly recommended consolidation, and this has been supported by the elected boards of Hospital District #1 and Fire District #3.

The boards have worked together to consolidate emergency services and enable San Juan Island Fire and Rescue (SJIF&R) to continue providing advanced life support (paramedic) and ambulance transport services. The people and equipment of San Juan Island EMS will be combined with the people and equipment of SJIF&R, allowing a single agency to be responsible for the operation of medical, fire, rescue and marine rescue capabilities.

We are asking you to support, for six years beginning in 2023, a general tax on taxable property in the district in an amount up to \$0.50 (cents) per \$1000 of true and fair assessed valuation to the Fire District. By consolidating, the total cost being paid through property tax levies for all emergency services will only be approximately \$0.94 (cents) per \$1000.

Join us in voting yes on this important public safety levy needed to maintain and improve our islands' emergency services for our families and our neighbors.

San Juan County Public Hospital District No. 1 (the "District") seeks voter approval to authorize an increase of its regular property tax levy to \$0.70 per \$1,000 of assessed valuation in 2021 (with collection beginning in 2022), which is an increase of approximately \$0.36 per \$1,000 of assessed valuation. This levy is the primary funding source for medical services provided by the District. Voter approval of Proposition 1 will help maintain and increase the level of services currently provided by the District, including plans to provide long-term medical care.

Argument For Proposition No. 1

Caring for the aging population in our community is in crisis. Our only convalescent center closed in 2017. There are no adult family homes currently functioning on the island and a limited supply of in-home care givers. Right now, islanders are limited to a choice of expensive private care (in home or at The Village) or a stressful move to the mainland.

Public Hospital District #1 is responsible for the health care needs on San Juan Island. It proposes to purchase Village at the Harbor, add Medicaid beds, and stabilize the Village workforce through improved wages and benefits for its employees. As a community owned enterprise, it could accept public and private funding to help expand services and provide more affordable care options.

With the Village as a foundation, the District envisions a center for training home care aides and a home care provider system for islanders needing more assistance. The home care system could provide support services including light housekeeping, assistance with meals, home safety checks, referrals to other resources, monitoring medication compliance, and similar services. It will allow islanders to age in place by staying in their homes as long as is practicable.

It will be significantly cheaper to purchase the Village, an existing structure, than to start from scratch. Funds generated by this levy would allow the District to build viable, community-owned, long term care resources that will benefit San Juan Islanders; this is a win-win for us all.

The Orcas Island Park and Recreation District (“Orcas Rec”) was formed in 2009 and two years later, in 2011, the voters in the district approved its first regular property tax levy. A Park and Recreation District must seek voter approval of its regular levy every six years. When the 2011 levy expired it was renewed with a levy at the rate of fifteen cents per \$1,000 assessed value. This proposal will cancel the levy for the year 2022 and replace it with a property tax levy at the rate of fifteen cents per \$1,000 assessed valuation for a period of six years beginning in 2022 and ending in 2027.

The levy would generate approximately \$450,000 in 2022. Future increases are subject to the limit factor in RCW Chapter 84.55. This amount is well below the statutory limit of sixty cents per \$1000 of assessed valuation.

The district funds its programs, activities, services, staffing, and property improvements with a combination of money from fees and tax revenue. The purposes for which the tax revenue will be spent are described in RCW 36.69.130 and include facilities, improvements to facilities, programs, services, and activities involving park and recreation.

The executive director of the district estimates that each year approximately 120 programs are offered that serve about 1900 adults and children. The district owns and manages Buck Park, and the revenue is expected to be used to operate, staff, provide programming and maintain and improve facilities there, including but not limited to, fields, pickleball and tennis courts, fences, irrigation, skatepark, playscape, parking lot and other facilities as approved by the Board.

To the extent allowed by law, a portion of the funds may be placed into a reserve account dedicated to planned replacement of infrastructure, courts and facilities when they reach the end of their useful life.

This measure requires approval by 60 percent or more of those voting at the election.

Argument For Proposition No. 1

Voting YES for the Orcas Island Park and Recreation District (OIPRD) Levy will continue to fund programs and maintain Buck Park, both of which add to the quality of life on Orcas Island. In 2016, voters authorized a renewal levy in the amount of \$0.15. As the current levy expires in 2022, OIPRD is asking to renew the levy at fifteen cents per \$1,000 assessed valuation for the next six years.

Buck Park land was a gift to Orcas Island from the Buck family. State money developed the park. Caring for it properly is our legacy to Orcas Island and future generations.

Vote YES so that OIPRD can continue to staff, improve, maintain and repair Buck Park, including the dog park, skatepark, pickleball courts, tennis courts, playground, high school baseball and softball fields, Little League field, soccer fields, water fountains and portable toilets.

Argument Against Proposition No. 1

The Committee Against Recreational Petrification (CARP) respectfully requests that Orcas voters reject the current levy. While well-intended, the levy is so limited that it hardly scratches the surface of viable recreational opportunities on this, our lovely isle.

The meager 15-cent per \$1000 levy might fund a few new signs, and provide for the care and feeding of parking-lot potholes, but we've got to think larger, perhaps—more inclusively, certainly.

Most Park and Recreation programs are targeted at residents. Perhaps some programming aimed at tourists would be feasible? Courses such as “How to Bicycle Single-File” and “Prune Alley Jaywalking 101” might fill up quickly in-season.

CARP recommends two long-term goals:

1. Development of a lung-shaped rail line around the island, with stops attended by locals serving ice cream, wool, oysters, firewood, orca-shaped-knick-knacks, local grass-fed llama steaks, artwork, etc.
2. Development of a more inclusive activity site to mitigate the barking and yelping coming from the dog park, namely in the form of an ATV track so that local gear heads have a public opportunity to shred mounds with their knobbies.

CARP advises island residents to take a forward-thinking perspective--one that might expand island recreational opportunities, rather than simply maintain them.

Indeed—we don't just need a few new signs to existing attractions: we need signs that direct us to the Cascade Falls kayak training watercourse, the lead-free blindfold-only skeet range, and the island-vehicle demolition derby track! Which are all within our grasp. Vote!

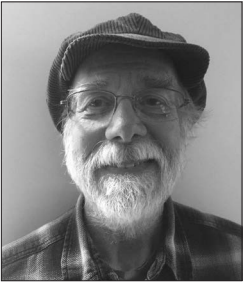

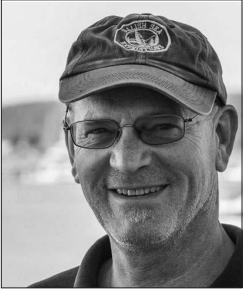

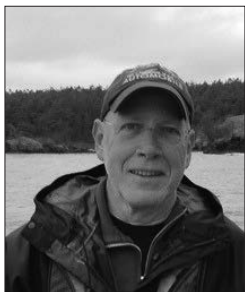

Each year, the Governing Board of the Lopez Solid Waste Disposal District has proposed a balanced budget that includes revenue from tipping fees based upon weight or volume, and tax revenue to be paid for with a one-year property tax levy. For the year 2022, the amount of the tax revenue that is budgeted is \$105,000, which is the same amount as in the year 2021.

The governing board has adopted Resolution No. 20-2021 calling for an election to approve the one-year property tax measure to generate \$105,000. If adopted, the property tax rate for the Solid Waste District would be an amount of approximately \$0.081201 per \$1,000 of assessed value for taxes imposed for the year 2022. This amount is a reduction of the levy rate charged in the current year.

The Lopez Solid Waste Disposal District must use the revenue raised for district operations and capital expenses.

A “yes” vote is a vote to approve the proposal; a “no” vote is a vote against the proposal. A sixty percent majority is needed to pass this measure.

Argument For Proposition No. 1

It's that time of year again when the Lopez Solid Waste Disposal District must put its levy on the ballot as required annually by state law. Our award-winning local facility handled over 295 tons of recyclable materials last year. Local drivers hauled off 760 tons of garbage on our District roll-off truck, a 7% increase over the previous year, and removed 137 tons of glass from the waste stream. Skagit's mainland garbage fees on LSWDD have increased 20%. LSWDD can no longer recycle paper on the mainland free of charge. Both San Juan and Orcas charge for recycling but LSWDD continues to opt for free recycling, including paper and glass. Additionally LSWDD created the Remakery so that more of Lopez's cast-offs can be made into useable products and not go into the garbage. Take It or Leave It is still free for shopping and dropping. Garbage fees alone cannot pay for our unique and innovative system.

This year's levy is again at \$.08 cents per \$1,000 value of property. That is approximately \$20 a year for a \$250,000 property, a great value for the yearlong services. Vote for Lopez Proposition No. 1. Keep our Lopez Dump and Take It Or Leave It operating under local control and managed according to Lopez values.

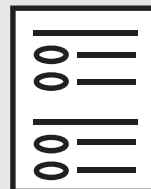

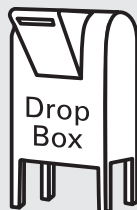

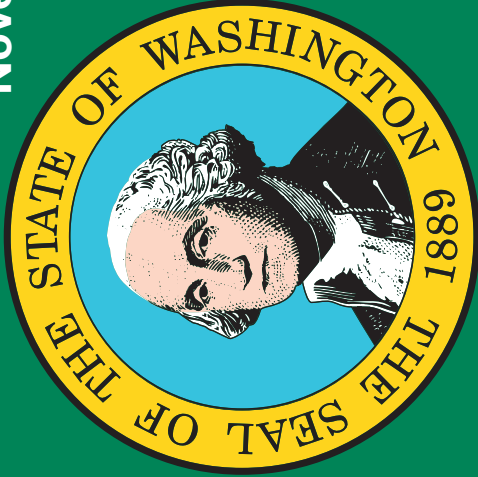
