I am pleased to present the 2021 General Election Voters’ Pamphlet. We offer this comprehensive guide as a reference to help you find information about the candidates and measures that appear on your ballot.

This general election you will have the opportunity to vote for local officials and measures that could have a significant impact on your community. Yet in order to make your voice heard, you must be registered to vote. Voter registration forms that are mailed or completed online must be received by Oct. 25, and we encourage you to check your registration information today at **VoteWA.gov**. After Oct. 25, you must visit your local elections office or voting center during regular business hours and until 8 p.m. on Election Day to register to vote or update your registration and receive a ballot.

Once you have completed your ballot, be sure to sign the return envelope. This is important, as election officials verify your signature matches the one on your voter registration file before they can count your ballot. Then, send your ballot via U.S. mail — no postage needed. Remember, all ballots must be postmarked by Nov. 2 in order to be counted. The U.S. Postal Service recommends that you mail a week before Election Day. You can also return your ballot using an official ballot drop box anywhere in the state. Drop boxes are open until 8 p.m. the day of the election. Check **VoteWA.gov** to locate a ballot drop box.

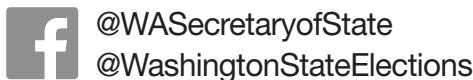
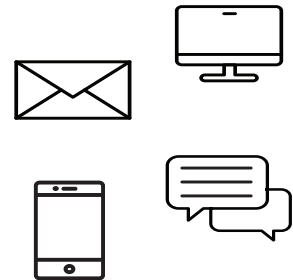

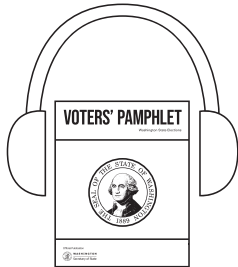

Qualifications

You must be at least 18 years old, a U.S. citizen, a resident of Washington, and not under Department of Corrections supervision for a Washington felony conviction.

If you're 16 or 17 years old, you can sign up as a Future Voter and be automatically registered to vote when you qualify.



How do I register to vote?

Online: Register at VoteWA.gov

By mail: Request a paper form be mailed to you or print your own at sos.wa.gov/elections

No internet access? Call 1 (800) 448-4881.

In person: Visit a county elections office (listed at the end of this pamphlet).

Registration deadlines



By mail or online: Your application must be received no later than October 25.

In person: Visit a local voting center no later than 8 p.m. on November 2.

Check your registration info at VoteWA.gov.

Moved? Update your voting address

Contact a county elections office to request a ballot at your new address.

By October 25: Have your application received by mail or updated online.

Or

By November 2: Visit a local voting center in person.

If you are 16 or 17, become a Future Voter!

Future Voter

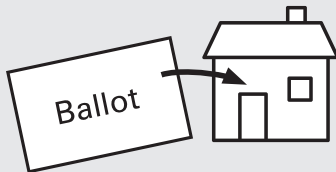
Sign up online at VoteWA.gov with your Washington state driver's license or ID. Or you can fill out a paper registration form using the last four digits of your Social Security number and mail it in. You'll be automatically registered to vote when you qualify.

Every January on Temperance and Good Citizenship Day, high school students 16 and older have the opportunity to complete a voter registration form in class.

How do I vote and return my ballot?

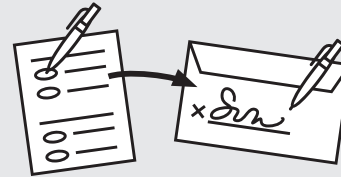

If you're registered to vote, there is no need to request a ballot. Your ballot will be mailed **October 15** to the address you provide in your voter registration. If you need a replacement ballot, contact a county elections office listed at the end of this pamphlet.



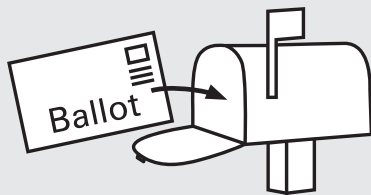

Vote your ballot and sign your return envelope. We need your signature to accept your ballot. You are not required to vote every race on your ballot. We encourage using this pamphlet to help you decide.



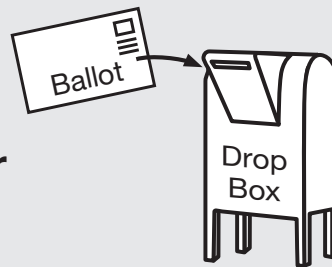

Return your ballot by mail, no stamp needed. If mailed, your ballot must be postmarked by **November 2**. Don't let a late postmark disqualify your ballot. The USPS recommends that you mail a week before Election Day.



Or, return your ballot to an official ballot drop box. Drop boxes are open until 8 p.m. on **November 2**. Find drop box locations at **VoteWA.gov**.

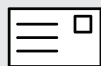

If you cannot personally return your ballot, let only people you trust deliver it for you.

Check the status of your ballot on **VoteWA.gov** to see if it has been received by your county elections office.



Election staff will contact you before your ballot is processed if:

- Your signature is missing
- Your signature doesn't match your voter registration record

View election results online

After 8 p.m. on election night, tallied results from each county are posted at **sos.wa.gov/elections**.

Results are updated as counties report and unofficial until certification.

When reviewing online or printed information, think about:

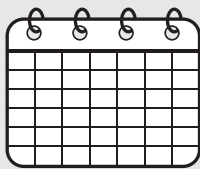
Who made this, and who is it for?

Was it a company, or an individual person? Who is the intended audience?



Why did they make it?

Think about the purpose. Is it to inform, entertain, or persuade?



When was this made?

Is the information relevant today?



What makes it believable?

Is there evidence from a reputable source or expert?

How might other people read this message?

Consider how someone with a different background might interpret it.



Ask the experts

Consult a fact-checking site or ask an official source. Get trusted info from your county auditor or elections office.



i Advisory votes are the result of Initiative 960, approved by voters in 2007. The Office of the Secretary of State publishes the Attorney General's advisory vote description according to RCW 29A.72.283.

You are advising the Legislature if you do or do not favor a tax increase passed during the recent legislative session.

Repeal — means you **don't favor** the tax increase.

Maintain — means you **favor** the tax increase.



**Advisory votes are non-binding.
The results will not change the law.**

The legislature imposed, without a vote of the people, a 7% tax on capital gains in excess of \$250,000, with exceptions, costing \$5,736,000,000 in its first ten years, for government spending.

This tax increase should be:

- Repealed

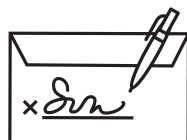

If you are a survivor of domestic violence, sexual assault, trafficking, stalking, or an employee in criminal justice and target of felony harassment on the job, you may be able to enroll in the Address Confidentiality Program and register as a Protected Records Voter.

To become a Protected Records Voter:

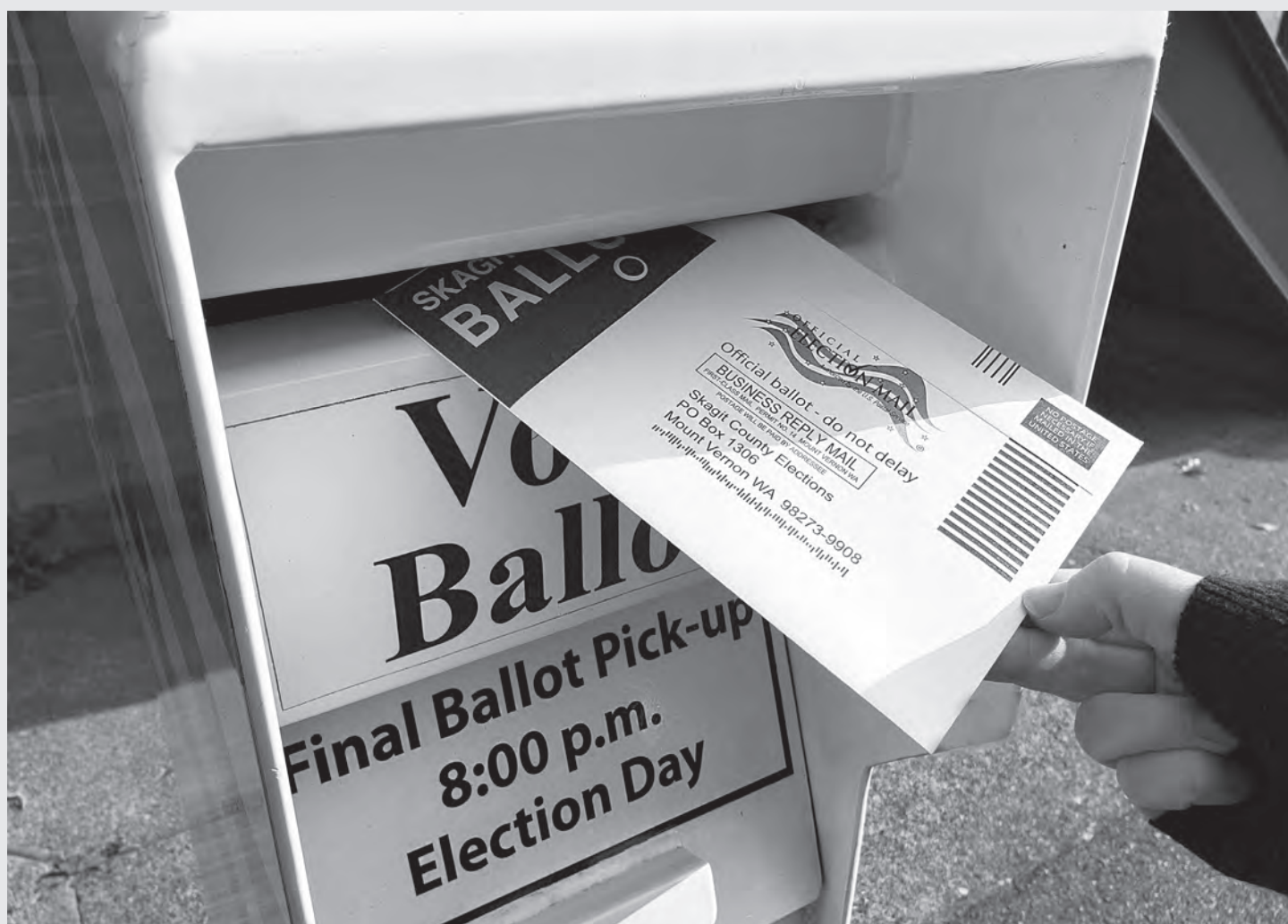
- You must first meet with a Certified Advocate who can assist with threat assessment, safety planning, and the program application.
- The best time to enroll is when you move or are planning to move to a location that is unknown to the offender and undocumented in public record.

After October 25th and until 8:00pm on November 2nd, you can register and vote at our Elections Office: 700 S. Second Street, Room 201, Mount Vernon. 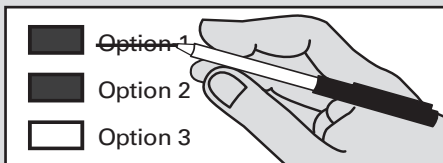

Explanatory Statement

Fidalgo Pool & Fitness Center (FPFC) is a separate municipal corporation not financially affiliated with the City of Anacortes or Skagit County. The FPFC District was formed by voter approval in May 1972 to build and operate a swimming pool for Fidalgo Island residents. A fitness center was added in 1986 to accommodate strength training and group exercise classes. Due to the expense to maintain the facility and to keep the doors opened, the FPFC District requires levies to supplement user fees collected at the front desk. The District is required to obtain voter approval every one to six years to continue this support. In 2021, the FPFC’s levy is scheduled to be approximately \$ 746,366. With approval by the voters on this replacement levy, the District will be authorized to receive \$760,000 in 2022 to continue maintenance and operations for six years. The levy will cover years 2022 through 2027, and will not exceed an increase of 1% each year. The mil rate for this election is the same as the current mil rate.

Argument For

The Fidalgo Pool & Fitness Center is our community asset that has served the wellness and recreational needs of all ages for over 45 years. The pool and fitness center, opened seven days a week, is constantly being used for rehabilitation, group fitness, weight training, swimming, kayaking, scuba diving, water safety classes and public school aquatics. Our pool offers youth and adults a place to learn how to swim, participate in swim training, enjoy aquatics exercise, receive physical therapy, and compete in organized Thunderbird Aquatics Club youth and master’s level swimming. Families can share quality time during open swims, and seniors can engage in group water exercises to improve mobility and strength. The Maintenance and Operation Levy is an ongoing obligation, not a new tax, and must have voter approval to continue. The Maintenance and Operation Levy keep user fees affordable for all citizens, and pays expenses such as utility bills, operating and custodial supplies, minor facilities and equipment repair or replacement, and insurance coverage. The District is asking for the mil rate of 0.1138 cents per \$1,000 assessed valuation in 2021, which is less than what you granted in the November 2015 General Election for levy years 2016-2021. At that time, the district asked for 0.1394 cents per \$1,000 assessed valuation. We believe the District is prudent with the use of taxpayer dollars, and Fidalgo Pool and Fitness Center is financially responsible. The Thunderbird Aquatic Club and Friends of Fidalgo Pool and Fitness are pleased to be essential partners with the District and urge you to vote YES for the Districts’ Maintenance & Operations Levy. Fire Protection District No. 10**Proposition No. 1****Property Tax Levy for Fire Protection and Emergency Services**

The Board of Skagit County Fire Protection District No. 10 adopted Resolution No. 178 concerning a proposition to maintain and adequately fund District operations.

This proposition authorizes Skagit County Fire Protection District No. 10 to establish its regular property tax levy at \$0.90 per \$1,000.00 of assessed valuation in 2021 and authorizes annual increases of up to 3% each of the five succeeding years to maintain fire protection, emergency medical services and to provide for firefighter safety. The maximum allowable levy in 2026 shall serve as the base for subsequent levy limitations as provided by Chapter 84.55 RCW.

Explanatory Statement**Written by Fire Protection District No. 10**

Skagit County Fire Protection District No. 10 provides emergency fire protection and medical services to its citizens. If approved by the voters, this proposition will authorize the District to establish its regular real property tax levy rate at \$0.90 per \$1,000 of assessed valuation in 2021 for collection in 2022 (the current levy is approximately \$.50 per \$1,000 of assessed valuation) and will establish an annual growth rate of up to 3% for following five years. The dollar amount levied in 2026 shall serve as the District's tax levy base and in 2026, absent further voter approval, the tax levy will be subject to the statutory one percent limit.

The District's Board of Commissioners has determined that this proposition is necessary to maintain an effective level of services, fire fighter staffing, equipment and facilities in light of rising costs. Approval of this measure will allow the District to maintain the level of fire protection and emergency medical services provided to its citizens.

The Skagit County Auditor is not responsible for the content of statements or arguments

Argument For

Property tax dollars are the primary source of funding for emergency fire and medical services provided by the District. The District's current tax levy rate is approximately \$0.55 per \$1,000 of assessed valuation, approved over 30 years ago and is substantially less than that of neighboring districts of similar size including one district who's rate is currently set at \$1.2235 per \$1,000 of assessed valuation. If approved, this proposition will authorize the District to increase its regular property tax levy to \$0.90 per \$1,000 of assessed valuation in 2021 for collection in 2022. The District's Board of Commissioners has determined that this proposition is necessary to maintain an effective level of service, firefighter staffing and training, equipment maintenance and replacement and facilities management in accordance with rising costs and increased call volume. Passage of Proposition No. 1 will provide the funding needed for the District to continue to provide fire and emergency medical services at existing and future levels. Voting no, could potentially limit the district's ability to continue to provide the level of services it's citizens are accustomed to and deserve. At the statutory limit of 1% the District has only been allowed to increase it's annual budget by 10% over the last 10 years, while inflation has increased over 20% over the same time frame. This makes it very difficult to maintain increasing demands for service.
