- Do not use a felt pen. You may use a pencil or pen.
- Voting more than once per race or question will cancel that vote.

How to correct a vote:

- Draw a line through the entire candidate's name or measure as shown:

- You then have the option of making another choice.
- Do not sign your ballot; it will cancel your entire ballot.

How to vote a write-in:

- To vote for a person not on the ballot, connect the arrow and write in the name of the person on the line provided.

Property Tax Levy

The Board of Fire Commissioners for Snohomish County Fire District No. 12 (Marysville Fire District) adopted Resolution No. 2008A-1 concerning a regular property tax levy for Emergency Medical Services. This proposition would authorize the Fire District to set and maintain a regular property tax levy of \$0.50 or less per \$1,000.00 of assessed valuation for 2009 and thereafter pursuant to RCW 84.55.050 and subject to any other applicable statutory dollar rate limitations.
