

Initiative Measure No. 1658

Filed January 15, 2019

AN ACT to repeal excise taxes; repealing RCW 54.28.020; repealing RCW 54.28.025; repealing RCW 69.50.535; repealing RCW 82.02; repealing all RCWs from 82.04 to RCW 82.98; and repealing WAC 314-55-089. RCW 54.28.020, RCW 54.28.025, RCW 69.50.535, RCW 82.02, and all revised codes from RCW 82.04 to RCW 82.98 which are listed under "**Current RCWs**" shall be placed under "**RCW Dispositions**," with the date of the amendment included with the title of each code, and therefore officially removed from Washington State law. WAC 314-55-089 shall be placed under "WAC > Title section dispositions" and therefore officially removed from Washington State law.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF WASHINGTON:

Sec. 1. The following acts or parts of acts are each repealed:
