

Washington State Library Statewide Database Licensing - Intent to Participate (NewsBank)

YES, this library will participate in the paid trial subscription to resources from NewsBank, Inc. as brokered by the Washington State Library (WSL), a division of the Office of the Secretary of State (OSOS). NO, this library does not choose to participate in this offer at this time. The reasons are as follows:

It is understood that:

- This paid trial subscription will run from September 1, 2018 (with an effective date beginning once a library completes the setup and authentication process with NewsBank) through December 31, 2020, with the entire cost covered by the Washington State Library, using Library Services and Technology Act funds from the Institute of Museum and Library Services. *Libraries with existing subscriptions to NewsBank products must continue those subscriptions during the paid trial, but will have access to all of the content listed above at no additional cost to the library.* A copy of this Intent to Participate form will be provided to NewsBank.
- At any time during the paid trial, a library may exercise its option to continue its subscription to these resources by entering into an agreement with NewsBank, using pricing that has been proposed by NewsBank, increasing to “list” level pricing over a 3-year period (individual library pricing available from NewsBank upon request). WSL will provide subsidies for libraries that subscribe past the end of this free access period. For the 2021 calendar year, the subsidy rate will be 50%, followed by a 25% subsidy in 2022, after which subsidies will end. NewsBank will provide each participating library with that library’s usage data from the paid trial period.
- By agreeing to participate in the Statewide Database Licensing contract with NewsBank, the library also agrees to comply with the terms of the NewsBank license agreement (product terms of use) as modified for the State of Washington and made available for review (<https://sos.wa.gov/q/NewsEnroll>).
