1 AN ACT Relating to trading in special influence; amending RCW  
2 9A.68.050; reenacting and amending RCW 9.94A.515; and prescribing  
3 penalties.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 9A.68.050 and 1975 1st ex.s. c 260 s 9A.68.050 are  
6 each amended to read as follows:

7 (1) A person is guilty of trading in special influence if:

8 (a) He or she offers, confers, or agrees to confer any pecuniary  
9 benefit upon another person pursuant to an agreement or understanding  
10 that such other person will offer or confer a benefit upon a public  
11 servant or procure another to do so with intent thereby to secure or  
12 attempt to secure a particular result in a particular matter; or

13 (b) He or she requests, accepts, or agrees to accept any pecuniary  
14 benefit pursuant to an agreement or understanding that he will offer or  
15 confer a benefit upon a public servant or procure another to do so with  
16 intent thereby to secure or attempt to secure a particular result in a  
17 particular matter.

18 (2) Trading in special influence is a class ((C)) A felony.
