Creed of Jefferson.

[INADEQUATE UNDERSTANDING, 4, 1802.] It is proper you should understand what I deem the essential principles of our government, and consequently those who ought to shape its administration. I will compress them within the narrow compass they will bear—stating the general principle, but not its limitations:

Equal and exact justice to all men of whatever State or persuasion, religion or political.

Peace, commerce and honest friendship with all nations, entangling alliance with none.

The support of the State Governments in all their rights, as the most important administrations of our domestic concerns and surest bulwark against all anti-republican tendencies.

The preservation of the General Government in its whole constitutional vigor, as the sheet anchor of our peace at home and safety abroad.

A jealous care of the right of election by the people, a mild and safe correction of revolution where peaceable remedies are unprovided.

Absolute acquiescence in the decision of the majority, the vital principle of republics, from which there is no appeal but to form the vital principle and immediate parent despotism.

A well-disciplined militia, our best reliance in peace, and for the first moments of war, till regulars may relieve them.

The supremacy of the civil over military authority.

Economy in the public expenses, that labor may be lightly burdened.

The honest payment of our debts and sacred preservation of the public faith.

The diffusion of information, and arraignment of all abuses at the bar of public reason.

Freedom of religion, freedom of the press and freedom of person, under the protection of the habeas corpus, and trial by juries impartially selected.

These principles form the bright constellation which has gone before us and guided our steps through an age of revolution and reformation.

The wisdom of our sages and blood of our heroes have been devoted to their attainment. They should be the creed of our political faith, the text of civil instruction, the touchstone by which to try the services of those we trust; and should we wander from them in moments of error or alarm let us hasten to retrace our steps, and to regain the road which alone leads to peace, liberty and safety.

Under Which King?

Our last dispatches from the east bring the division question up in a new light. We tell you that our Territory is divided, but do not describe the boundary lines. We have searched faithfully among our exchanges for some light upon the subject, but the only thing we find in relation to the matter is contained in the news of the 4th—that the Senate, the House concurring, passed the bill organizing the Territory of Montana, changing the name to Idaho, and changing the boundary lines. It is a question then, with us, whether we are in the new or the old Territory. One proposition of the divisionists was to make the line of this county the boundary, leaving Walla Walla in the old Territory. Another proposition was that of that slippery old hypocrite Dr. A. G. Henry, running from the north-eastern boundary of Oregon by the 46th parallel to Snake river; thence north by longitude 117 to the British Pacific possessions; cutting off all the mining counties from Washington, excepting Spokane, and dividing Nez Perce county, so as to leave Lewiston in the old Territory. As Henry had arrived at Washington (having been sent as the special emissary of the Olympia clique) with his maps, &c., to advocate his plan of division, there is some reason to fear his plan may have been adopted. If either of these plans have been adopted they cannot be otherwise than distasteful to the people of the upper country as well as deleterious to their interests, and it may be said that their rights have been bartered away by a coterie of politicians and capitalists who are interested in retaining the capital of Washington Territory at Olympia, and who have worked for the division with this sole object. If they have accomplished their purpose in this case, and considering the treatment we have heretofore received at the hands of these Olympia men, it becomes the duty of the people of the upper country to begin to guard their own interests. They have the power, by concentrating it, to elect their own Congressmen; and we say let them exercise it. Let the people of the upper country call their own Convention and unite upon some one man whose interests are identified with theirs, and send him to Washington that their interests may be represented there as well as those of the baker's dozen of Clam-eaters who have fattened upon the spoils of office at Olympia until they think themselves the only people in Washington Territory worthy the consideration or attention of the government. Let the issue be made upon the securing of proper boundaries for our Territory and we cannot fail to win.

Later news says our present Delegate, Wm. H. Wallace, has been appointed, by the President, Governor of the new Territory.

A Prospective Indian War.

Recent letters from the Boise mines and vicinity confirm reports in regard to the hostility of the Snake Indians in that country. Several persons have already been brutally murdered and scalped by these savages. Animals are driven off by them with impunity, and a hostile bearing towards the whites is manifested by this tribe in all their actions. That there will be a war with these Indians the coming summer there is now every reason to believe. For years these savages have been the constant terror to overland emigrants to the Pacific coast, and thousands have been deterred from crossing the plains simply because these Indians stood in the way of a safe journey. Hundreds of emigrants have perished by the hands of this marauding, blood-thirsty tribe, and their bones lie bleaching from the Rocky mountains to the Grande Ronde valley. But the time, we hope, is near at hand when these savage fiends will get their dues and pay the penalty of their atrocious deeds by being swept from the face of the earth. They have commenced hostilities in a manner that there can scarce be any hope that they intend to show any mercy to the whites. Treaties have never availed much with Indians when they have once assumed a hostile attitude towards the whites, and there can be no hope of accomplishing anything in that way in the present instance. Let the tables now be turned, and if the same hostile bearing is continued by them, let the watchword of the Boise miners be adopted—"Kill every Snake Indian on sight!" By the slow process of Government expeditions there will perhaps be no avail to military force in the Boise region for some time to come; and until there is such a force there it behooves miners and others to prepare to protect themselves. Every one who goes to Boise should go well armed. Until the Indians are driven back from the road it is better and safer to go in parties of from ten to thirty than to straggle along by twos and threes. Third. Allowing a large profit to the miller, flour can be manufactured and sold here at \$6 to \$8 per barrel. In addition to this the miller will have the offal which will produce a large amount of food for hogs, to be converted into bacon.

Fourth. Flour, bacon, cattle and horses can be produced here much cheaper than they can be imported under any circumstances.

Fifth. Flour, bacon and beef are the chief requirements of miners, and as with the natural advantages of the country for producing them and the facilities for land transportation they can be furnished here cheaper than at any other point this side of the Cascades, the proceeds from the furnishing of these requisites will induce the sale of other articles to a large amount in the mercantile and manufacturing line, and necessarily benefit and increase every branch of business.

No one now doubts the acquisition of a very large population for this section of the country, not only from this coast but from the Atlantic States; and we may reasonably expect a large proportion of these emigrants will find homes in this valley, as it offers inducements for permanent residents that no other valley between the Rocky mountains and Cascades can. This will fully develop our resources within a short period; and when this is done we will have an annual trade of from twelve to fifteen millions of dollars per year. As at least two-thirds of this amount will be retained at home, as the proceeds of the sale of actual products and the profits of trade, any one can estimate the future wealth of the community.

In enumerating these advantages, we have made no allusion to the certainty of the development of good mines much nearer here than any now being worked, in the supply of which we will have the exclusive control over any other point of trade.

The development of agricultural, mineral and commercial resources requires capital and labor, and the concentration of both at any one point will always create a monopoly of trade that will overcome mere geographical advantages. We are satisfied with our prospects here and do not envy the prosperity of any other point, as the prosperity of the whole country gives prosperity to all points in proportion to their capital, labor and natural resources.

Freights to Boise.

The Golden Age says: "In Walla Walla, reports say the merchants are willing to give forty cents if the contractor will deliver freight in Boise within forty days. Our packers intend to go through in less than half that time." Such stuff may look very well in print; but it only serves to inspire a feeling of contempt for him in the minds of those who know better, and who know that he only writes such stuff through an intense local prejudice. This disposition to misrepresent facts and mislead the public, through a merely local prejudice, is the most contemptible thing of which a public journalist can be guilty. No honorable man will stoop to it. Thirty cents is the highest figure that has been paid here this spring for freight to the Boise mines; and so to the time required in making the trip, no one would be so insane as to speak of forty days being required to do it. The distance by the present traveled route is only about 220 to 230 miles, and nearer than that to Lewiston, notwithstanding the editor of the Age computes the distance from that point at only 180 miles; and when the new road is opened from this place the distance from here will be materially shortened.

The express companies have been making the trip from here to Boise via Auburn, nearly all winter in five to six days.

</

Navigation of Snake River.
The navigation of Snake river for any considerable distance above Lewiston is pronounced an impossibility by a party who left Lewiston some time ago, in a small boat, for Boise. Mr. D. Rideout, who came in a few days from Old's Ferry, on Snake river, says the party above referred to, consisting of Messrs. Edwards, Francis and others, arrived at the ferry just before he left, and reported that they had been forty days in making the trip from Lewiston to that place. About half way through these points they were compelled to leave their boat and resort to *Cayuses*, being unable to get their boat over the rapids and falls, which they say are too high for any boat ever to ascend. This party went back to their friends here and in the Willamette not to attempt on any account to ascend Snake river to Boise in boats, assuring them that navigation of that river for more than half that distance is a matter of impossibility.

This Year's Crop.—We estimate, from what we consider reliable authority, that the crop of small grain the present season in this valley will not fall far short of two hundred thousand bushels. Think of that you who have been predicting that the Walla Walla valley is "played out." When this grain is brought into market, and it will all find sale—you will find this the most prosperous valley on the north-Pacific coast.

The Oregon Statesman.—Mr. Ashbel Bush has retired from the control of the Oregon Statesman. Messrs. C. P. Crandall and E. M. Waite are the new proprietors. Brother Pearce, of the *Advocate*, will now have a "breathing spell" unless the printer member of the new firm has not forgotten how the revered *epitome* him by charging him six-bits for a worthless dry goods box.

The Golden Age grows jubilant over the report of a party who have returned to that place reporting Snake river navigable to a point near the mouth of Powder river. The report, however, contradicts itself, in stating that in some places the river seemed to flow rapids from the height of 10 feet in fifty yards. We very naturally infer from the statement—taken altogether, "drinks" thrown in—that it would take a steamboat of magnificent proportions and "glorious" power, to navigate Snake river to the point in question. Wonder if the *Age* man has ever reflected upon the fact that if the river should prove navigable to the point he claims it is, it will effectively place the town of Lewiston out and build up a city at the head of navigation?

Home Again.—Hon. S. D. Smith, Representative from this county in the late legislature, returned home on Wednesday. His affection for the Clam-catchers of Puget Sound is expressed in terms no more ardent than those used by his fellow-representatives from the upper country. Mr. S. has been detained in Portland on account of ill health, but we are glad to state it is now in a fair way soon to become "himself again."

A Hoe Country.—An old farmer remarked to us the other day that "this valley would eventually become the best raising country of the Pacific coast, for the reason that corn can be produced here in such abundance as to render the fattening of hogs as cheap a business as in the western States." Making some allowance for a very slight difference between this valley and the western States in the production of corn, we shall not be surprised to see his prediction fulfilled, for while we may not compete with the States in the production of corn, it is very certain that no other part of the Pacific coast can compete with this valley in that respect.

"Glorious News!"—The editor of the *Age* heads the news of the division of the Territory as "Glorious News." If old Henry's boundaries have been adopted, and Lewiston is left in the southern corner of the old Territory—as is quite likely the case—we wonder whether Senators will still think the news so "glorious?" And if the government of the new Territory, as reported by the correspondent of the *Sacramento Union*, is merely a "provisional" one, without a delegate or a Legislature, would it be a "glorious" plea for intelligent and loyal freemen?

LEGAL TENDERS.—Greenbacks were quoted at 70 on the 7th inst, in San Francisco—5c above the New York valuation. The rise above the New York valuation was stimulated by a demand for notes to exchange for stamps. The Portland quotation on the 13th, was 66 cents, and on the 14th 70 to 75 cents.

ANOTHER PASSENGER TRAIN.—Mr. Wm. Ish has started a passenger train between this city and Auburn. He sent out one train on Thursday, and will send another some time next week.

TERMINAL CONVENTIONS.—We are informed that Democratic and Republican Conventions are soon to be held at Olympia to nominate candidates for the delegateship. The programme has not yet been made public, but we presume the "Clam-catchers" will arrange it so as to have matters entirely their own way.

GARDENING.—We notice a number of gardens in the vicinity of the city already in a fair state of advancement. Another month and we will have various kinds of vegetables in our market. Some few persons who have planted in hot-beds have already vegetables nearly fit for table use.

STAGE LINE TO AUBURN.—We are informed that parties are now in this city perfecting arrangements for the establishment of a stage line from Walla Walla via this city to Auburn.

PAY DAY FOR THE LEGISLATORS.—It is announced that Elwood Evans Secretary of this Territory is now ready to pay the Legislators their mileage and pay them for 1863.

THE OPPOSITION.—We are informed that the opposition line of steamers will be in operation between here and Portland in a few days.

RISING.—The Columbia and Snake rivers are rising slowly.

Letter From Boise.
PLACHEVILLE, March 9th, 1863.
EDS. STATESMAN—I see an article in your paper wherein the informant states that a man by the name of Shaffer, on the Payette River near Horse-shoe bend. Such is not the case. Burns was killed by two Irishmen, one by the name of Sullivan and one by the name of Boil. The fight took place in Standifer's saloon. The men were tried before Justice Stringham—one was acquitted and the other bound over to the first court that may be held in this country. I do this to let those whom it may concern know that the statement is not correct.

The snow is going away fast. The mines are paying well. Many trains have lately arrived in the mines. Many new discoveries are being made. The town is improving fast—many good buildings going up. Provisions of all kinds are very high. No news from Standifer and his party, who went to fight Indians a few days since. Mr. Kockelrow reaches us very regular with all the papers letters and is very obliging to all who have dealings with him.

REPORTED NEW DIGGINGS.—We hear reports this week of new mines having been discovered near Elk City, which prospect well; also on the Payette river, Clearwater river, and in the vicinity of the Bald Mountain mines. It would be well for miners to divide their attention between these places and Boise.

THE TELEGRAPH.—The work of stretching the wire on the line of the Oregon telegraph is now in process between Portland and Salem. The line is nearly completed between those points.

NEW BOAT.—The new boat *Nes Perce* Chief belonging to the O. S. N. Co.'s line, made a trial trip last week from Celilo to Deochotus. She will be ready to put on the line to Walla Walla and above as soon as the stage of the water will permit.

REDUCTION OF FARE.—The Pioneer Stage Line has reduced the fare from here to Lewiston, from \$20 to \$10.
