THE RAILROAD BOOM.

Telegraphic advices of yesterday bring information that a new company, just organized in Portland, Or., with Villard at its head, and fifty million dollars at its back (when the stock is all taken) contemplates the building of several railroads among which will be one across the Cascade mountains, through the Snoqualmie pass, to Seattle.

Puget Sound people generally will recognize very hopeful signs in this new move, because, disguise it as they may, the Portland people cannot get rid of the fact that Villard has been sharp enough to see that the growing needs of this great northwest would soon track a road across the Cascade mountains, and that he who failed to get the start in railroad building might as well seek some other field or retire from the business.

There is an attempt, by a proposed network of roads, to make Washington Territory still tributary to Portland, yet when an outlet is once furnished from the valleys of Eastern Washington direct to Puget Sound, nothing but the most unwarranted high tariffs over such route could ever force the commerce of that vast and fertile region through Portland and out by way of the Columbia river.

Once connect the two sections of this territory, by railway communication, and the way is opened for a perpetual exchange of commodities, while the farmers of the eastern portion are emancipated from the slavery of delay and expense of sending their produce around by Robin Hood's horn (the Columbia river bar). That they will avail themselves of the benefits thus offered, as soon as possible, is to say that men will look to their pecuniary interests by patronizing the cheapest and most expeditious route to market—a fact which needs no argument to demonstrate.

Villard is an ambitious monopoly manager who aspires to control the entire traffic of the northwest, caring little for petty jealousies between different local points if his grand schemes may be realized. For the general welfare of Puget Sound, we hope he may push the good work with all possible speed.

Locally there will not be much cause for hickering or regrets. All sensible people in Western Washington will be pleased to see a road to ANY point on the Sound. It will prove "the beginning of the end" in the way of development of the country.

If the statement was true—and from its reliable source, and the way it hurt, we may reasonably pronounce it so—Mr. Banks did a brave act for the good of society in making it public, and such a cowardly course on the part of the would-be murderer will only serve to make friends for the temperance cause and its obvious advocate. The shooting aroused great indignation, we are informed, and the shooter languishes in jail on a charge of assault with attempt to kill.

SAN JUAN CO. MINES.—M. S. Booth, Esq., of Seattle, who has been down to see the silver bearing quartz on Orcas Island, reports much local excitement there over the supposed value of the discovery. SUBDUE DEATH.—About last past 11 yesterday morning, Samuel L. Wells, a carpenter and contractor, brother of Geo. F. Wells, died suddenly of rheumatism of the heart. He complained of the trouble a few weeks ago, and consulted a physician. However, he continued to work at a building on which he was engaged at the corner of Twentieth and F streets. After working a while yesterday, he became very weak and lay down on the ground, calling to a fellow workman to procure a wagon and take him to a physician. An express wagon was procured and he was lifted in. After proceeding two or three blocks, the driver observed Mr. Wells gasping and stopped. In less than a minute the suffering man died. The body was taken to Coroner Garfield's, who, after the facts above related, decided it unnecessary to hold an inquest. The deceased was thirty-three years old and leaves a wife, but no children. He was a member of Pacific lodge, A. O. U. W., under whose auspices he will be buried tomorrow at 2 P. M. from his late residence, No. 188 Eighth, between Yamhill and Taylor.—"Oregonian," of June 23d.

It forbids the sale, or keeping or offering for sale, of any article of food or drink, or of any kind of drug designed for medical use, that is adulterated in any manner whatsoever, under a penalty of \$50 fine for the first offense and \$100 for the second. It will be the duty of our next Legislature to enact a similar law for Washington Territory.—W. W. "Union."



FARMERS were complaining early in the spring about a lack of rain. We haven't heard a single murmur on this score, however, for over a month.


