On behalf of the Office of the Secretary of State, thank you for participating in our democratic process. I am pleased to present the 2022 General Election Voters’ Pamphlet to help you make informed decisions as you exercise your right to vote. This guide includes information about voting, and the candidates and measures that appear on your ballot.

Before you can participate, you must be registered to vote. Voter registration forms that are mailed or completed online must be received by Oct. 31, and we encourage you to review your registration information today at **VoteWA.gov**. After Oct. 31, you must visit an elections office or voting center during regular business hours or until 8 p.m. on Election Day, Nov. 8, to register to vote or update your registration and receive a ballot.

After you have voted your ballot, be sure to sign the return envelope. Your signature is important because election officials check that your signature matches the one on your voter registration record before they count your ballot. Next, return your ballot. If returning by U.S. mail — no postage needed — remember that ballots must be postmarked by Nov. 8 in order to be counted. You can also use an official ballot drop box anywhere in the state. Drop boxes are open until 8 p.m. on Election Day. Check **VoteWA.gov** to locate a ballot drop box or see the status of your ballot.

By voting, you are making your voice heard.

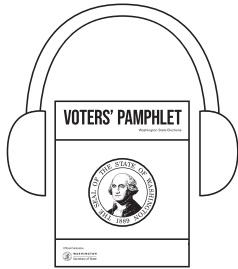

Qualifications

To vote, you must be at least 18 years old, a U.S. citizen, a resident of Washington, and not currently serving a sentence of total confinement in prison.



If you're 16 or 17 years old, you can sign up as a Future Voter and be automatically registered to vote when you qualify.

How do I register to vote?

By mail: Request a paper form be mailed to you or print your own at sos.wa.gov/elections

In person: Visit a county elections office (listed at the end of this pamphlet).

Registration deadlines



By mail or online: Your application must be received no later than October 31.

In person: Visit a local voting center no later than 8 p.m. on November 8.

Check your registration info at VoteWA.gov.

Moved? Update your voting address

Contact a county elections office to request a ballot at your new address.



By October 31: Have your application received by mail or updated online.

Or

By November 8: Visit a local voting center in person.

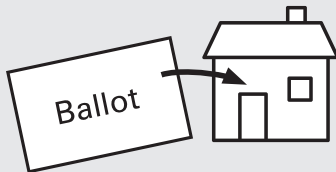
Sign up online at VoteWA.gov with your Washington state driver's license, permit or ID. Or, you can fill out a paper registration form using the last four digits of your Social Security number and mail it in. You'll be automatically registered to vote when you qualify.

Every January on Temperance and Good Citizenship Day, high school students 16 and older have the opportunity to complete a voter registration form in class.

How do I vote and return my ballot?

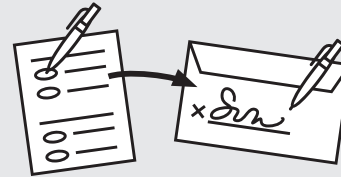

If you're registered to vote, there is no need to request a ballot. Your ballot will be mailed by **October 21** to the address you provide on your voter registration. If you need a replacement ballot, contact a county elections office listed at the end of this pamphlet.



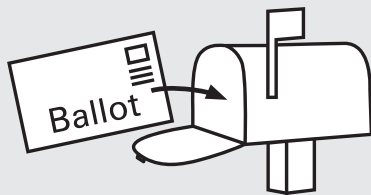

Vote your ballot and sign your return envelope. We need your signature to accept your ballot. You are not required to vote every race on your ballot. We encourage using this pamphlet to help you decide.



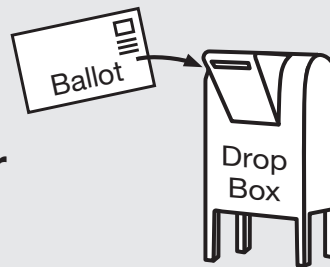

Return your ballot by mail, no stamp needed. If mailed, your ballot must be postmarked by **November 8**. Don't let a late postmark disqualify your ballot. The USPS recommends that you mail a week before Election Day.



Or, return your ballot to an official ballot drop box. Drop boxes are open until 8 p.m. on **November 8**. Find drop box locations at **VoteWA.gov**.

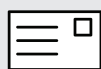

If you cannot personally return your ballot, let only people you trust deliver it for you.

Election staff will contact you before your ballot is processed if:

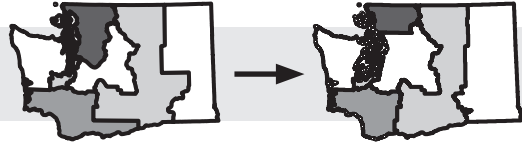
- Your signature is missing
- Your signature doesn't match your voter registration record

View election results online

After 8 p.m. on election night, tallied results from each county are posted at **results.vote.wa.gov**.

Results are updated as counties report and unofficial until certification.

Your district may have changed



Every 10 years, following the U.S. Census, legislative and congressional district boundaries are redrawn in a process called redistricting.

Redistricting ensures that each district has about the same number of people, which means equal representation in government.

As a result of redistricting, you may have been assigned to a new legislative or congressional district.

If you have changed districts, you will vote on different legislative or congressional races, beginning this year.

How do I know if something is true?

When reviewing online or printed information, think about:

- Who made this, and who is it for?
- Why did they make it?
- When was this made?
- What makes it believable?
- How might other people read this message?
- Ask the experts — consult a fact-checking site or ask an official source. Get trusted info from your county auditor or elections office.



i Advisory votes are the result of Initiative 960, approved by voters in 2007. The Office of the Secretary of State publishes the Attorney General's advisory vote description according to RCW 29A.72.283.

You are advising the Legislature if you do or do not favor a tax increase passed during the recent legislative session.

Repeal — means you **don't favor** the tax increase.

Maintain — means you **favor** the tax increase.



**Advisory votes are non-binding.
The results will not change the law.**

Engrossed Substitute House Bill 2076

The legislature imposed, without a vote of the people, premiums on “transportation network companies” to provide workers compensation to their drivers, costing an indeterminate amount in its first ten years, for government spending.

Engrossed Substitute House Bill 2076 (ESHB 2076)
Narrative Explanation (required for Indeterminate Cash Receipts)
<p>Section 1 requires transportation network companies (TNCs) to remit \$0.15 of every passenger fare quarterly to the newly created Driver Resource Center Fund beginning July 1, 2024. How much is collected will change each January 1 because remittance will be adjusted each year based on inflation. In addition, the Department of Labor & Industries has no way to predict how many passenger fares will be remitted or how many TNCs will be subject to interest and penalties due to failing to remit payments by the deadlines. For these reasons, fiscal impact associated with section 1 is indeterminate.</p> <p>Section 11 of the bill directs L&I to assess premiums for TNC drivers only for hours while the driver is engaged in passenger platform time and dispatch platform time effective January 1, 2023. These premiums would be used for potential future claims and would be deposited in the Accident and Medical Aid Accounts. L&I anticipates that there would be additional claims filed by these workers and L&I would receive additional premiums for this coverage. However, there is not sufficient data on these workers to determine the volume of additional claims or the level of additional premiums. This section of the bill is indeterminate.</p>

If I am a victim of a crime, can I vote safely?**Keep your voting address confidential**

You may be able to enroll in the Address Confidentiality Program (ACP) and register as a Protected Records Voter if you are:

- a survivor of domestic violence, sexual assault, trafficking, stalking; or
- a criminal justice participant or election official who is a target for harassment.



To become a Protected Records Voter:

- You meet with a Certified Advocate who can assist with threat assessment, safety planning, and the program application.
- The best time to enroll is when you move or are planning to move to a location that is unknown to the offender and undocumented in public record.

Federal Qualifications & Responsibilities

Except for the President and Vice President, all federal officials elected in Washington must be residents of the state. Only federal offices have age requirements above and beyond being a registered voter.

Congress

The United States' Senate and House of Representatives have equal responsibility for declaring war, maintaining the armed forces, assessing taxes, borrowing money, minting currency, regulating commerce, and making all laws and budgets necessary for the operation of government.

United States Senator

Senators must be at least 30 years old and citizens of the U.S. for at least nine years. Senators serve six-year terms. The Senate has 100 members; two from each state.

The Senate has several exclusive powers, including consenting to treaties, confirming federal appointments made by the President, and trying federal officials impeached by the House of Representatives.

United States Representative

Representatives must be at least 25 years old and citizens of the U.S. for at least seven years. Representatives are not required to be registered voters of their district, but must reside in the state. Representatives serve two-year terms.

The House of Representatives has 435 members, all of whom are up for election in even-numbered years. Each state has a different number of members based on population. After the 2010 Census, Washington was given a 10th Congressional District.

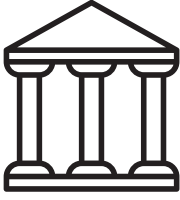

Judicial Qualifications & Responsibilities

Washington judges are nonpartisan. Judges must be registered Washington voters.

Judges

Judicial candidates must be in good standing to practice law in Washington and are prohibited from statements that appear to commit them on legal issues that may come before them in court.

State Supreme Court Justice

The Washington Supreme Court is the highest judiciary in the state. State Supreme Court justices hear appeals and decide cases from Courts of Appeals and other lower courts. Nine justices are elected statewide to serve six-year terms.

Court of Appeals Judge

Court of Appeals judges hear appeals from Superior Courts. A total of 22 judges serve three divisions headquartered in Seattle, Tacoma, and Spokane. Court of Appeals judges serve six-year terms.

Superior Court Judge

Superior Courts hear felony criminal cases, civil matters, divorces, juvenile cases, and appeals from the lower courts. Superior Courts are organized by county into 30 districts. Superior Court judges serve four-year terms.

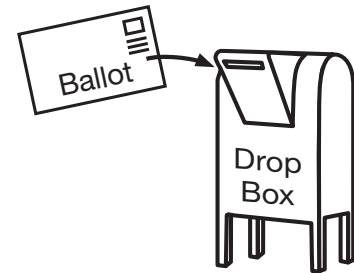

Your county receives your ballot

Deposit your ballot in an official drop box by 8 p.m. on November 8, Election Day, or return your ballot by mail — postage paid — but make sure it's postmarked by Election Day! Don't let a late postmark disqualify your ballot. The USPS recommends that you mail it back at least one week before Election Day.



Election staff will contact you before your ballot is processed if:

- Your signature is missing
- Your signature doesn't match your voter registration record

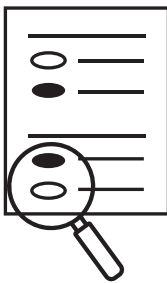
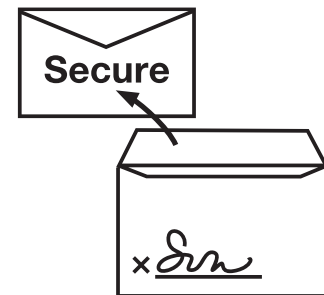
Your signature is verified

Your signature is important and we need it to accept your ballot. The signature on your return envelope is compared to the signature on your voter registration record. If the signature matches, your ballot is accepted and you are credited for voting to ensure **only one** ballot is counted for you.

Envelopes and sleeves are separated

The return envelope is opened and the security envelope or sleeve containing your ballot is removed. They are separated to ensure the secrecy of your vote.

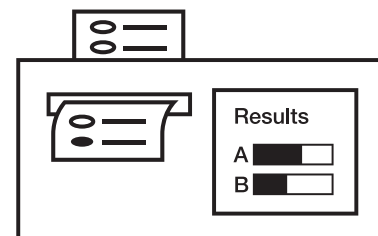
Your ballot is reviewed and scanned

The security envelope or sleeve is opened and election staff review your ballot to verify that it can be successfully scanned. Each voting system is certified and tested before every election.

Your ballot is counted

After 8 p.m. on Election Day all scanned ballots are tallied. Ballots will be scanned and tallied over the next several days until all the votes are counted. Every county conducts a post-election audit.

To register to vote you must be:

- A citizen of the United States
- A legal resident of Washington state for at least 30 days prior to election day
- At least 18 years old. If you are 16 or 17, you can sign up as a Future Voter and be automatically registered to vote when you qualify
- Not disqualified from voting due to a court order
- Not currently serving a sentence of total confinement for a felony conviction in Washington state
- Not currently incarcerated for a federal or out-of-state felony conviction

In Washington state, you do not register by political party or declare political party membership to vote.

- Mail a completed registration form (available online and at public libraries, schools, and other government offices)

Registration Deadlines

- Register to vote online or by mail by October 31 (8 days before the election)

Ballots

All registered voters will receive a ballot in the mail for every election in which they are eligible to vote. Accessible voting equipment is available to allow voters who cannot vote independently by mail to vote a private, secure ballot. (See Accessible Voting in next column).

Ballot envelopes must be signed and postmarked or dropped in a ballot drop box on or before Election Day, November 8.

- If returned by mail - check the last pickup time to ensure your ballot envelope is postmarked on or before Nov. 8
- If returned by ballot drop box - make sure you drop it in one of our 35 ballot drop boxes before 8 p.m. on Nov. 8
- Vote early to ensure your vote is counted in the Election Night results and to allow time to cure any signature issues.

Accessible Voting

Accessible voting equipment is available to assist voters in independently casting a private, secure ballot.

Sales and Use Tax for Street, Sidewalk, Walkways, and Trail Construction and Street Preservation Improvements

If approved, this proposition would authorize a sales and use tax of 0.2% within the City pursuant to RCW 82.14.0455, for a term of 10 years, to pay for costs, and repay indebtedness issued from time to time to construct, repair, and maintain streets, sidewalks, walkways, and trail improvements in the City to improve transportation and pedestrian access and safety.

Explanatory Statement

The City Council for the City of Lake Stevens in the interest of public safety, acting through its assumed power of the Lake Stevens Transportation Benefit District, is seeking voter approval to impose a two-tenths of one percent sales and use tax upon all taxable retail sales and uses within the boundaries of the City/District to finance transportation improvements. The sales and use tax will be used entirely to finance the cost, and repay debt issued, to construct and maintain streets, sidewalks, walkways, trails, and related infrastructure described in Section 2 of Council Resolution No. 2022 - 10 and on the City website. The period of the tax, if approved, is ten years. The sales and use tax will apply to persons who shop and thereby use the sidewalks, walkways, trails, and roads in the City and not just to City residents. The proceeds from the sales and use tax are intended to finance the costs, and repay an estimated \$10,000,000 in debt to be issued to expedite the completion of sidewalks, walkways, trails, and other eligible transportation improvement projects, improving pedestrian and traffic safety within the City of Lake Stevens. The sales and use tax proceeds will supplement existing revenue sources and any grant funding obtained by the City for transportation improvements.

Argument For

Funding a Transportation Benefit District is a positive step for Lake Stevens. It will enable Lake Stevens to build and upgrade roads to reduce congestion and build needed sidewalks and walkways. Through a citizen advisory process, the council wisely made congestion reduction, sidewalks, and walkways a high priority for TBD funds. Sidewalks and walkways are for everyone's benefit. Congestion relief is sorely needed and will only worsen if the city doesn't act now.

City roads need maintenance, particularly, preservation maintenance. TBD funds will help fund a proactive approach to road maintenance.

Two tenths of a cent sales tax will cost 2 cents on every \$10.00 retail purchase or, obviously, \$0.20 on a \$100.00 purchase yet produce enough revenue to make a genuine difference in the number of sidewalks, and road improvements in Lake Stevens. It also provides a way for the city to provide matching funds for infrastructure grants from state and federal sources. The benefit of using sales tax rather than a property tax is that it captures revenue from retail sales from people who don't live here but drive through to shop. With Costco coming into Lake Stevens, this is a significant capture from those who use Lake Stevens roads, just to drive through and shop.

A vote to fund the TBD is a vote for Lake Stevens to relieve congestion and build sidewalks and walkways. Let's make the city truly walkable with safe and efficient roadways.

Rebuttal to Argument Against

Nine hundred people let the city know their priorities. That's significant. 900 households out of 14,000 is 6%. That is very significant. They are involved, not on the sidelines.

The city received \$2.5m for a pathway on 16th Street. I'm sure other cities would love to have that grant.

Lundeen Park, North Cove Park, Callow Rd and South Lake Stevens sidewalks are examples of good management

Argument Against

The City of Lake Stevens is asking voters to approve a sales tax increase of 0.2% to fund Transportation Benefit District (TBD) projects.

The City website states: Earlier this year more than 900 community members participated in a survey identifying funding priorities for the TBD. Almost 61% liked the idea of a voter-approved sales tax option to fund the TBD projects.

The population of Lake Stevens in 2020 was 37,142 (worldpopulationreview.com/us-cities/lake-stevens-wa-population). Therefore the "900" persons who responded to the survey are less than 2.5% of the City's population. The 61% who support this tax increase are less than 1.5% or approximately 560 persons. And as with past surveys anyone can respond, residency is virtually unknown, and someone can respond more than once.

On March 10, 2022, Lake Stevens secured \$2.5 million for the 16th St NE Centennial Trail Connector in the Move Ahead Washington transportation package. (Washington State fiscal.wa.gov) Yet the number one item to be funded by this proposed sales tax increase, as noted on the City's priority list, is the Main Street connection to the Centennial Trail. (The complete priority list can be found on the City TBD website.)

Did you participate in the City's survey? Did you even see the survey? Let's tell the City to make better use of the funds they have, before authorizing more. Therefore, you must reject this measure.

Rebuttal to Argument For

Yes, the City must build, maintain and upgrade our roads, sidewalks and walkways.

The new Costco will provide the city additional sales tax revenue.

Each new residence built in Lake Stevens increases the revenue through their property taxes.

The City already received \$2.5 million from the State for the item listed as their number one priority.

They must show us they can use the current funds and increasing tax revenue wisely before asking for more.

Sales and Use Tax for Transportation Improvements

The Stanwood City Council adopted Resolution 2022-10 concerning a tax to fund transportation improvements. This proposition would renew a sales and use tax of two-tenths of one percent (0.2%) to be collected from all taxable retail sales in accordance with RCW 82.14.0455 for 10 years. Funds would be used to pay costs associated with transportation improvement projects identified in the City of Stanwood's Six-year Capital Improvements Plan.

Explanatory Statement

If approved, this measure would keep the two-tenths of one percent (0.2%) currently included in the local sales tax rate (9.3%) to fund costs of preserving streets in the City of Stanwood and constructing street improvement projects. The sales tax rate would remain in place for 10 years and raise approximately \$550,000 annually for paving streets and improvement projects. The funds to be generated from this ballot measure can only be used for qualifying safety and maintenance services, and capital projects included in the current six-year Transportation Improvement Plan. All consumers making purchases subject to sales tax in Stanwood would be taxed equally under this existing tax rate regardless of where they reside. If this measure is approved, a consumer's \$50 taxable purchase would continue to be taxed 4.65 cents as a result of maintaining this tax rate.

Argument For

This is not a tax increase. Extending the current, minimal, .02% Transportation Benefit Fund (TBF) sales tax (two cents on ten dollars) will improve the safety of our city. Building safe streets ranked as the highest resident priority, in a recent survey.

Safe streets and sidewalks make for a walkable and interconnected community. For example, future sidewalk improvements along 72nd, 80th, 92nd and 98th Avenues will benefit all residents by linking new developments into the current sidewalk systems. Efforts are underway to slow traffic on 80th Ave, improving safe routes to schools.

In the past 10 years, the city leveraged the \$2 million TBF monies into almost \$6 million of state and federal grants. To date, we have 5.47 miles of new or resurfaced roads and 153 ADA ramp upgrades. Over 2 miles of new sidewalks are in process. The list of specific street and sidewalk improvements is found on the City of Stanwood website.

We need your vote. Remember, everyone who shops in Stanwood contributes to this fund, not just Stanwood residents. By passing this TBF extension, we will be able to support our current transportation projects. Explanatory Statement

Passage of Proposition 1 would authorize the Monroe School District to replace an expiring levy for school programs and operations by levying \$15,890,376 for collection in 2023, \$16,767,086 for collection in 2024, \$17,672,509 for collection in 2025, and \$18,607,442 for collection in 2026. In accordance with Resolution No. 8-2022 approving this proposition, these amounts would be used to pay for day-to-day school operations to meet student needs not funded by the State, including but not limited to, arts, athletics, extracurricular activities, transportation, special education, school safety and security, professional learning for staff, operations and building maintenance costs, and additional staff including teachers, nurses, para-educators, mental health specialists, and counselors.

Based on projected assessed valuation information, the District estimates tax rates of \$1.71 per \$1,000 of assessed value for collection in 2023, \$1.72 per \$1,000 in 2024, \$1.73 per \$1,000 in 2025, and \$1.73 per \$1,000 in 2026. Under State law, tax exemptions may be available to homeowners age 61 or older, and disabled persons who meet certain income requirements. Argument For

Please **RENEW** this essential School Programs and Operations levy for the children and families of Monroe School District. Passing it is vital to providing a quality education to the more than 5,500 students the district currently serves.

A wonderful community must have wonderful public schools. This levy would replace our expiring levy, which provides critical funding to bridge the gaps where the state does not fully fund education and extracurriculars. Those things include special education services; STEM education and other academic programs; safety, security and health staff; athletics; drama, choir, band and other clubs; competitive wages to attract and retain quality teachers; instructional materials, new curriculum and smaller class sizes. If this levy is not renewed, the district will be forced to make deep cuts that will impact families in our community for years to come. Teachers, classified employees and other support staff will be laid off and valuable programs that support our students will be reduced or eliminated.

Rebuttal to Argument Against

OSPI Report Card's most recent data shows Monroe spent \$14,063 per pupil. Arlington spent \$14,197. Additionally, Monroe had a 90% graduation rate for 2020-21 to Arlington's 85%. Meanwhile, Monroe served more unhoused students (3.4% vs. 1.9% in 2021-22) and more English Language Learner students (11.9% vs. 5.3%), which can greatly factor into student testing performance. Monroe just came through challenging times, has brand new leadership and needs the community's support for continued progress.

Argument Against

Taxpayers should assess current Monroe School District (MSD) value for dollars spent when determining their support for the levy. Consider that Arlington, a nearby, similarly sized school district, spends less money per student and achieves better outcomes. Looking at the 2020-2021 total per pupil expenditure, which includes operational expenses, six year rolling average capital outlays, and interest on debt, Arlington spends \$15,360 per student per year and Monroe spends \$18,635 (schooldatapoint.com). Per the Washington State OSPI "Report Card" website, MSD student performance lags other districts, with students meeting standards at the following rates: English 41.8%, science 28.4%, and math 21.4%. Arlington Schools spend \$3,275 less per student annually, yet their students show better outcomes: 50.4% meet English standards, 49.1% meet science, and 23.7% meet math.

In February 2022, prior to the last levy vote, MSD eliminated the U3 college pathway program which had 156 participants, only 32 of whom were from the district. The percentage of participants completing the program was 3%. Taxpayers expect this type of stewardship and want to see more of it.

In 2018, the McCleary Decision was promised to be a levy swap but instead state property taxes increased dramatically. With property values increasing significantly our out of pocket spend continues to rise. Taxpayers are already supporting students - and the schools and teachers that serve them - but we also have the opportunity to hold MSD accountable for financial stewardship and student performance. <https://www.levyno.com/>

Rebuttal to Argument For

Despite what the pro committee suggests, a vote no is not a vote against our students or our schools but instead a vote for fiscal accountability and improved decision-making. Since the 2018 MSD levy vote, McCleary pumped billions into state schools.

Monroe can make better financial decisions to live within the framework of McCleary funding while providing a great education for our children. A vote against renewing this optional levy ensures they will do it.

Explanatory Statement

This proposition will authorize the merger of Snohomish County Fire Protection District No. 23 into Snohomish County Fire Protection District No. 17. Both fire districts currently provide fire protection and emergency medical services within their boundaries and have a history of working cooperatively. The Commissioners of both fire districts have determined that a merger of the two organizations into a single fire department is in the best interest of the District's residents.

If a majority of the registered voters of District 23 vote for merger, then the merger will be effective January 1, 2023. If merger is approved, District No. 23 will be dissolved and the boundaries of Snohomish County Fire Protection District No. 17 will expand to include all areas currently in District 23. The existing commissioners of both Districts will govern the merged district until the number of commissioners is reduced according to law.

Argument For

Over the past few years, Fire District 23's (FD23) volunteer firefighters have decreased significantly, and since the pandemic, there have been no available volunteers. Unfortunately, FD23 lacks the resources to train new volunteers or pay for staff and simply cannot respond to emergency calls. To provide for public safety, FD23 entered into a temporary agreement with Granite Falls-based Fire District 17 (FD17).

FD17 responds to our community's calls very quickly and provides Basic Life Support with their Firefighter/Emergency Medical Technicians and Advanced Life Support with Paramedics. They work with insurance carriers and never bill the community with additional costs or claims they do not cover.

FD23 has discussed a merger before, but now, the number of volunteer firefighters has dramatically declined in the past decade, and we have not been able to provide emergency medical services. The bottom line is that we have limited resources and no staffing.

By voting "Yes" to the merger, we will receive quick and professional responses down the Mountain Loop. FD17 staffs firefighters and paramedics 24/7 and maintains readiness for their fire engines, ambulances, medical equipment, and first aid supplies.

The proposed merger with FD17 is essential in maintaining lifesaving and fire protection for the Robe Valley. Of course, taxpayers will be paying more, but this is a small price to pay for a fire department that will be more responsive and can provide professional emergency services.

Voting "Yes" is critical to protecting us and is in the best long-term interest of the Loop.

Argument Against

After repeated recruitment attempts, no volunteers against the ballot measure came forward to write a statement.

New Washington resident

Welcome! Register to vote online, by mail, in person, or when you get your new driver's license or ID at the Department of Licensing. You may not vote in more than one place, so cancel your previous voter registration.

**Military or overseas voter**

Register to vote anytime on or before Election Day. You may receive your ballot by mail, email, or fax. Spouses and dependents also away from home have the same voting rights.

**College student**

Register to vote using either your home or school address, but you may not vote in more than one place. Your ballot can be mailed to you anywhere in the world; however, your residential address must remain in Washington.

**Non-traditional address voter**

Use any physical location you consider your residence such as a shelter, park, or marina. Your mailing address can be general delivery at a local post office, a PO Box, or an address of a trusted friend or relative. A federally recognized tribe may designate tribal government buildings to serve as residential or mailing addresses for voters living on tribal lands.

**Seasonal resident**

Vote in Washington even if you're away during an election. To ensure you receive your ballot, update your mailing address at VoteWA.gov or with a county elections office. Your ballot can be mailed to you anywhere in the world; however, your residential address must remain in Washington. You may not vote in more than one place.

**Person convicted of a felony**

If you were convicted of a felony in Washington, your right to vote is restored when you are no longer serving a sentence of total confinement in prison. After your right to vote is restored, you must re-register to vote in order to receive a ballot.

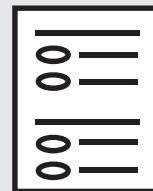

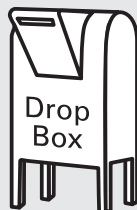

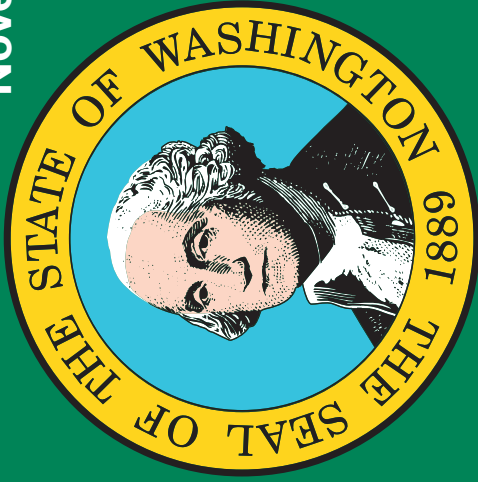
