

### **INSTRUCTIONS: ARTICLES OF CONVERSION NONPROFIT TO FOR-PROFIT RCW 24.03A.820**

<u>General Instructions</u>: Use dark ink only. Complete the entire form and enter all requested information in the fields provided. A fillable .pdf version of this form is available by contacting our office, to ensure you have the most recent version of the form.

Mail: Send the completed form and payment to the address listed above.

**Payment:** Make checks or money orders payable to "Secretary of State." Checks cannot be backdated more than 60 days from the date the check is received.

**Fees:** The filing fee for Articles of Conversion from a Washington Nonprofit or Nonprofit Professional Service Corporation to a Washington Profit Corporation is a total of \$190. This fee is broken down as \$10 for Articles of Conversion and \$180 for the Articles of Incorporation as a Profit Corporation.

**Expedited Service**: If expedited service is requested, an *additional* \$50 must be added to the filing fee. Check the box indicating expedited service on page one.

#### ALL FILING FEES ARE NON-REFUNDABLE. ALL DOCUMENTS ARE PUBLIC RECORD.

(1) Unified Business Identifier (UBI): Provide the UBI Number assigned to the business registration as on file with the Office of the Secretary of State of Washington. The UBI Number and name of the business must match our records in order to be accepted.

(2) Business Name: Provide the name as recorded with the Office of the Secretary of State of Washington.

(3) Charitable Assets: Select "Yes" if the Nonprofit Corporation holds assets for a charitable purpose as defined by <u>RCW</u> 24.03A.010(6) If "Yes" the select the attestation that the attorney general approved, or deemed to have approved, the for-profit conversion pursuant to <u>RCW 24.03A.770</u>

(4) Adoption of Articles of Conversion: Select how the Conversion was adopted by checking the appropriate box. If the second selection is made a date is required.

(5) Effective Date: Select the date this filing is to be effective. If "Date of Filing" is selected, the effective date will be the date the submission is completed by our office. A future effective date may be specified which may not be more than 90 days after the date of filing.

(6) Additional documents: It is required to submit the Articles of Incorporation pursuant to <u>RCW 23.B.02</u> This can be the form our office provides, or drafted Articles of Incorporation.

(7) Return Address for this Filing: If provided, the confirmation regarding this specific filing will be sent to this address, in addition to the Registered Agent's address.

(8) Authorized Person: Sign, print, provide the signer's title, and date the document.
