



The Court of Appeals decides which cases are appealed following trial in the Superior Courts, and has exclusive appellate jurisdiction in all but those cases which state law reserves to the state Supreme Court. An appellate court judge must be a legal scholar who understands and appreciates the social and human significance of the cases before the Court. Our law is an ever-evolving process that must preserve and protect the rights of all citizens. As a former district court judge, as a former deputy prosecuting attorney, and as an attorney in private practice, I have over twentythree years of direct experience with the legal issues and human conflicts that must be decided by our courts. I have written and lectured extensively on complex legal matters, in the course of continuing legal education process for lawyers and judges alike. I have been active in legal, civic and charitable organizations, in an effort to return to my profession and the community some of the benefits I have enjoyed as an attorney and as a citizen. As a Court of Appeals judge, I will work to fairly decide cases on their merits, not on technicalities. I will draw on my experience to write clear and well-reasoned opinions that will help citizens understand their rights and duties under the law. After graduating with honors from the University of Washington School of Law, I served as law clerk to Justice Charles Horowitz of the Washington Supreme Court. As a partner at Edwards, Sieh, Wiggins & Hathaway, my practice concentrates on appeals. I was appointed to Washington Appellate Defender Association's Board of Directors by the Court of Appeals and served as Chair of SKCBA's Judiciary & Court Committee. Robert E. SCHILLBERG Nonpartisan


