Hirotaka and Hobbs will present the Washington State Constitution for view at the Spokane Public Library September 15<sup>th</sup>, 2025. Hirotaka announced other events are in the works. Hirotaka thanked Washington State Patrol for their assistance safeguarding the document. Hirotaka announced the return of the Archives monthly newsletter and invited attendees to sign up for it. Hirotaka also announced staff will be attending and presenting at the NAGARA conference in Oklahoma City in July. Finally, Hirotaka announced the publication of *New Land* through Legacy Washington. The book commemorates the 50<sup>th</sup> anniversary of Washington State's resettlement program for Southeast Asian refugees and

features stories from first-generation refugees and their descendants. Hirotaka thanked Representative My-Linh Thai for her leadership and involvement on the project.
