I am pleased to present the 2025 General Election Voters' Pamphlet on behalf of the Office of the Secretary of State. This comprehensive guide to the candidates and measures on your ballot can help you find the information you need to cast your vote.

Elections that are accessible, secure, and transparent are the cornerstone of our democracy, providing you with the opportunity to make your voice heard on a variety of issues. This general election, you have the chance to help decide who represents your local community and weigh in on measures that affect daily life in Washington. It all starts with making sure you're registered to vote. Online and mail-in voter registrations and updates must be received by Monday, Oct. 27. In-person registration is also available at your local county elections office until 8 p.m. on Election Day, Nov. 4. If you're already registered to vote, now is a great time to sign into VoteWA and verify your voter registration information is up to date.

Once you receive and vote your ballot, make sure you sign the return envelope. Highly trained elections officials compare your signature to the one on your voter registration before your ballot can be counted. Then, return your ballot. If you vote by U.S. mail — no stamp needed — remember that ballots must be postmarked by Election Day to be counted. The USPS recommends mailing a week before Election Day to ensure your ballot is received on time. Or, return your ballot to one of the many secure ballot drop boxes across the state by 8 p.m. on Election Day. You can track the status of your ballot at [VoteWA.gov](https://VoteWA.gov) after returning it. Sign up for text notifications so you'll know when your ballot is received and accepted.

Exercising your right to vote is one of the most powerful ways you can make a difference in your community. Thank you for voting and supporting democracy here in Washington.

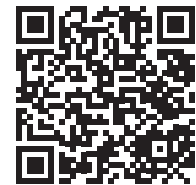

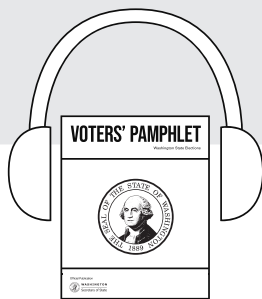

## How do I register to vote?

**Online:** Register at **VoteWA.gov**.

**By mail:** Request a paper form be mailed to you or print your own at **sos.wa.gov/elections**.

No internet access? Call 1 (800) 448-4881.

**In person:** Visit a county elections office (listed at the end of this pamphlet).

## Registration deadlines



**By mail or online:**

Your application must be received no later than October 27.

**In person:** Visit a local voting center no later than 8 p.m. on November 4.

Check your registration info at **VoteWA.gov**.

## Qualifications

To vote, you must be at least 18 years old, a U.S. citizen, a resident of Washington, and not currently serving a sentence of total confinement in prison for a felony.



## What if I'm not 18 yet?

**If you are 16 or 17, become a Future Voter!**

Sign up with your Washington state driver's license, permit, ID, or the last four digits of your Social Security number. You'll be automatically registered to vote when you qualify.

## Past felony conviction?

Get registered to vote.

Washington now restores voting rights to citizens with felony convictions immediately upon release from prison.

You must **re-register** to vote to receive a ballot.



## Moved? Update your voting address

Contact a county elections office to request a ballot at your new address.

**By October 27:** Have your application received by mail or updated online.

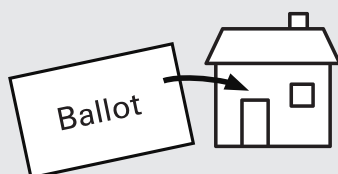

## How do I vote and return my ballot?

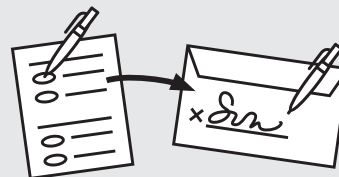

If you're registered to vote, there is no need to request a ballot. Your ballot will be mailed by **October 17** to the address you provided on your voter registration. If you need a replacement ballot, contact a county elections office listed at the end of this pamphlet.



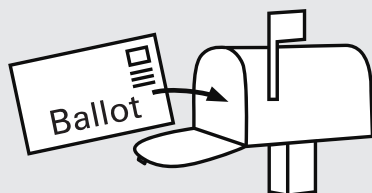

Vote your ballot and sign your return envelope. We need your signature to accept your ballot. You are not required to vote every race on your ballot. We encourage using this pamphlet to help you decide.



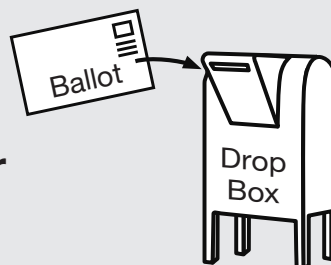

Return your ballot by mail, no stamp needed. If mailed, your ballot must be postmarked by **November 4**. Don't let a late postmark disqualify your ballot. The USPS recommends that you mail a week before Election Day.



Or, return your ballot to an official ballot drop box. Drop boxes are open until 8 p.m. on **November 4**. Find drop box locations at **VoteWA.gov**.

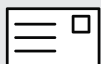

- Your signature is missing

### View election results online

After 8 p.m. on election night, tallied results from each county are posted at **results.vote.wa.gov**.

Results are updated as counties report and are unofficial until certification.

Senate Joint Resolution No.

8201

The legislature has proposed a constitutional amendment on allowing money in Washington’s long-term care fund to be invested.

This amendment would allow the state fund dedicated to providing long-term care benefits for eligible seniors and people with disabilities to be invested as authorized by law.

Explanatory Statement

The Law As It Presently Exists

The Washington Constitution generally prohibits investing public money in stocks of private companies. This means that state funds can only be invested in fixed-income securities, such as government and corporate bonds and certificates of deposit.

The Constitution currently exempts several funds from this restriction. This exemption applies to any public pension or retirement fund, workers’ compensation funds, and money held in trust for the benefit of people with developmental disabilities, permitting those funds to be invested as authorized by law, including in stocks of private companies. The Washington State Investment Board invests and manages these funds.

In 2019, the legislature created a long-term care insurance program. The program provides money to pay for certain long-term care services, such as nursing home care, to program beneficiaries who need assistance with daily living. Under that law, employees pay premiums for long-term care insurance through a payroll deduction, and those premiums are deposited into a Long-Term Services and Supports Trust Account. Under the current provision of the Constitution, money held in the Trust Account cannot be invested in stocks of private companies.

The Effect of the Proposed Amendment if Approved

This Amendment would allow funds in the Long-Term Services and Supports Trust Account to be invested in stocks of private companies, if authorized by law. Investment income from the Trust Account could only be used for long-term care services and supports for program beneficiaries, including for seniors and people with disabilities.

## Argument for

### Approve 8201 to guarantee long-term care funds are there when we need them

8201 requires 100% of investment income earned by the state's Long-Term Care Trust Fund to be spent on long-term care services for vulnerable seniors and disabled people. Washingtonians want to live with dignity as they age. 8201 supports this shared goal, strengthening the benefit's Trust Fund to help seniors and disabled Washingtonians while protecting taxpayers.

### 8201 is a commonsense measure that ensures tax dollars go further

Current law limits investment of the Trust Fund to only low-return choices, like government bonds and savings certificates. 8201 allows the Trust Fund to be invested to produce higher returns. This proven method would be managed by the independent, nonpartisan Washington State Investment Board, which is bound by the highest fiduciary standards.

### Approve 8201 to increase funding without impacting taxpayers

8201 is projected to grow the Trust Fund by \$67 billion over the next 50 years, money that can be used to increase benefits for people with disabilities and seniors without costing taxpayers a penny. Higher earnings mean more money for care – good for seniors, disabled Washingtonians, their families, and taxpayers!

### 8201 has overwhelming bipartisan support across the political spectrum

It's encouraging when leaders of both parties agree on something – and a supermajority of Democratic and Republican lawmakers approved this commonsense approach. 8201 is supported by nurses, unions, businesses, and groups representing millions of Washingtonian seniors and people with pre-existing conditions. *Vote Approve!*

## Rebuttal of argument against

Fact: Since 1981 the independent Washington State Investment Board has *safely and effectively* managed over \$200 billion for pensions, college savings funds, and more, with an average growth rate of 8% yearly. We must ensure our Long-Term Care Trust Fund grows to *keep up with rising costs while protecting taxpayers*. A bipartisan supermajority of lawmakers approved this measure. *Approve 8201* so WA's Trust Fund is *there for aging seniors and people with disabilities*.

## Argument against

### Reject this constitutional change, *again*.

Washington voters already rejected this proposal to take taxpayer money and invest in private stocks and corporations (2020, SJR8212). Our state founders protected public funds from risky investments by establishing safeguards in our state Constitution prohibiting corporate stock market investments of your tax dollars.

### Reject constitutional changes that gamble your money in an unstable market.

SJR 8201 overturns safeguards for the Long Term Services and Support (LTSS) fund, a multibillion dollar program established in 2020. Washingtonians are not yet eligible to access program benefits but proponents are *again* asking you to remove a key Constitutional protection. Currently, it's safeguarded in *secured* investments like federal, state and municipal bonds, which support our communities -- *a better use of our tax dollars*. Stock markets and private investments fluctuate greatly, *with no guarantees*, and the benefit needs are unknown in this untested program. This LTSS fund exists to help Washingtonians access long term care as we age or face disability. *When market speculation falls short, taxpayers and beneficiaries would pay the price through reduced benefits or increased taxes*.

### Rejecting constitutional changes provide more stability and certainty.

Continuing to invest our public money into federal, state and municipal bonds supports public works that we all depend on. Rejecting SJR 8201 provides for better planning and stability.

### Reject SJR 8201

Our state and LTSS need fiscal responsibility, not financial roulette. Reject SJR 8201 to keep the fund secure, stable, and focused on serving the people who will depend on it.

## Rebuttal of argument for

Proponents imply a guaranteed return of \$\$billions over 50 years but of course, that's not guaranteed. In 2008 the State Investment Board lost -26.2% and 2022 lost -12.9%. It's how the stock market works. In future recessions or market crashes, when returns fall short, benefits must be cut or tax rates must go up. Compared to *guaranteed* municipal bond returns of 3-5%, the choice is clear. Invest in ourselves, not Wall Street. *Reject SJR 8201*.

### Judges

Judicial candidates must be in good standing to practice law in Washington and are prohibited from statements that appear to commit them on legal issues that may come before them in court.

#### **Court of Appeals Judge**

Court of Appeals judges hear appeals from Superior Courts. A total of 22 judges serve three divisions headquartered in Seattle, Tacoma, and Spokane. Court of Appeals judges serve six-year terms.

**Remember to sign and date your ballot return envelope. Your signature must match the signature that is in your voter registration file in order to be accepted.**

The signature on file generally is the same as your driver's license signature. The Department of Licensing sends updates to our office.

## Vote and Return Early

### Accessible Voting

An Accessible Voting Unit (AVU) will be available in the Auditor's Office Monday through Friday 8:30 a.m. to 5:00 p.m., October 17, 2025, through November 3, 2025, with extended hours on Election Day, November 4, 2025, from 8:30 a.m. to 8:00 p.m.

Election Officials will be available to provide instructions and assistance as needed.

### Address Information

#### Keep it Current

Where you live determines which races and measures are on your ballot. When you move or change your mailing address, contact our office or go online to: [votewa.gov](http://votewa.gov) to update your voter registration.

#### Snowbirds or Travelers

We can set up a temporary or on-going seasonal address so we can send your ballot to your current location. Tell us the dates you will be gone, whether it is a one-time or on-going change, and the mailing address where you can receive your ballot.

#### College Students

You can register to vote using either your hometown address or the address where you live now, whichever location you consider your residence. If you choose to use your hometown address, your ballot can be mailed to you at school.

### Ballots

- Ballots will be mailed to all registered voters in participating jurisdictions on or before October 17, 2025. If you need a replacement ballot, visit [votewa.gov](http://votewa.gov) or contact the Auditor's Office.
- Your ballot will contain only races and measures you are eligible to vote on. For a list of jurisdictions you are eligible to vote on, visit [votewa.gov](http://votewa.gov).
- Printable replacement ballots and mail requests are available online at: [votewa.gov](http://votewa.gov). If you cannot access the internet, contact our office.

### Ballots (continued)

- If you choose to write-in a candidate's name, only write in a candidate's name who has filed a write-in declaration of candidacy with our office and is not already listed on the ballot.

- at least 18 years old
- not disqualified from voting due to a court order.
- not currently serving a sentence of total confinement in prison under the jurisdiction of the department of corrections for a Washington felony conviction and not currently incarcerated for a federal or out-of-state felony conviction.

### Future Voter Program

In Washington State, 16 and 17-year-olds can sign up as Future Voters and be automatically registered to vote when they become eligible. A voter who turns 18 between the August Primary and the November General Election can vote in the Primary.

### Community Outreach Plan - Signature Challenges and Cures

When a voter does not sign the back of the ballot return envelope or when the signature on the return envelope does not match the signature(s) in their voter registration record, their signature may be challenged. Any voter with a signature challenge can cure the issue and have their ballot count by following the instruction below.

#### **What to do if you forgot to sign your ballot envelope? (WAC 434-261-053(3-4))**

Return a missing signature form with a signature matching your voter registration file so that the ballot can be counted. This form is due by 5 p.m. the day before the election is certified (certification dates are listed later in this document).

Our office will mail you this form within 3 days of receiving your ballot. Missing signature forms are also available online at: <https://www.sos.wa.gov/elections/voters/forms-voters>.

Forms can be returned by mail, email, fax, or in-person. If you are unable to sign the missing signature form, you may make a mark in the signature area and have two people sign as witnesses. Power of Attorney is not acceptable.

If you do not return this form within 5 days before the election is certified, we will call to remind you to return it, if you have provided your phone number.

#### **What to do if your ballot envelope signature didn't match your record? (WAC 434-261-053(5))**

Return a signature update form with a signature that matches the ballot envelope you returned so that your ballot can be counted. This form is due by 5 p.m. the day before the election is certified (certification dates are listed later in this document).

Our office will mail you this form within 3 days of receiving your ballot. Missing Signature update forms are also available online at: <https://www.sos.wa.gov/elections/voters/forms-voters>.

Forms can be returned by mail, email, fax, or in-person. If you are unable to sign the missing signature form, you may make a mark in the signature area and have two people sign as witnesses. Power of Attorney is not acceptable.

If you do not return this form within 5 days before the election is certified, we will call to remind you to return it, if you have provided your phone number.

#### **Other options for correcting "curing" a signature that does not match.**

You may provide secondary identification verification by email, telephone or in person. Valid secondary identity verification may be either the last four digits of your Social Security Number (if that information is in your voter's registration file to verify) or full Washington driver's license, instruction permit or ID card number.

Alternate identification that may also be used if returned by mail, email, fax or in person:

- Photo ID;
- Valid enrollment card of a federally recognized Indian Tribe in Washington state;
- Copy of a current utility bill or bank statement;
- Copy of a current government check; or
- Another government document.

If you have had 2 consecutive elections with signatures that did not match, an additional signature update form will be sent so that you can update your signature for future elections.

#### **When are elections certified?**

- Ten days after the February or April Special Elections
- Ten days after a Presidential Primary
- Fourteen days after a Primary
- Twenty-one days after a General Election

#### **Keep your signature up to date.**

Signatures change over time. To ensure that your voter registration reflects your current signature, submit a signature update form to the Klickitat County Auditor's Office. Going forward any additional signature will be used for comparison to your ballot envelope along with all of the existing signatures in your record. #### **Ballot Alerts.**

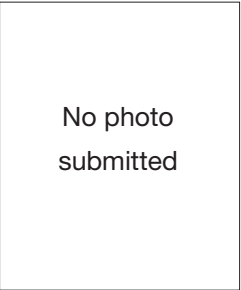

**Proposition No. 1**

**0.1% Public Safety Sales Tax**

The Goldendale City Council passed Resolution No. 747 concerning a public safety, criminal justice, and fire protection sales and use tax. This proposition would authorize the imposition of a city-wide sales and use tax, in addition to any other taxes authorized by law, of one tenth of one percent (0.1% -- 1 cent for every \$10) to be used for public safety, criminal justice, and fire protection purposes, as authorized by RCW 82.14.450. Should this proposition be:

**Explanatory Statement**

Written by Quinn Plant, City Attorney

The City of Goldendale is asking voters to approve a local public safety sales tax to help pay for police and fire services.

State law limits how much property taxes can increase each year to 1%. This limit does not keep up with rising costs.

Under RCW 82.14.540, cities can ask voters to approve a public safety sales and use tax of up to 0.1%. This proposal would add a 0.1% (10 cents per \$100 spent on taxable goods and services) within the City.

Together, police and fire services cost more than the City expects to receive in property taxes in 2025.

As required by law, Klickitat County would receive 15% of the money collected. The City of Goldendale would receive 85% and will use 100% of its share to help pay for police and fire services. Additional tax revenue raised through the public safety sales and use tax will be shared equally by the City of Goldendale’s police and fire departments.

This measure would not increase property tax.

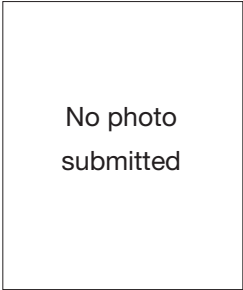

## Explanatory Statement

Written by White Salmon Valley Pool Metropolitan Park District Board

This measure asks voters in the Trout Lake area (School District R-400) whether to annex into the White Salmon Valley Pool Metropolitan Park District (WSVPMPD). The District was formed in 2018 to provide long-term public support for aquatic recreation: to build, operate, and maintain a community pool.

The current District boundaries reflect the White Salmon Valley School District excluding areas within Skamania County. If annexation is approved, Trout Lake residents would become part of WSVMPD. They would be eligible to vote in future Park District elections and run for a seat on the Board of Commissioners.

District residents pay a property tax levy of \$0.167 per \$1,000 of assessed value. For example, a home assessed at \$300,000 would pay approximately \$50 per year. Trout Lake property owners would pay the same levy if annexation is approved. Any future increase must be approved by voters.

District residents may receive discounted rates for pool use and programming. Rates are set by the WSVMPD Board.

A “Yes” vote approves annexation into WSVMPD.

A “No” vote means Trout Lake would remain outside the District.

## Argument For

### Support Trout Lake Joining the White Salmon Valley Pool Metropolitan Park District and the construction of the pool

The pool to be built in White Salmon will be a multi lane pool that can be used for recreational swimming, family swimming, water safety training, swim lessons, water aerobics, swim teams and just plain fun. There will be, initially, a bath house/changing room. Plans for future additions, when money has been raised, include a therapy pool, splash pad and community center for parties and events.

Our seniors and disabled members of the community need access to a pool for physical therapy. The proposed pool will meet this need.

Joining the Pool Metropolitan Park District would give residents of Trout Lake all the benefits of membership in the Pool District.

The new pool, construction to start in 2026, will be located adjacent to the White Salmon high school and middle school grounds. This location is closer to Trout Lake than the current option, the Hood River pool. Members of our community will significantly benefit from a pool that is closer to Trout Lake. The journey to the Hood River pool has costs: gas burned, tolls paid, time spent, and of out-of-district admission fees that will be eliminated when going to the White Salmon Pool.

## Argument Against

### Don't let yourself get taxed to subsidize White Salmon's pool and your neighbor's pastimes

This measure forces you to pay larger property taxes for annual operating expenses of a proposed community pool that is a 45-mile/1hour round trip away.

#### WSVPMPD:

- operated their old pool for years without taxing Trout Lake property owners.
- has yet to secure the “*estimated*” \$8.4m capital needed to build the pool, which has ballooned from their original 2018 “*estimate*” of \$2m, and they have visions of additional phases too!
- cannot legally cover the pool without paying-off undisclosed state grants forbidding them, that is unless taxpayers pay them off too.
- is short of their “*estimated*” annual operating budget and wants to expand their tax base boundaries into Trout Lake to pay for “*their*” pool.

Comparing 2025 in-district versus out-of-district published fee schedules from The Dalles and Hood River pools, the math makes no sense to let yourself get taxed, even if you and your family would regularly use the pool. Examples:

- Hood River and The Dalles out-of-district admission fees are only \$1/day and \$2/day higher than in-district fees for individuals. This means you would have to use the pool 25 or more times in the 3 to 4 months the pool will be open to breakeven on the proposed tax burden.
- The Dalles out-of-district fees for individual and family season passes are only \$30 and \$40 higher than in-district, which is less than the amount you'd be taxed to be in-district via this measure!

---

### Rebuttal of argument for

WSVPMPD's emotional taxation pitch does not add-up.

Hood River and The Dalles out of district pool usage rates are very small. Unless you use the pool more than twice every week during the 3-4 months it is open, you'll pay more in taxes to be in-district. This applies to seniors and the disabled too.

Vote “NO” to block paying even more personal property tax that subsidizes the interests of a few people from Trout Lake.

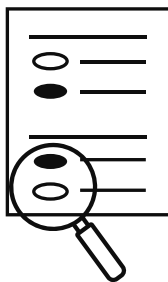
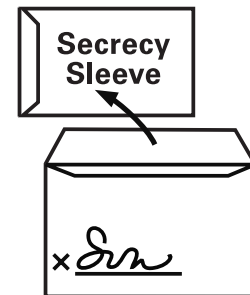
## Your signature is verified

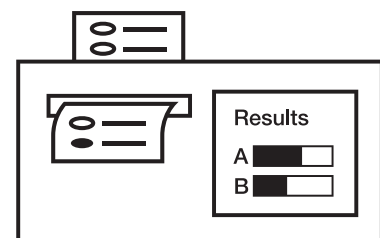
## Your ballot is reviewed and scanned

## Complete Text

### Senate Joint Resolution No. 8201

BE IT RESOLVED, BY THE SENATE AND HOUSE OF REPRESENTATIVES OF THE STATE OF WASHINGTON, IN LEGISLATIVE SESSION ASSEMBLED:

THAT, At the next general election to be held in this state the secretary of state shall submit to the qualified voters of the state for their approval and ratification, or rejection, an amendment to Article XXIX, section 1 of the Constitution of the state of Washington to read as follows:

Article XXIX, section 1. Notwithstanding the provisions of sections 5, and 7 of Article VIII and section 9 of Article XII or any other section or article of the Constitution of the state of Washington, the moneys of any public pension or retirement fund, industrial insurance trust fund, ~~((or))~~ fund held in trust for the benefit of persons with developmental disabilities, or fund to provide for long-term care services and supports for eligible seniors and

people with disabilities may be invested as authorized by law. Investment income from a fund to provide for long-term care services and supports for eligible seniors and people with disabilities is dedicated to long-term services and supports for program beneficiaries.

BE IT FURTHER RESOLVED, That this amendment is a single amendment within the meaning of Article XXIII, section 1 of the state Constitution.

The legislature finds that the changes contained in this amendment constitute a single integrated plan for the fund to provide long-term care services and supports for eligible seniors and people with disabilities. If this amendment is held to be separate amendments, this joint resolution is void in its entirety and is of no further force and effect.

BE IT FURTHER RESOLVED, That the legislature, pursuant to its authority under RCW 29A.36.020(3), specifies the ballot title and concise description shall read "The legislature has proposed a constitutional amendment on allowing money in Washington's long-term care fund to be invested. This amendment would allow the state fund dedicated to providing long-term care benefits for eligible seniors and people with disabilities to be invested as authorized by law.

Should this constitutional amendment be:

BE IT FURTHER RESOLVED, That the secretary of state shall cause notice of this constitutional amendment to be published at least four times during the four weeks next preceding the election in every legal newspaper in the state.

- You meet with a Certified Advocate who can assist with threat assessment, safety planning, and the program application.
- The best time to enroll is when you move or are planning to move to a location that is unknown to the offender and undocumented in public record.

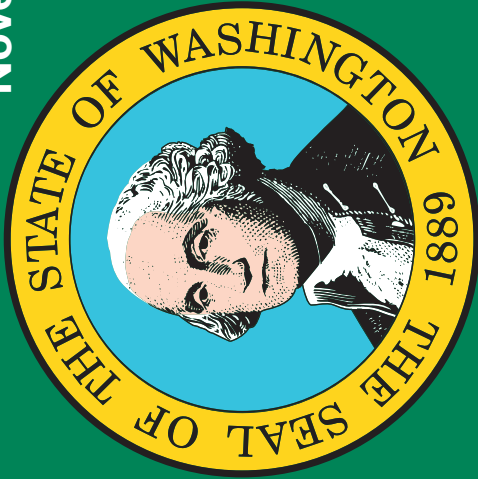
