I am pleased to present the 2025 General Election Voters' Pamphlet on behalf of the Office of the Secretary of State. This comprehensive guide to the candidates and measures on your ballot can help you find the information you need to cast your vote.

Elections that are accessible, secure, and transparent are the cornerstone of our democracy, providing you with the opportunity to make your voice heard on a variety of issues. This general election, you have the chance to help decide who represents your local community and weigh in on measures that affect daily life in Washington. It all starts with making sure you're registered to vote. Online and mail-in voter registrations and updates must be received by Monday, Oct. 27. In-person registration is also available at your local county elections office until 8 p.m. on Election Day, Nov. 4. If you're already registered to vote, now is a great time to sign into VoteWA and verify your voter registration information is up to date.

Once you receive and vote your ballot, make sure you sign the return envelope. Highly trained elections officials compare your signature to the one on your voter registration before your ballot can be counted. Then, return your ballot. If you vote by U.S. mail — no stamp needed — remember that ballots must be postmarked by Election Day to be counted. The USPS recommends mailing a week before Election Day to ensure your ballot is received on time. Or, return your ballot to one of the many secure ballot drop boxes across the state by 8 p.m. on Election Day. You can track the status of your ballot at [VoteWA.gov](https://VoteWA.gov) after returning it. Sign up for text notifications so you'll know when your ballot is received and accepted.

Exercising your right to vote is one of the most powerful ways you can make a difference in your community. Thank you for voting and supporting democracy here in Washington.

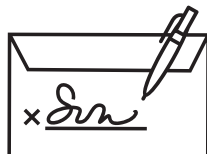

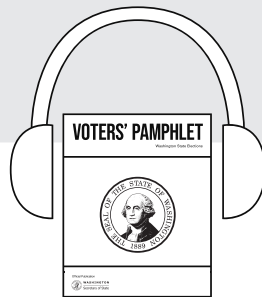

## How do I register to vote?

## Registration deadlines



**By mail or online:**

Your application must be received no later than October 27.

**In person:** Visit a local voting center no later than 8 p.m. on November 4.

## Qualifications

To vote, you must be at least 18 years old, a U.S. citizen, a resident of Washington, and not currently serving a sentence of total confinement in prison for a felony.



## What if I'm not 18 yet?

**If you are 16 or 17, become a Future Voter!**

Sign up with your Washington state driver's license, permit, ID, or the last four digits of your Social Security number. You'll be automatically registered to vote when you qualify.

## Past felony conviction?

Get registered to vote.

Washington now restores voting rights to citizens with felony convictions immediately upon release from prison.

You must **re-register** to vote to receive a ballot.



## Moved? Update your voting address

Contact a county elections office to request a ballot at your new address.

**By October 27:** Have your application received by mail or updated online.

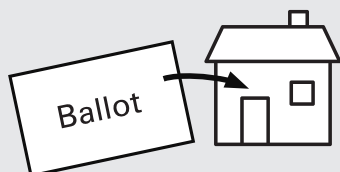

## How do I vote and return my ballot?

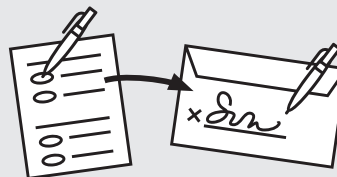

If you're registered to vote, there is no need to request a ballot. Your ballot will be mailed by **October 17** to the address you provided on your voter registration. If you need a replacement ballot, contact a county elections office listed at the end of this pamphlet.



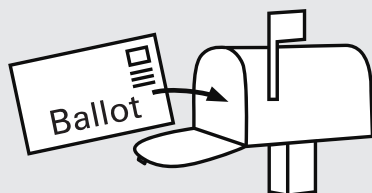

Vote your ballot and sign your return envelope. We need your signature to accept your ballot. You are not required to vote every race on your ballot. We encourage using this pamphlet to help you decide.



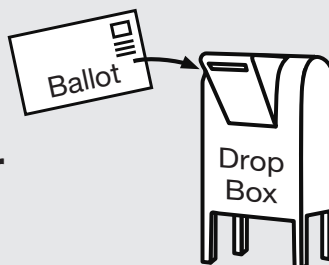

Return your ballot by mail, no stamp needed. If mailed, your ballot must be postmarked by **November 4**. Don't let a late postmark disqualify your ballot. The USPS recommends that you mail a week before Election Day.



Or, return your ballot to an official ballot drop box. Drop boxes are open until 8 p.m. on **November 4**. Find drop box locations at **VoteWA.gov**.

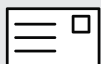

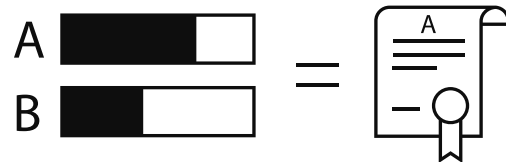

## Fiscal Impact Statement

Not required by law

This Amendment would allow funds in the Long-Term Services and Supports Trust Account to be invested in stocks of private companies, if authorized by law. Investment income from the Trust Account could only be used for long-term care services and supports for program beneficiaries, including for seniors and people with disabilities.

## Argument for

### Approve 8201 to guarantee long-term care funds are there when we need them

8201 requires 100% of investment income earned by the state's Long-Term Care Trust Fund to be spent on long-term care services for vulnerable seniors and disabled people. Washingtonians want to live with dignity as they age. 8201 supports this shared goal, strengthening the benefit's Trust Fund to help seniors and disabled Washingtonians while protecting taxpayers.

### 8201 is a commonsense measure that ensures tax dollars go further

Current law limits investment of the Trust Fund to only low-return choices, like government bonds and savings certificates. 8201 allows the Trust Fund to be invested to produce higher returns. This proven method would be managed by the independent, nonpartisan Washington State Investment Board, which is bound by the highest fiduciary standards.

### Approve 8201 to increase funding without impacting taxpayers

8201 is projected to grow the Trust Fund by \$67 billion over the next 50 years, money that can be used to increase benefits for people with disabilities and seniors without costing taxpayers a penny. Higher earnings mean more money for care – good for seniors, disabled Washingtonians, their families, and taxpayers!

### 8201 has overwhelming bipartisan support across the political spectrum

It's encouraging when leaders of both parties agree on something – and a supermajority of Democratic and Republican lawmakers approved this commonsense approach. 8201 is supported by nurses, unions, businesses, and groups representing millions of Washingtonian seniors and people with pre-existing conditions. *Vote Approve!*

## Rebuttal of argument against

Fact: Since 1981 the independent Washington State Investment Board has *safely and effectively* managed over \$200 billion for pensions, college savings funds, and more, with an average growth rate of 8% yearly. We must ensure our Long-Term Care Trust Fund grows to *keep up with rising costs while protecting taxpayers*. A bipartisan supermajority of lawmakers approved this measure. *Approve 8201* so WA's Trust Fund is *there for aging seniors and people with disabilities*.

## Argument against

### Reject this constitutional change, *again*.

Washington voters already rejected this proposal to take taxpayer money and invest in private stocks and corporations (2020, SJR8212). Our state founders protected public funds from risky investments by establishing safeguards in our state Constitution prohibiting corporate stock market investments of your tax dollars.

### Reject constitutional changes that gamble your money in an unstable market.

SJR 8201 overturns safeguards for the Long Term Services and Support (LTSS) fund, a multibillion dollar program established in 2020. Washingtonians are not yet eligible to access program benefits but proponents are *again* asking you to remove a key Constitutional protection. Currently, it's safeguarded in *secured* investments like federal, state and municipal bonds, which support our communities -- *a better use of our tax dollars*. Stock markets and private investments fluctuate greatly, *with no guarantees*, and the benefit needs are unknown in this untested program. This LTSS fund exists to help Washingtonians access long term care as we age or face disability. *When market speculation falls short, taxpayers and beneficiaries would pay the price through reduced benefits or increased taxes*.

### Rejecting constitutional changes provide more stability and certainty.

Continuing to invest our public money into federal, state and municipal bonds supports public works that we all depend on. Rejecting SJR 8201 provides for better planning and stability.

### Reject SJR 8201

Our state and LTSS need fiscal responsibility, not financial roulette. Reject SJR 8201 to keep the fund secure, stable, and focused on serving the people who will depend on it.

## Rebuttal of argument for

Proponents imply a guaranteed return of \$\$billions over 50 years but of course, that's not guaranteed. In 2008 the State Investment Board lost -26.2% and 2022 lost -12.9%. It's how the stock market works. In future recessions or market crashes, when returns fall short, benefits must be cut or tax rates must go up. Compared to *guaranteed* municipal bond returns of 3-5%, the choice is clear. Invest in ourselves, not Wall Street. *Reject SJR 8201*.

Dear Asotin County Voters,

Your General Election ballot will be mailed by October 17, 2025, and should arrive a few days later. For your ballot to be counted, you must sign your yellow envelope with a verifiable signature, or if you are unable to sign please mark an X witnessed by two people who must also sign the envelope. Power of Attorney is not valid for voting purposes. Your ballot must be received in any one of our drop boxes before 8:00 p.m. on Election Day or postmarked no later than Tuesday, November 4, 2025. Please return ballots as soon as possible.

Ballot drop boxes are located in the alley behind City Hall in downtown Clarkston, in the parking lot behind Lincoln Middle School and in the Clarkston Heights, and in the Asotin County Courthouse. Stamps are no longer required to mail your ballot.

**ASOTIN COUNTY, WASHINGTON****PROPOSITION NO. 1****A ONE-TENTH OF ONE CENT SALES AND  
USE TAX FOR COSTS OF EMERGENCY  
COMMUNICATIONS IN ASOTIN COUNTY**

The Asotin County Board of Commissioners adopted Resolution No. 25-29 proposing a sales and use tax. This measure will impose a sales and use tax in the amount of one-tenth of one cent; and, provide that all funds generated by the tax will be dedicated 100% to costs to finance, design, acquire, construct, equip, operate, maintain, remodel, repair, reequip, or improve emergency communications systems and facilities for Asotin County. All revenues shall be distributed to Asotin County Emergency Communications.

**Explanatory Statement**

Asotin County relies on a system of radio, telephone, and computer network components to facilitate emergency communications between the public, 911 dispatch, and first responders. Currently the costs associated with maintaining and upgrading this equipment are funded through various funds from the County, Cities and Fire District. These costs are projected to increase, while revenue is projected to decrease.

Chapter 82.14.420 RCW allows the County to propose a sales tax, of up to two-tenths of one percent specifically to fund emergency communications. Having reviewed current costs and projected revenues it was determined by the Communications Advisory Committee that a rate of one-tenth will meet our current needs, generating approximately \$500,000 annually. This will give the county dedicated funds to maintain and improve aging communications infrastructure.

If approved, these funds will be used exclusively to fund the financing, design, acquisition, construction, equipping, operating, maintaining, remodeling, repairing, reequipping, and improvement of emergency communication systems and facilities for the benefit of the county, cities, fire districts, and citizens of Asotin County.

## Resolution No. 25-29

### A RESOLUTION FOR PROPOSING A ONE-TENTH OF ONE PERCENT SALES AND USE TAX FOR THE COSTS OF EMERGENCY COMMUNICATIONS IN ASOTIN COUNTY

**WHEREAS**, The County Legislative Authority is authorized by RCW 82.14.420 to impose a sales and use tax not to exceed a rate of two-tenths of one percent to provide funds for costs associated with the financing, design, acquisition, construction, equipping, operating, maintaining, remodeling, repairing, reequipping, and improvement of emergency communication systems and facilities, if approved by the voters in the county; and,

**WHEREAS**, the public safety agencies in Asotin County including: Asotin Fire Department, Asotin Police Department, Asotin County Sheriff's Office, Asotin County Fire Protection District #1, Blue Mountain Fire Protection District #1, Clarkston Fire Department, and Clarkston Police Department all rely on Asotin County's radio system as the primary means for transmitting mission-critical communications between emergency responders; and,

**WHEREAS**, Asotin County's emergency communications systems are absolutely essential for the safety of Asotin County residents, visitors, and emergency services personnel; and,

**WHEREAS**, the existing radio communication system and infrastructure is failing to provide reliable emergency communications in all areas of Asotin County putting the public, first responders, and property at risk; and,

**WHEREAS**, existing funding mechanisms for Asotin County emergency communications are not adequate to support capital improvements required to provide reliable emergency communication in Asotin County; and,

**WHEREAS**, based in part on the recommendation of the Asotin County Emergency Communications Advisory Committee, the Board finds that it is in the best interest of the citizens of Asotin County and necessary of public health, safety, and welfare that a sales and use tax in the amount of one-tenth of one percent be imposed; and, one hundred percent (100%) of the monies that would be generated by such tax shall be specifically used to fund Emergency Communications in Asotin County in accordance with RCW 82.14.420;

**THEREFORE, BE IT RESOLVED**, by the Board of County Commissioners of Asotin County, Washington, as provided for in RCW 82.14.420, that the Board does hereby authorize the Clerk of the Board to certify a copy of this resolution to the Asotin County Auditor no later than August 31, 2025 and to perform such other duties

as may be necessary or required by law to place the proposition described herein on the ballot at the election to held on November 4, 2025; and,

**BE IT FURTHER RESOLVED**, that the Board of County Commissioners does hereby direct the Prosecuting Attorney to prepare a Ballot Title, as provided by law, in substantially the same format as set forth below.

### PROPOSITION 1

#### ASOTIN COUNTY

#### A ONE-TENTH OF ONE CENT SALES AND USE TAX FOR COSTS OF EMERGENCY COMMUNICATIONS IN ASOTIN COUNTY

The Asotin County Board of Commissioners adopted Resolution No. 25-\_\_\_\_ proposing a sales and use tax. This measure will impose a sales and use tax in the amount of one-tenth of one cent; and, provide that all funds generated by the tax will be dedicated 100% to costs to finance, design, acquire, construct, equip, operate, maintain, remodel, repair, reequip, or improve emergency communications systems and facilities for Asotin County. All revenues shall be distributed to Asotin County Emergency Communications.

## Explanatory Statement

If approved by the voters, Asotin County Rural Library District (ACL) will be authorized to restore its property tax levy to \$0.50 per thousand dollars of assessed value in 2026. Tax limitations since the last ACL levy in 2009 have reduced the effective levy rate to approximately \$0.40 per thousand dollars.

## Resolution No. 2025-01

**A RESOLUTION OF THE ASOTIN COUNTY RURAL LIBRARY DISTRICT, ASOTIN COUNTY, WASHINGTON, FINDING A SUBSTANTIAL NEED AND CALLING FOR A SPECIAL ELECTION IN ORDER TO SUBMIT TO THE QUALIFIED ELECTORS OF THE DISTRICT THE PROPOSITION OF WHETHER OR NOT THE DISTRICT SHALL LEVY REGULAR PROPERTY TAXES IN EXCESS OF THE LEVY LIMITATION PROVIDED FOR IN RCW 84.55.0101 FOR MAINTENANCE AND OPERATION PURPOSES, AND PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO.**

BE IT RESOLVED BY THE BOARD OF TRUSTEES OF ASOTIN COUNTY RURAL LIBRARY DISTRICT, ASOTIN COUNTY, WASHINGTON, as follows:

WHEREAS, Asotin County Rural Library District, Asotin County, Washington (the "District"), is a library district duly organized and existing under and by the virtue of the constitution and laws of the State of Washington; and

WHEREAS, pursuant to RCW 84.55.050, the District may levy a regular property tax in excess of the levy limitation named contained in RCW 84.55.0101, when such levy amount is authorized by a proposition approved by a majority of the voters of the District voting on the proposition at a general or special election held within the District; and

WHEREAS, there is a substantial need to provide continued funding for the normal maintenance and operation of the District, and it is deemed necessary for the District to continue its regular levy rate at \$0.50 per thousand dollars of assessed value upon all the taxable property within the District in 2025 for collection in 2026, thus increasing its regular property tax levy in excess of the limit factor provided for in RCW 84.55.0101; and thereafter using such levy to compute limitations for subsequent years; and

WHEREAS, the Board of Trustees of the District (the "Board") deems it necessary to place the proposition of whether or not the District shall levy regular property taxes in 2025, for collection in 2026, in excess of the limit factor provided for in RCW 84.55.0101 before the qualified electors of the District; and

WHEREAS, it is further deemed advisable that said propositions be submitted to such electors at an election to be held within the District on November 4th, 2025.

NOW THEREFORE, IT IS HEREBY FOUND, DETERMINED AND ORDERED as follows:

*Section 1:* The Board hereby finds and declares that, there is a substantial need to provide for continued funding for the normal maintenance and operation of the Asotin County Library system, and it is necessary for the District to continue its regular levy rate at \$0.50 per thousand of assessed value upon all the taxable property within the District in 2025, for collection in 2026, thus increasing its regular property tax levy in excess of the limit factor provided for in RCW 84.55.0101, and thereafter using such levy to compute limitations for subsequent years.

*Section 2:* The Board hereby finds and declares that the welfare of the residents of the District requires the Board to submit to the voters of the District, for their approval or rejection, the proposition of whether or not the District shall continue its regular levy rate at \$0.50 per thousand of assessed value upon all the taxable property within the District in 2025, for

collection in 2026, thus increasing its regular property tax levy in excess of the limit factor provided for in RCW 84.55.0101, in order to provide for continued funding for the normal maintenance and operation of the Asotin County Rural Library District; and upon the approving vote of the majority of the voters of the District voting on such proposition, the District shall be authorized to do so.

*Section 3:* Upon approval of said proposition, the District may issue warrants against the general fund for District purposes.

*Section 4:* The Board hereby finds and declares that an emergency exists requiring submission to the voters of the District at a special election to be held on November 4th, 2025 the proposition of whether or not the District shall continue its regular levy rate at \$0.50 per thousand dollars of assessed value upon all the taxable property within the District in 2025, for collection in 2026, thus increasing its regular property tax levy in excess of the limit factor provided for in RCW 84.55.0101, in order to provide continued funding for the normal maintenance and operation of the Asotin County Rural Library District.

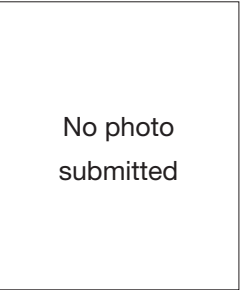

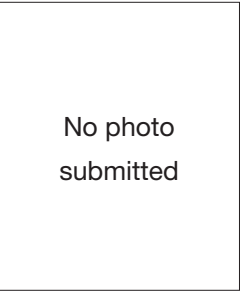

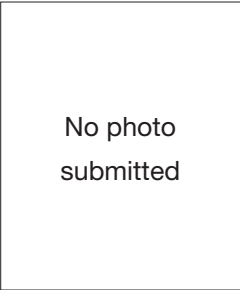

**WHEREAS**, the City Council of the City of Clarkston Ordinance No. 1525 passed on May 27, 2014, establishes boundaries for the Clarkston Transportation Benefit District (TBD) which are coterminous with the boundaries of the City of Clarkston city limits; and

**WHEREAS**, the necessary transportation improvement projects are identified in the City of Clarkston's Six-Year Transportation Improvement Plan; and

**WHEREAS**, additional necessary transportation improvement projects are identified in the Regional Transportation Plan for the Lewis-Clark Valley Metropolitan Organization; and

**WHEREAS**, City of Clarkston Ordinance No. 1525 passed on May 27, 2014, provides that funds generated by the Clarkston TBD shall be used for transportation improvements that preserve, maintain and operate the planned and/or existing transportation infrastructure of the City, consistent with the requirements of RCW 36.73; and

**WHEREAS**, RCW 36.73.040(3)(a) authorizes transportation benefit districts to impose a sales and use tax in accordance with RCW 82.14.0455 in an amount not exceeding two-tenths of one percent (0.2%) for a period of ten years upon a favorable vote of the qualified electors within the City for the purpose of financing certain transportation improvements; and

**WHEREAS**, City of Clarkston TBD adopted Ord. No. TBD-002 on September 8, 2014, which imposed a \$20 vehicle license fee and began collecting that fee April 1, 2015, but has identified a sales and use tax imposed in accordance with RCW 82.14.0455 as a fairer funding source; and

**WHEREAS**, if approved by the voters, a sales and use tax will be used for the purpose of acquiring, investing in, constructing, improving, providing, operating, preserving, maintaining and/or funding transportation improvements within the City of Clarkston Transportation Benefit District, a.k.a. the City of Clarkston City Limits; and

**WHEREAS**, if approved by the voters, a sales and use tax will apply to people who shop and thereby use streets and roadways in the City of Clarkston and not just to City residents; and



**WHEREAS**, if approved by the voters, revenues from a sales and use tax will be used entirely for transportation improvements in the City of Clarkston Transportation Benefit District; and

**WHEREAS**, the City Council of the City of Clarkston TBD has considered this matter during a duly called public meeting of said City Council, has given this matter careful review and consideration, and finds that good government and the best interests of the City of Clarkston TBD will be served by the passage of this resolution,

**NOW, THEREFORE**, the City Council of the City of Clarkston Transportation Benefit District does resolve as follows:

**Section 1: Purpose.** The City Council of the City of Clarkston TBD finds that it is in the best interests of the City to submit to the qualified voters of the City, at a special election to be held on November 4, 2025, a proposition authorizing the Clarkston TBD to impose a sales and use tax of two-tenths of one percent (.002) pursuant to sections 36.73.040(3)(a), 36.73.065(1) and 82.14.0455 of the Revised Code of Washington for the purpose of raising revenue to acquire, invest in, construct, improve, provide, operate, maintain, and/or fund transportation improvements in the City, and to impose such sales and use tax if approved by an affirmative vote of a majority of the City voters voting at the election.

**Section 2: Description of transportation improvements.** The revenues from a sales and use tax may be used to acquire, invest in, construct, improve, provide, operate, preserve, maintain and/or fund the following described transportation improvements:

- A. Projects in the City identified in the City of Clarkston Comprehensive Transportation Program, also known as the City of Clarkston's Six-Year Transportation Improvement Plan;
- B. Projects in the City identified in the Regional Transportation Plan for the Lewis-Clark Valley Metropolitan Organization;
- C. Projects in the City identified in the Washington Transportation Plan adopted by the Washington Transportation Commission;
- D. Expanded projects identified in accordance with section 36.73.050(2)(b) of the Revised Code of Washington, as amended; and/or
- E. Projects changed in accordance with the material change policy of the Clarkston TBD adopted in accordance with section 36.73.160 of the Revised Code of Washington, as amended.

The cost of all construction, maintenance, preservation, operation, design, engineering, construction management, financial, legal, and other consulting services, inspection and testing, administrative and relocation expenses, and other costs incurred in connection with the foregoing described transportation benefit district projects shall be deemed to be a part of the transportation improvements.

**Section 3: Sales and use tax.** If approved by a majority of voters voting at the election, the City Council of the City of Clarkston TBD shall fix and impose a sales and use tax as authorized by sections 36.73.040(3)(a), 36.73.065(1) and 82.14.0455 of the Revised Code of Washington upon taxable events at the rate of two-tenths of one percent (.002) of the selling price (in the case of sales tax) and the value of the article used (in the case of use tax) for purpose of acquiring, investing in, constructing, improving, providing, operating, preserving,

maintaining and/or funding the foregoing transportation improvements described in Section 2 herein. The sales and use tax may be used to pay for indebtedness incurred by Clarkston TBD in accordance with the requirements of chapter 36.73 RCW to acquire, invest in, construct, improve, provide, operate, preserve, maintain and/or fund the foregoing transportation improvements described in Section 2 herein.

The sales and use tax shall be imposed for a period not exceeding ten (10) years. **WHEREAS**, the City of Clarkston has established and operates an ambulance service providing emergency medical services and ambulance transport to the residents of the City of Clarkston; and

**WHEREAS**, the City portion of the cost of said Ambulance services for 2026 is anticipated to be \$1,539,465.00; and

**WHEREAS**, if the Ambulance is discontinued, the City will be unable to meet its obligations to IAFF #2299, a labor contract; and

**WHEREAS**, RCW 84.52.052 AUTHORIZES AN EXCESS PROPERTY TAX LEVY TO SUPPORT OBLIGATIONS OF

CONTRACT AND FOR OTHER PURPOSES UPON VOTER APPROVAL; and

**WHEREAS**, the lack of emergency medical services care to the residents of the City of Clarkston constitutes an emergency dealing with health and welfare of the citizens of the City;

**NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF CLARKSTON IN REGULAR MEETING ASSEMBLED AS FOLLOWS:**

**SECTION 1.0**

That a special election is to be held in the City of Clarkston, State of Washington, on November 4, 2025, in conjunction with the state general election to be held on the same date. This election is for the purpose of submitting an excess levy proposition as authorized by RCW 84.52.052 in the amount of \$1,539,465.00 to the electors of said City for their approval or rejection, the proceeds thereof be placed in the Ambulance/ EMS Fund of the City to be used for the maintenance and operation of the Ambulance Service.

**SECTION 2.0**

Proposition: Shall the City of Clarkston, Washington, authorize the County Commissioners of Asotin County to levy in the year 2026 as part of the ad valorem real property taxes to be collected for the City in 2026 the sum of \$1,539,465.00, which will require a rate of approximately \$2.645 per thousand dollars of assessed valuation of the aforesaid City based upon the assessment ratio of 100 percent of true and fair value. 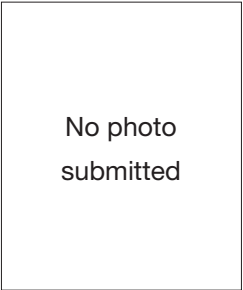

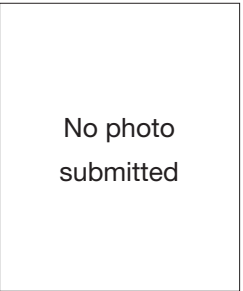

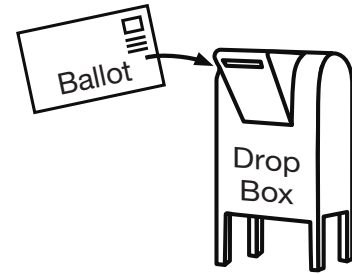

## Your county receives your ballot

Deposit your ballot in an official drop box by 8 p.m. on Election Day, or return your ballot by mail — postage paid — but make sure it's postmarked by Election Day! Don't let a late postmark disqualify your ballot. The USPS recommends that you mail it back at least one week before Election Day.



Election staff will contact you before your ballot is processed if:

- Your signature is missing
- Your signature doesn't match your voter registration record

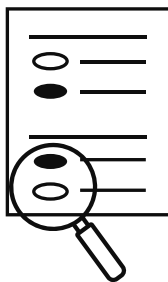
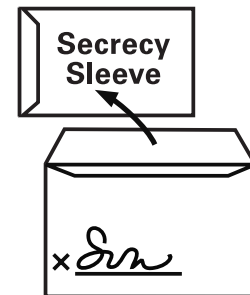
## Your signature is verified

Your signature is important and we need it to accept your ballot. The signature on your return envelope is compared to the signature on your voter registration record. If the signature matches, your ballot is accepted and you are credited for voting to ensure **only one** ballot is counted for you.

## Envelopes and sleeves are separated

The return envelope is opened and the secrecy sleeve containing your ballot is removed. They are separated to ensure the secrecy of your vote.

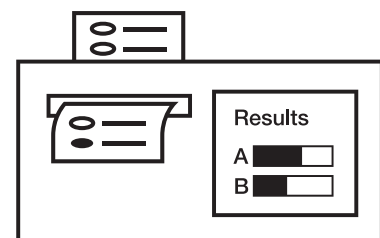
## Your ballot is reviewed and scanned

The ballot is removed from the secrecy sleeve and election staff verify that it can be successfully scanned. Each voting system is certified and tested before every election.

## Your ballot is counted

After 8 p.m. on Election Day all scanned ballots are tallied. Ballots will be scanned and tallied over the next several days until all the votes are counted. Every county conducts a post-election audit.



## Before an Election

### Voting systems certification and testing



Ballot counting equipment is tested and certified by an independent testing authority and the State of Washington.

Voting systems are not connected to the internet.

### Pre-election audit: logic & accuracy tests

Before every election, counties test their voting systems to make sure the machines are correctly set up and accurately counting votes.

### Voter registration database

Washington's statewide voter registration database is constantly maintained and updated as voters become registered, move, change their name, pass away, or are no longer eligible to vote.

All eligible voters are automatically mailed ballots. Only one ballot per voter is accepted.

## During an Election

### Paper ballots



Voting on paper ballots allows election officials to audit results of an election after votes are counted.

### Signature verification

Trained election officials compare your signature to your voter registration file to confirm your identity and eligibility.

If your signature is missing or doesn't match, your ballot is "Challenged" and you are notified. Once your signature is verified, your ballot status will update to "Accepted".

### VoteWA

Check the status of your ballot at [VoteWA.gov](https://VoteWA.gov). Once your ballot status is updated to "Accepted," your ballot will be opened and scanned. Only one ballot per voter is accepted.

### Chain of custody

Ballots are sealed in secure, tamper-evident containers and at least two staff are present whenever your ballot is handled.

### Scanning and tabulation

Ballot scanners and vote counting machines are physically secured in locked rooms. Election staff sign in and out each time the room is opened, and always in groups of two or more.

## After an Election

### Random batch audits



Your local election officials hand count randomly selected precincts or ballot batches and compare those numbers to the voting system totals to make sure the vote counting machines counted correctly.

### Random ballot audits

Your local election officials examine a statistically significant, randomly selected sample of ballots to help ensure the reported outcome is correct.

### Full ballot reconciliation

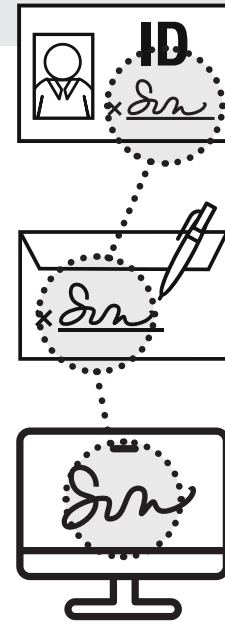
Your local election officials keep detailed records of the steps taken to process each ballot or group of ballots, creating an audit trail.

A final report at the end of the process includes a summary of the ballots received and counted.

## Why is my signature important?

### Your signature is needed to make sure your ballot gets counted.

- The signature on your return envelope is compared to the signature on your voter registration record. Trained election officials are responsible for verifying each and every signature.
- If your signature is missing or does not match your voter registration record, the county elections office will contact you by mail **before results are certified**. They may call or email if you gave them this info.
- If you registered to vote online or through Department of Licensing, the signature from your driver's license, permit, or state ID will be on your voter registration record.
- Voters can track and check their ballot status at **VoteWA.gov**.



## How do I know if something is true?

When reviewing online or printed information, think about:

- Who made this, and who is it for?
- Why did they make it?
- When was this made?
- What makes it believable?
- How might other people read this message?
- Ask the experts — Get trusted info from your county auditor or elections office. Consult a fact-checking site or ask an official source.



## What does this mean?

**Certification Day**

The date when election results are finalized by state or county officials.

**Logic and Accuracy Test**

A test completed before each election to ensure the accuracy of voting equipment.

**Nonpartisan Office**

An elected position in which candidates do not state a political party preference and candidates for the office are not officially associated with a political group. Office appears on the ballot as “Nonpartisan.”

**Partisan Office**

An elected position in which candidates may state their preferred political party. A candidate may also choose “States No Party Preference.” Their preference is printed on the ballot.

**Postmark**

A postmark indicates the location and date the Postal Service accepted custody of a ballot. Ballots must be postmarked by Election Day to be accepted. Placing your ballot in a mailbox on Election Day does not guarantee a postmark of the same day.

**Post-election Audit**

A test completed before the certification of results to ensure the security and accuracy of the voting system. Counties perform a post-election audit each election.

**Term Type**

How much of a term a candidate will be serving for an office. It is split into regular, unexpired, and short-and-full.

**Voter Registration Database**

The official list of registered voters maintained in every state to conduct safe and secure elections. Our database in Washington is known as VoteWA.

**Voting Center**

A county-run facility where you can receive voting assistance from trained elections staff. Some services include registering or updating voter information, requesting and returning a ballot, or finding an accessible voting unit.

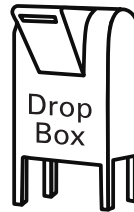
**Voting System**

Ballot counting equipment that must be tested by an independent testing authority and certified by the state of Washington before it can be used.

## Complete Text

### Senate Joint Resolution No. 8201

BE IT RESOLVED, BY THE SENATE AND HOUSE OF REPRESENTATIVES OF THE STATE OF WASHINGTON, IN LEGISLATIVE SESSION ASSEMBLED:

THAT, At the next general election to be held in this state the secretary of state shall submit to the qualified voters of the state for their approval and ratification, or rejection, an amendment to Article XXIX, section 1 of the Constitution of the state of Washington to read as follows:

Article XXIX, section 1. Notwithstanding the provisions of sections 5, and 7 of Article VIII and section 9 of Article XII or any other section or article of the Constitution of the state of Washington, the moneys of any public pension or retirement fund, industrial insurance trust fund, ~~((or))~~ fund held in trust for the benefit of persons with developmental disabilities, or fund to provide for long-term care services and supports for eligible seniors and

people with disabilities may be invested as authorized by law. Investment income from a fund to provide for long-term care services and supports for eligible seniors and people with disabilities is dedicated to long-term services and supports for program beneficiaries.

BE IT FURTHER RESOLVED, That this amendment is a single amendment within the meaning of Article XXIII, section 1 of the state Constitution.

The legislature finds that the changes contained in this amendment constitute a single integrated plan for the fund to provide long-term care services and supports for eligible seniors and people with disabilities. If this amendment is held to be separate amendments, this joint resolution is void in its entirety and is of no further force and effect.

BE IT FURTHER RESOLVED, That the legislature, pursuant to its authority under RCW 29A.36.020(3), specifies the ballot title and concise description shall read "The legislature has proposed a constitutional amendment on allowing money in Washington's long-term care fund to be invested. This amendment would allow the state fund dedicated to providing long-term care benefits for eligible seniors and people with disabilities to be invested as authorized by law.

Should this constitutional amendment be:

Approved.....

Rejected ....."

BE IT FURTHER RESOLVED, That the secretary of state shall cause notice of this constitutional amendment to be published at least four times during the four weeks next preceding the election in every legal newspaper in the state.

### Keep your voting address confidential

You may be able to enroll in the Address Confidentiality Program (ACP) and register as a Protected Records Voter if you are:

- A survivor of domestic violence, sexual assault, trafficking, stalking; or
- A criminal justice participant, election official, or protected health care worker who is a target for harassment.

To become a Protected Records Voter:

- You meet with a Certified Advocate who can assist with threat assessment, safety planning, and the program application.
- The best time to enroll is when you move or are planning to move to a location that is unknown to the offender and undocumented in public record.

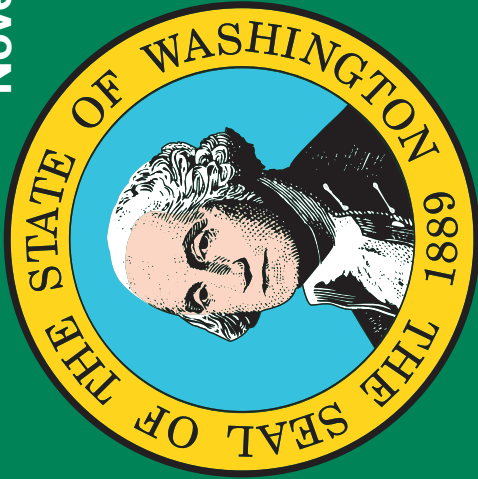
