I am pleased to present the 2025 General Election Voters' Pamphlet on behalf of the Office of the Secretary of State. This comprehensive guide to the candidates and measures on your ballot can help you find the information you need to cast your vote.

Elections that are accessible, secure, and transparent are the cornerstone of our democracy, providing you with the opportunity to make your voice heard on a variety of issues. This general election, you have the chance to help decide who represents your local community and weigh in on measures that affect daily life in Washington. It all starts with making sure you're registered to vote. Online and mail-in voter registrations and updates must be received by Monday, Oct. 27. In-person registration is also available at your local county elections office until 8 p.m. on Election Day, Nov. 4. If you're already registered to vote, now is a great time to sign into VoteWA and verify your voter registration information is up to date.

Once you receive and vote your ballot, make sure you sign the return envelope. Highly trained elections officials compare your signature to the one on your voter registration before your ballot can be counted. Then, return your ballot. If you vote by U.S. mail — no stamp needed — remember that ballots must be postmarked by Election Day to be counted. The USPS recommends mailing a week before Election Day to ensure your ballot is received on time. Or, return your ballot to one of the many secure ballot drop boxes across the state by 8 p.m. on Election Day. You can track the status of your ballot at VoteWA.gov after returning it. Sign up for text notifications so you'll know when your ballot is received and accepted.

Exercising your right to vote is one of the most powerful ways you can make a difference in your community. Thank you for voting and supporting democracy here in Washington.

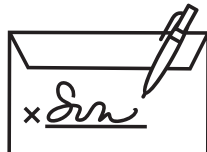

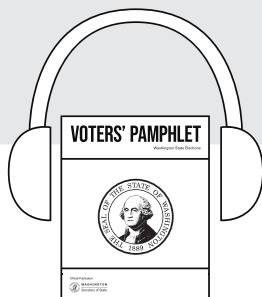

By mail: Request a paper form be mailed to you or print your own at **sos.wa.gov/elections**.

In person: Visit a county elections office (listed at the end of this pamphlet).

Registration deadlines



By mail or online:

Your application must be received no later than October 27.

In person: Visit a local voting center no later than 8 p.m. on November 4.

Check your registration info at **VoteWA.gov**.

Qualifications

To vote, you must be at least 18 years old, a U.S. citizen, a resident of Washington, and not currently serving a sentence of total confinement in prison for a felony.



What if I'm not 18 yet?

If you are 16 or 17, become a Future Voter!

Sign up with your Washington state driver's license, permit, ID, or the last four digits of your Social Security number. You'll be automatically registered to vote when you qualify.

Past felony conviction?

Get registered to vote.

Washington now restores voting rights to citizens with felony convictions immediately upon release from prison.

You must **re-register** to vote to receive a ballot.



Moved? Update your voting address

Contact a county elections office to request a ballot at your new address.

By October 27: Have your application received by mail or updated online.

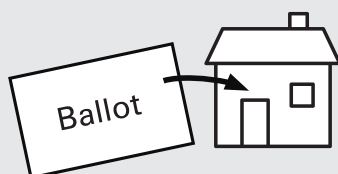

How do I vote and return my ballot?

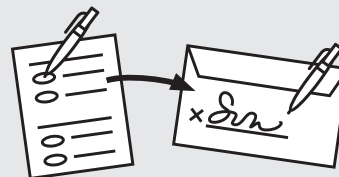

If you're registered to vote, there is no need to request a ballot. Your ballot will be mailed by **October 17** to the address you provided on your voter registration. If you need a replacement ballot, contact a county elections office listed at the end of this pamphlet.



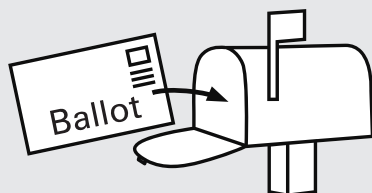

Vote your ballot and sign your return envelope. We need your signature to accept your ballot. You are not required to vote every race on your ballot. We encourage using this pamphlet to help you decide.



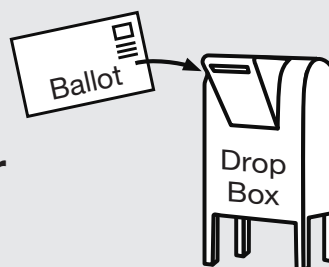

Return your ballot by mail, no stamp needed. If mailed, your ballot must be postmarked by **November 4**. Don't let a late postmark disqualify your ballot. The USPS recommends that you mail a week before Election Day.



Or, return your ballot to an official ballot drop box. Drop boxes are open until 8 p.m. on **November 4**. Find drop box locations at **VoteWA.gov**.

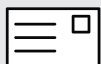

If you cannot personally return your ballot, only let people you trust deliver it for you.

Check the status of your ballot on **VoteWA.gov** to see if it has been received by your county elections office.



Election staff will contact you before your ballot is processed if:

- Your signature is missing
- Your signature doesn't match your voter registration record

After 8 p.m. on election night, tallied results from each county are posted at **results.vote.wa.gov**.

Results are updated as counties report and are unofficial until certification.

This amendment would allow the state fund dedicated to providing long-term care benefits for eligible seniors and people with disabilities to be invested as authorized by law.

Explanatory Statement

The Law As It Presently Exists

The Washington Constitution generally prohibits investing public money in stocks of private companies. This means that state funds can only be invested in fixed-income securities, such as government and corporate bonds and certificates of deposit.

The Constitution currently exempts several funds from this restriction. This exemption applies to any public pension or retirement fund, workers’ compensation funds, and money held in trust for the benefit of people with developmental disabilities, permitting those funds to be invested as authorized by law, including in stocks of private companies. The Washington State Investment Board invests and manages these funds.

In 2019, the legislature created a long-term care insurance program. The program provides money to pay for certain long-term care services, such as nursing home care, to program beneficiaries who need assistance with daily living. Under that law, employees pay premiums for long-term care insurance through a payroll deduction, and those premiums are deposited into a Long-Term Services and Supports Trust Account. Under the current provision of the Constitution, money held in the Trust Account cannot be invested in stocks of private companies.

The Effect of the Proposed Amendment if Approved

This Amendment would allow funds in the Long-Term Services and Supports Trust Account to be invested in stocks of private companies, if authorized by law. Investment income from the Trust Account could only be used for long-term care services and supports for program beneficiaries, including for seniors and people with disabilities.

Fiscal Impact Statement

Not required by law

Argument for

Approve 8201 to guarantee long-term care funds are there when we need them

8201 requires 100% of investment income earned by the state's Long-Term Care Trust Fund to be spent on long-term care services for vulnerable seniors and disabled people. Washingtonians want to live with dignity as they age. 8201 supports this shared goal, strengthening the benefit's Trust Fund to help seniors and disabled Washingtonians while protecting taxpayers.

8201 is a commonsense measure that ensures tax dollars go further

Current law limits investment of the Trust Fund to only low-return choices, like government bonds and savings certificates. 8201 allows the Trust Fund to be invested to produce higher returns. This proven method would be managed by the independent, nonpartisan Washington State Investment Board, which is bound by the highest fiduciary standards.

Approve 8201 to increase funding without impacting taxpayers

8201 is projected to grow the Trust Fund by \$67 billion over the next 50 years, money that can be used to increase benefits for people with disabilities and seniors without costing taxpayers a penny. Higher earnings mean more money for care – good for seniors, disabled Washingtonians, their families, and taxpayers!

8201 has overwhelming bipartisan support across the political spectrum

It's encouraging when leaders of both parties agree on something – and a supermajority of Democratic and Republican lawmakers approved this commonsense approach. 8201 is supported by nurses, unions, businesses, and groups representing millions of Washingtonian seniors and people with pre-existing conditions. *Vote Approve!*

Rebuttal of argument against

Fact: Since 1981 the independent Washington State Investment Board has *safely and effectively* managed over \$200 billion for pensions, college savings funds, and more, with an average growth rate of 8% yearly. We must ensure our Long-Term Care Trust Fund grows to *keep up with rising costs while protecting taxpayers*. A bipartisan supermajority of lawmakers approved this measure. *Approve 8201* so WA's Trust Fund is *there for aging seniors and people with disabilities*.

Argument against

Reject this constitutional change, *again*.

Washington voters already rejected this proposal to take taxpayer money and invest in private stocks and corporations (2020, SJR8212). Our state founders protected public funds from risky investments by establishing safeguards in our state Constitution prohibiting corporate stock market investments of your tax dollars.

Reject constitutional changes that gamble your money in an unstable market.

SJR 8201 overturns safeguards for the Long Term Services and Support (LTSS) fund, a multibillion dollar program established in 2020. Washingtonians are not yet eligible to access program benefits but proponents are *again* asking you to remove a key Constitutional protection. Currently, it's safeguarded in *secured* investments like federal, state and municipal bonds, which support our communities -- *a better use of our tax dollars*. Stock markets and private investments fluctuate greatly, *with no guarantees*, and the benefit needs are unknown in this untested program. This LTSS fund exists to help Washingtonians access long term care as we age or face disability. *When market speculation falls short, taxpayers and beneficiaries would pay the price through reduced benefits or increased taxes*.

Rejecting constitutional changes provide more stability and certainty.

Continuing to invest our public money into federal, state and municipal bonds supports public works that we all depend on. Rejecting SJR 8201 provides for better planning and stability.

Reject SJR 8201

Our state and LTSS need fiscal responsibility, not financial roulette. Reject SJR 8201 to keep the fund secure, stable, and focused on serving the people who will depend on it.

Rebuttal of argument for

Proponents imply a guaranteed return of \$\$billions over 50 years but of course, that's not guaranteed. In 2008 the State Investment Board lost -26.2% and 2022 lost -12.9%. It's how the stock market works. In future recessions or market crashes, when returns fall short, benefits must be cut or tax rates must go up. Compared to *guaranteed* municipal bond returns of 3-5%, the choice is clear. Invest in ourselves, not Wall Street. *Reject SJR 8201*.

Make Your Vote Count – Support Your Local Leaders and Return Your Ballot on Time!

Voting isn't just about big races, it's about choosing the people who lead our community every day. By voting for local officials like city council, port commissioner, hospital commissioner, school board director, fire commissioner, and others, you're helping shape decisions that directly affect your daily life—roads, schools, safety, and public services.



Your **General Election Voters' Pamphlet** includes important details about local candidates and state and local measures. Use it to make informed choices.

As the General Election approaches, we strongly encourage all Clallam County voters to make a plan and vote early. This helps ensure your ballot is received before the deadline and avoids any delivery delays.

The United States Postal Service recommends mailing your ballot at least **two weeks before Election Day** to help guarantee timely delivery. If you're mailing in your ballot, don't wait, send it as soon as possible!

Prefer not to mail it? Take advantage of the **8 Official Ballot Drop Boxes** placed throughout Clallam County—in areas like Port Angeles, Sequim, Forks, Clallam Bay, Neah Bay, Sekiu, and Carlsborg. These secure drop boxes are open **24/7**, are routinely collected by elections staff, and taken directly to the Elections Center. Using a drop box means **no postage is needed**, and your ballot goes straight into the system.

Your signature matters. Be sure to sign your Return Ballot Envelope. Each signature is compared to the one on your voter registration file. If it's missing or doesn't match, our office will notify you and give you a chance to correct it, so your vote is counted.

Thank you for being a Clallam County voter. Your vote is your voice. Your local leaders need to hear it!

To Register to Vote, You Must Be

- a citizen of the United States;
- a Washington State resident;
- at least 16 years old;
If you are 16 or 17, you can sign up as a Future Voter and be automatically registered to vote when you qualify.
- not disqualified from voting due to court order;
- not currently serving a sentence of total confinement under the jurisdiction of the department of corrections for a Washington felony conviction; and
- not currently incarcerated for a federal or out-of-state felony conviction.

17-Year-Old Voters

Washington State Legislation allows 17-year-olds who will be 18 by the November General Election to vote in the August Primary.



Sixteen- and seventeen-year-olds can also pre-register and will automatically be registered when they are eligible to vote.

Felony Conviction & Voting Rights

When is my right to vote restored?

- If you were convicted of a felony in Washington State, another state, or in federal court, your right to vote will be restored automatically as long as you are not currently serving a sentence of total confinement in prison.
- If you were convicted of a felony in another state or in federal court, your right to vote is restored automatically as long as you are not currently incarcerated for that felony.
- You **do not** lose the right to vote for a misdemeanor conviction or a conviction in juvenile court.

Registering to vote

Once your right to vote is restored, you must register to vote even if you were previously registered. You do not need a certificate of discharge to register to vote.

Accessible Voting



Clallam County voters with disabilities can request a reasonable accommodation or assistance to vote. Clallam County Elections is committed to ensuring accessibility

for our voters. For each Primary and Election we offer an Accessible Voting Unit (AVU) in order to provide you with the opportunity to vote independently and privately.

AVUs are available starting 20 days before Election Day, until 8:00 p.m. on Election Day. AVUs must be wheelchair-accessible and screened from other voters to maintain privacy. An AVU presents your ballot on a monitor. You select choices by touching the screen, using a select wheel, or by using a tool. You can use headphones to listen to the text and prompts on your ballot.

If you have trouble reading your ballot or filling bubbles, we have a ballot marking device in our office that can help you. Visit us or call to learn more. (360) 417-2221.

FAQs: What Should I Do?

My spouse/roommate signed my return envelope.

If someone has mistakenly signed your return ballot envelope, **draw a line through the incorrect signature and sign your name** directly above the correction.

I forgot to put my ballot in the Secrecy Sleeve and sealed my Return Envelope.

The Secrecy Sleeve is optional and not required.

I received a Signature Update Form stating my signature on my return ballot envelope did not match the signature on my voter registration record.

Promptly return the completed, signed Signature Update Form to our office via mail, email, in person, or by Official Ballot Drop Box (boxes will close promptly at 8:00 p.m. on Election Day). **Signature Update Forms can be returned until 4:30 p.m. the day before Certification, November 24, 2025.**

ACP Address Confidentiality Program

Washington State's Address Confidentiality Program (ACP) can help maintain the security of your home, work, or school address.

The ACP will:

- Provide you with a legal substitute address and forward your first-class mail to you.
- Help you register to vote without the records being available to the public.

To be eligible for the ACP you must:

- Be an adult, or parent/guardian acting on behalf of a minor(s); and
- Be a victim of a crime; and
- Reside in Washington State

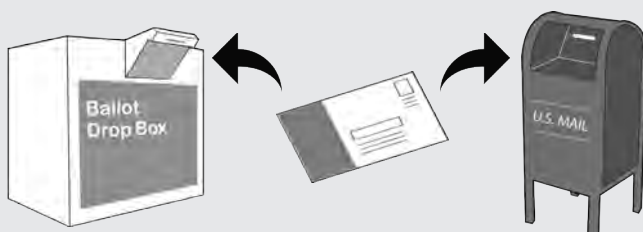
Sign, date and seal your return envelope.

Returning Your Ballot

By Official Ballot Drop Box

Drop Boxes are open 20 days before Election Day, 24 hours a day until 8:00 p.m. on Election Night.

Returning your ballot to a drop box reduces the cost of postage for the election.

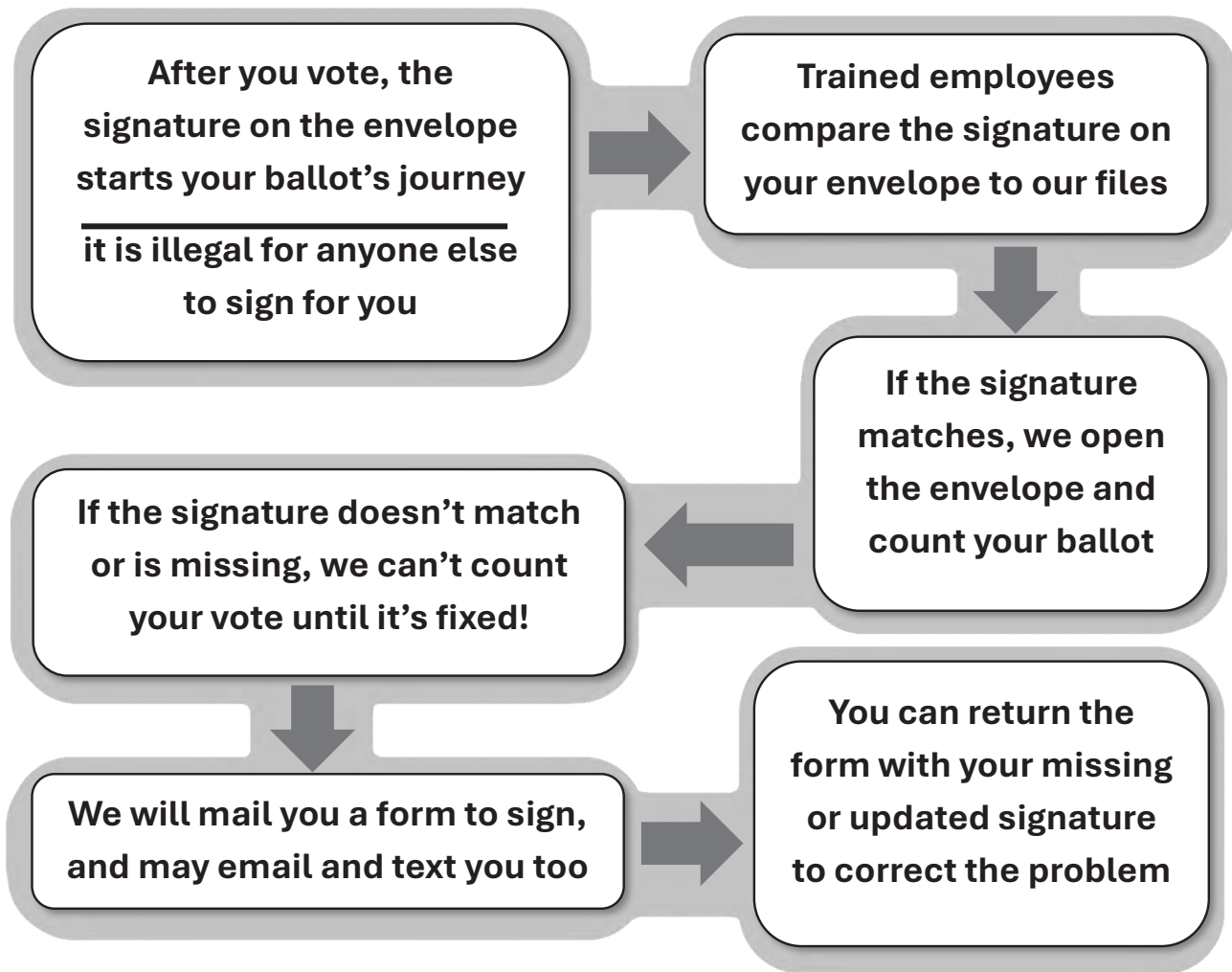

Charter Amendments

Clallam County is governed by a county charter. The Clallam County Charter has been in place since 1976. Clallam County is one of seven counties in the State of Washington to operate under a city charter. Other counties include Clark, King, Pierce, San Juan, Snohomish, and Whatcom.

What is a County Charter?

A charter serves as the organic law of the County establishing a basic set of rules for county government. Like the constitutions for the state and federal governments, the county charter establishes the form of county government and the branches, officers, and departments of county government. It defines their relationships and how they interact.

Changing the Charter

The Clallam County Charter can only be changed by a vote of the people. A Charter Review Commission is formed every five years to review the charter and suggest changes to the voters. Changes can also be brought to voters by County Commissioners and/or initiative.

Charter Review Commission

The voters of Clallam County elected a 15-member Charter Review Commission in November 2024. The Commission holds multiple meetings, takes public testimony, and studies numerous proposed amendments. The Commission meets from January through December when their term ends. During this time, the Charter Review Commission creates propositions to go to the voters with potential changes to the County Charter.

Charter Amendment Regarding Coroner Duties

The Clallam County Charter Review Commission proposes an amendment to the Clallam County Home Rule Charter, concerning the requirement that the Prosecuting Attorney serve as the ex-officio coroner. This amendment would remove the requirement that the Prosecuting Attorney serve as the ex-officio coroner, thereby removing the duties of coroner from the Prosecuting Attorney to the Board of County Commissioners of Clallam County, who would then have the responsibility to hire personnel with the appropriate credentials and training to serve as coroner.

Explanatory Statement

The Clallam County Home Rule Charter currently provides that the Prosecuting Attorney shall additionally serve as ex-officio coroner. The amendment, if adopted, would remove the Prosecuting Attorney as ex-officio coroner and place the responsibilities and duties of appointing a coroner to the Board of County Commissioners pursuant to Article XI, Section 4 of the Washington State Constitution, which provides that any duties of county officials prescribed by state law, with certain exceptions, if not assigned to specific officers by the County Charter, will become the responsibility of the Board of County Commissioners. Under this amendment, the Board of County Commissioners would have the ability to hire personnel with the appropriate credentials and training to serve as the coroner.

Argument For

Historically, the Prosecuting Attorney served as the ex-officio coroner for the county. Then, a Washington State Attorney General's opinion determined state law prohibited the Board of County Commissioners from selecting the Prosecuting Attorney as coroner.

Now, effective January 1, 2025, State Legislature changed the state law pertaining to who may serve in the position of coroner. Due to this year's change in state law, the Board of County Commissioners was essentially given the authority to appoint someone to serve as coroner. As a result of these changes, the Clallam County Charter is no longer aligned with state law.

To align the Charter with the state law, the County has two options: (1) create an elected county coroner - which would allow anyone to run for the coroner position - even someone with no training or background in forensic investigations; or, (2) allow the Board of County Commissioners to hire personnel with appropriate training and credentials in forensic investigations to serve in this role.

This Charter Amendment will bring the Charter into alignment with state law. Rather than creating an elected coroner position that would allow someone with no training or appropriate credentials to serve as coroner, this amendment, if adopted, would charge the Board of County Commissioners with the responsibility of hiring someone with appropriate training and expertise to serve as the county coroner.

Argument Against

No person in the jurisdiction contacted the Auditor to provide a statement, and there is no argument against this measure.

Levy Lid Lift for County Essential Public Services

The Board of County Commissioners of Clallam County adopted Resolution No. 61, concerning a proposition to maintain and adequately fund County operations. If approved, this proposition would provide additional funding to continue services which promote safety, health, and the quality of life for citizens in such areas as criminal justice, public safety, public health, land use, and parks. It authorizes a maximum regular County-General property levy rate for collection in 2026 of \$0.95 per \$1,000 of assessed value. The 2026 levy amount will be used for the purpose of computing the limitations for levies in subsequent years.

Clallam County is charged with providing certain services under the Constitution and laws of Washington State, specifically programs addressing criminal justice, public safety, public health, land use, parks, and other services which promote safety, health, and the quality of life for its citizens. While the maximum allowed levy rate is \$1.80 per \$1,000 for the County-General property tax levy, Clallam County's current rate is \$0.7598. If approved by the voters, the proposition will authorize the County to adjust its levy rate to \$0.95 per \$1,000 of assessed valuation in 2025 for collection in 2026. The 2026 levy amount will be used for the purpose of computing the limitations for levies in subsequent years. The Board of County Commissioners has determined this proposition is necessary to maintain essential county services in light of rising costs. Approval of this measure will allow the County to maintain the level of services it provides to its citizens.

Argument For

Counties in Washington State are an extension of state government and are required to provide certain services at the local level under the Constitution and laws of Washington. Those General Fund programs, separate from the Road Fund, include the criminal justice system – the courts, Prosecutor, Sheriff, jail, coroner, and juvenile services. Additionally, required programs include public health, elections, recording official documents, assessing property values, processing tax deferrals, land use regulations and permitting, collecting property taxes, and distributing taxes to other governmental entities. Beyond these services, counties provide services to provide quality of life for citizens such for parks, the Fair, and for youth (i.e. 4-H).

The primary source of funding for counties is the property tax. The maximum allowed levy rate for counties is \$1.80 per \$1,000 of assessed valuation. Unlike other taxing districts in the region, Clallam County does not levy the maximum rate. The current levy rate is \$0.7598 per \$1,000, far less than the \$1.44 per \$1,000 that was levied ten years ago. This proposal would assess a levy of \$0.95 per \$1,000 and cost the owner of a \$500,000 home an additional estimated \$8 per month.

Clallam County leaders have worked carefully in the past years to innovate, find efficiencies, and reduce costs. This measure will allow Clallam County to largely maintain current essential services while continuing to prioritize important needs of county residents. Argument Against

The levy lift is a 25% increase without the county specifying the essential services it believes it needs the additional revenues from the property owners. The General Fund is a broad array of services, not all required by statute as essential and the voter is not given the choice or understanding within this vote on what services are in the best interest of the citizens as also being essential. To accept that such an increase in taxation will represent only those portions of the General Fund that allocate for required essential services leaves the door wide open for the county to define what is essential that could even undercut those required. The current levy rate is mostly under threat for not being adequate by the loss of non-property tax based revenues that were created back as far as the formation of the State and also the amount of Federal removal from our tax rolls that do not have just compensation for which they were withdrawn. That burden is ultimately on the property tax payer to make up for when the rest of the country is reaping the benefits of such withdrawals but not paying their equal share of the burden. State legislature has created many *essential* basic services since the current rate has been in effect, but those too are a burden for being unfunded mandates, for when the rest of the state is reaping the benefits of such mandates but not paying their equal share of the burden.

The luxury of living in Port Angeles continues to outpace our income, making it harder for many residents to keep up. The city has raised both the sales tax and fees. Since 2021, city hiring and spending have continued without pause, adding 44.73 full-time equivalent positions—an 18% increase to the city payroll. Overall spending has jumped by 34%, all while the population has grown by less than 1%.

Building Single-family homes generate jobs, contribute to the property tax base, help strengthen family-oriented communities and are the back bone of the American dream. Yet the city seems more focused on congratulating itself for promoting multiplexes and apartment buildings. These policies have come at the expense of single-family housing, with increased fees making homebuilding less accessible and less affordable.

Economic development also deserves more serious attention. Of the \$32,000 budgeted for promoting business, the city spent just \$3,000. At the same time, substantial funds are being funneled to out-of-town consultants who deliver generic recommendations, rather than investing in local knowledge and expertise. The city's Comprehensive Plan reflects this misalignment, offering little meaningful support for local business development or long-term economic growth.

6-Year Regular Property Tax Levy

The Board of Directors of Quillayute Park and Recreation District adopted Resolution 2025 - 1 concerning a proposition to fund maintenance and operations of District assets. This proposition would authorize a Regular property tax levy equal to \$.30 per \$1,000 of assessed valuation, for six years commencing in 2026 for collection in the years 2026 through 2031.

Explanatory Statement

The Quillayute Park and Recreation District (the "District") serves the greater Forks area and owns a facility that the Forks Athletic & Aquatic Club operates out of as a public/private partnership. In 2000, voters approved general obligation bonds to construct this facility but rejected a levy to support the maintenance and operations of the District. As a result, the facility was closed for several years until the public/private partnership was created. Future operations of the facility are threatened by lack of revenue to support ongoing maintenance of the facility. Based on the current assessed value of property within the district, the proposed \$.30 per \$1,000 of assessed value would result in an estimated levy amount payable by an owner of a home with an assessed value of \$300,000 of \$7.50 per month or \$90 per year.

If Proposition 1 passes, the District will have sufficient revenues to support the operations and maintenance of the facility.

If Proposition 1 fails, the District will likely be forced to defer required maintenance and eventually close the facility in the coming years.

Argument For

This levy will secure the future of our community pool and recreation spaces while giving the board stability to plan, grow, and dream again. Passing this levy doesn't just provide funding—it brings our timber tax dollars home. Right now, because we don't have a levy, this revenue goes to Clallam County, where others decide how it's spent. With this levy, we decide.

The board is implementing stronger financial practices, updating contracts ensuring that this levy is managed with greater accountability and transparency.

The district already supports vital programs and spaces: Feeding 5000, Soroptimist Medical Supply Closet and meeting space for the American Legion, Lions Club, AA, and future after school programs. Through our public-private partnership with Forks Athletic and Aquatic Club, our pool offers swim lessons, family swim, aqua aerobics, lap swim and hosts afterschool STEM competition for underwater robotics teams. Our multipurpose room offers yoga, tumbling, self defense, dance, and other fitness classes. Our weightroom offers workout space, personal trainers, and fitness equipment. A community room and kitchen used for parties, community service, CPR class, and more. These programs keep our community connected, healthy, and active.

At just \$0.30 per \$1,000 assessed value - half the maximum rate - this levy is a responsible investment in our future. It will maintain our current assets, prepare for emergencies, and finally move forward with the original vision of more fields, programs, and opportunities for our community. Let's keep our money local and invest in ourselves. Vote YES on Proposition 1.

Argument Against

We all value the community pool and recreation spaces the district maintains, but public trust and transparency matter just as much as public access. While a new board member has joined with fresh energy and the board is working toward a revised lease and updated contracts, the district's most recent audit (2019–2021) raised serious concerns about weak internal controls, missing documentation, and inconsistent budgeting practices. Even now, the district is struggling to provide complete financial records for its current audit.

The board is voluntarily led, and their commitment is appreciated. But even volunteer-led public agencies must meet basic standards of accountability before receiving six years of new tax revenue. We should know how funds will be used, what safeguards are in place, and how progress will be tracked. The district does appear to be moving in the right direction, setting its sights on updating contracts and aligning rents with market rates. Let's give the board space to finish that work, adopt new policies, and return with a stronger, well-supported levy proposal next year.

Voting "No for now" does not mean "No forever." It simply encourages the district to continue reforming and then come back to voters with a clearer, more sustainable path forward.

Vote NO on Proposition 1—so we can all say yes to a better plan.

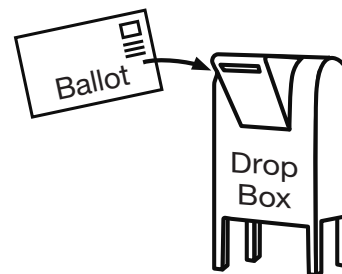

Your county receives your ballot

Deposit your ballot in an official drop box by 8 p.m. on Election Day, or return your ballot by mail — postage paid — but make sure it's postmarked by Election Day! Don't let a late postmark disqualify your ballot. The USPS recommends that you mail it back at least one week before Election Day.



Election staff will contact you before your ballot is processed if:

- Your signature is missing
- Your signature doesn't match your voter registration record

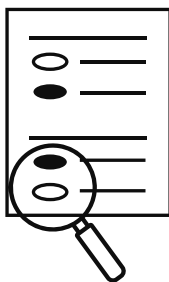
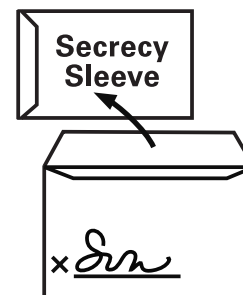
Your signature is verified

Your signature is important and we need it to accept your ballot. The signature on your return envelope is compared to the signature on your voter registration record. If the signature matches, your ballot is accepted and you are credited for voting to ensure **only one** ballot is counted for you.

Envelopes and sleeves are separated

The return envelope is opened and the secrecy sleeve containing your ballot is removed. They are separated to ensure the secrecy of your vote.

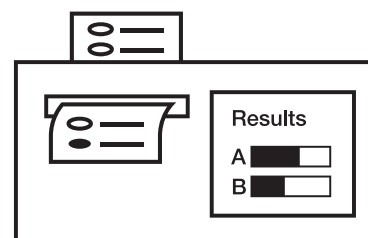
Your ballot is reviewed and scanned

The ballot is removed from the secrecy sleeve and election staff verify that it can be successfully scanned. Each voting system is certified and tested before every election.

5

Your ballot is counted

After 8 p.m. on Election Day all scanned ballots are tallied. Ballots will be scanned and tallied over the next several days until all the votes are counted. Every county conducts a post-election audit.

Voting systems certification and testing



Ballot counting equipment is tested and certified by an independent testing authority and the State of Washington.

Voting systems are not connected to the internet.

Pre-election audit: logic & accuracy tests

Before every election, counties test their voting systems to make sure the machines are correctly set up and accurately counting votes.

Voter registration database

Washington's statewide voter registration database is constantly maintained and updated as voters become registered, move, change their name, pass away, or are no longer eligible to vote.

All eligible voters are automatically mailed ballots. Only one ballot per voter is accepted.

During an Election

Paper ballots



Voting on paper ballots allows election officials to audit results of an election after votes are counted.

Signature verification

Trained election officials compare your signature to your voter registration file to confirm your identity and eligibility.

If your signature is missing or doesn't match, your ballot is "Challenged" and you are notified. Once your signature is verified, your ballot status will update to "Accepted".

VoteWA

Check the status of your ballot at VoteWA.gov. Once your ballot status is updated to "Accepted," your ballot will be opened and scanned. Only one ballot per voter is accepted.

Chain of custody

Ballots are sealed in secure, tamper-evident containers and at least two staff are present whenever your ballot is handled.

Scanning and tabulation

Ballot scanners and vote counting machines are physically secured in locked rooms. Election staff sign in and out each time the room is opened, and always in groups of two or more.

After an Election

Random batch audits



Your local election officials hand count randomly selected precincts or ballot batches and compare those numbers to the voting system totals to make sure the vote counting machines counted correctly.

Random ballot audits

Your local election officials examine a statistically significant, randomly selected sample of ballots to help ensure the reported outcome is correct.

Full ballot reconciliation

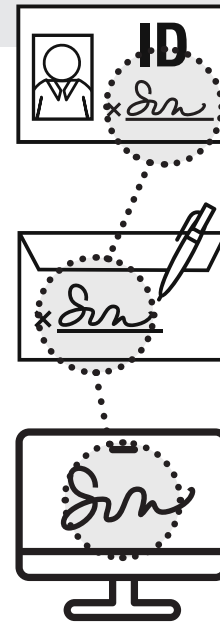
Your local election officials keep detailed records of the steps taken to process each ballot or group of ballots, creating an audit trail.

A final report at the end of the process includes a summary of the ballots received and counted.

Why is my signature important?

Your signature is needed to make sure your ballot gets counted.

- The signature on your return envelope is compared to the signature on your voter registration record. Trained election officials are responsible for verifying each and every signature.
- If your signature is missing or does not match your voter registration record, the county elections office will contact you by mail **before results are certified**. They may call or email if you gave them this info.
- If you registered to vote online or through Department of Licensing, the signature from your driver's license, permit, or state ID will be on your voter registration record.
- Voters can track and check their ballot status at **VoteWA.gov**.



How do I know if something is true?

When reviewing online or printed information, think about:

- Who made this, and who is it for?
- Why did they make it?
- When was this made?
- What makes it believable?
- How might other people read this message?
- Ask the experts — Get trusted info from your county auditor or elections office. Consult a fact-checking site or ask an official source.



What does this mean?

Certification Day

The date when election results are finalized by state or county officials.

Logic and Accuracy Test

A test completed before each election to ensure the accuracy of voting equipment.

Nonpartisan Office

An elected position in which candidates do not state a political party preference and candidates for the office are not officially associated with a political group. Office appears on the ballot as “Nonpartisan.”

Partisan Office

An elected position in which candidates may state their preferred political party. A candidate may also choose “States No Party Preference.” Their preference is printed on the ballot.

Postmark

A postmark indicates the location and date the Postal Service accepted custody of a ballot. Ballots must be postmarked by Election Day to be accepted. Placing your ballot in a mailbox on Election Day does not guarantee a postmark of the same day.

Post-election Audit

A test completed before the certification of results to ensure the security and accuracy of the voting system. Counties perform a post-election audit each election.

Term Type

How much of a term a candidate will be serving for an office. It is split into regular, unexpired, and short-and-full.

Voter Registration Database

The official list of registered voters maintained in every state to conduct safe and secure elections. Our database in Washington is known as VoteWA.

Voting Center

A county-run facility where you can receive voting assistance from trained elections staff. Some services include registering or updating voter information, requesting and returning a ballot, or finding an accessible voting unit.

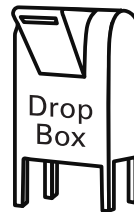
Voting System

Ballot counting equipment that must be tested by an independent testing authority and certified by the state of Washington before it can be used.

New Washington resident

Welcome! Register to vote online, by mail, in person, or when you get your new driver's license, permit, or ID at the Department of Licensing. You may not vote in more than one place, so cancel your previous voter registration.

**Military or overseas voter**

Register to vote anytime on or before Election Day. You may receive your ballot by mail, email, or fax. Spouses and dependents also away from home have the same voting rights.

**College student**

Register to vote using either your home or school address, but you may not vote in more than one place. Your ballot can be mailed to you anywhere in the world; however, your residential address must remain in Washington.

**Non-traditional address voter**

Use any physical location you consider your residence such as a shelter, park, or marina. Your mailing address can be general delivery at a local post office, a PO Box, or an address of a trusted friend or relative. A federally recognized tribe may designate tribal government buildings to serve as residential or mailing addresses for voters living on tribal lands.

**Seasonal resident**

Vote in Washington even if you're away during an election. To ensure you receive your ballot, update your mailing address at **VoteWA.gov** or with a county elections office. Your ballot can be mailed to you anywhere in the world; however, your residential address must remain in Washington. You may not vote in more than one place.

**Person convicted of a felony**

Your right to vote is automatically restored once you're no longer serving a sentence of total confinement in any state or federal prison, including for federal or out-of-state felony convictions. Register to vote upon your release from prison. Even if you were previously registered to vote, or voted before your felony conviction, you will need to re-register to receive a ballot.

Complete Text

Senate Joint Resolution No. 8201

BE IT RESOLVED, BY THE SENATE AND HOUSE OF REPRESENTATIVES OF THE STATE OF WASHINGTON, IN LEGISLATIVE SESSION ASSEMBLED:

THAT, At the next general election to be held in this state the secretary of state shall submit to the qualified voters of the state for their approval and ratification, or rejection, an amendment to Article XXIX, section 1 of the Constitution of the state of Washington to read as follows:

Article XXIX, section 1. Notwithstanding the provisions of sections 5, and 7 of Article VIII and section 9 of Article XII or any other section or article of the Constitution of the state of Washington, the moneys of any public pension or retirement fund, industrial insurance trust fund, ~~((or))~~ fund held in trust for the benefit of persons with developmental disabilities, or fund to provide for long-term care services and supports for eligible seniors and

people with disabilities may be invested as authorized by law. Investment income from a fund to provide for long-term care services and supports for eligible seniors and people with disabilities is dedicated to long-term services and supports for program beneficiaries.

BE IT FURTHER RESOLVED, That this amendment is a single amendment within the meaning of Article XXIII, section 1 of the state Constitution.

The legislature finds that the changes contained in this amendment constitute a single integrated plan for the fund to provide long-term care services and supports for eligible seniors and people with disabilities. If this amendment is held to be separate amendments, this joint resolution is void in its entirety and is of no further force and effect.

BE IT FURTHER RESOLVED, That the legislature, pursuant to its authority under RCW 29A.36.020(3), specifies the ballot title and concise description shall read "The legislature has proposed a constitutional amendment on allowing money in Washington's long-term care fund to be invested. This amendment would allow the state fund dedicated to providing long-term care benefits for eligible seniors and people with disabilities to be invested as authorized by law.

Should this constitutional amendment be:

Approved.....

Rejected"

BE IT FURTHER RESOLVED, That the secretary of state shall cause notice of this constitutional amendment to be published at least four times during the four weeks next preceding the election in every legal newspaper in the state.

If I am a victim of a crime, can I vote safely?

Keep your voting address confidential

You may be able to enroll in the Address Confidentiality Program (ACP) and register as a Protected Records Voter if you are:

- A survivor of domestic violence, sexual assault, trafficking, stalking; or
- A criminal justice participant, election official, or protected health care worker who is a target for harassment.

To become a Protected Records Voter:

- You meet with a Certified Advocate who can assist with threat assessment, safety planning, and the program application.
- The best time to enroll is when you move or are planning to move to a location that is unknown to the offender and undocumented in public record.

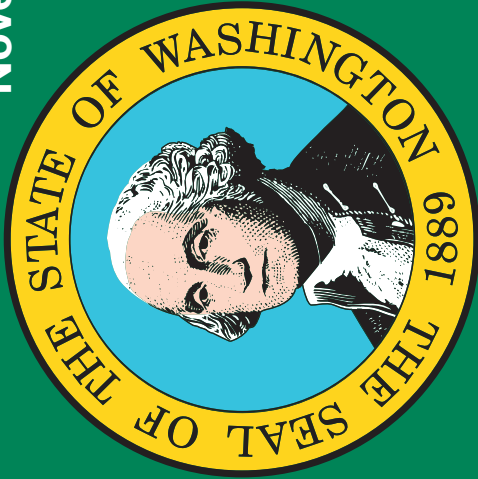
